WHEREAS it has been represented to Government by the Hon. the Attorney-General, that a Tamil man named Muttu, of Mabotalawa, in Haputale of Lower Hewaheta, in the district of Kandy, of about sixty years of age, was on the night of November 1, 1888, murdered in his house by some person or persons unknown: A reward of Rs. 160 is hereby offered to any person or persons, who shall, within three months from the date hereof, give such information as shall lead to the apprehension and conviction of the murderer or murderers.

# **OFFENDERS.**

#### WANTED BY

MAME, Weliwita Kulatangedara Siyatu; charged with escape from a working party at The Residency, Badnlla, on January 12, 1889; was convicted of burglary and theft and sentenced to 15 years' rigorous imprisonment on January 23, 1882; is a Sinbalese of the Goigama caste; religion, Buddhist; occupation, cultivator; age, 30 years; height, 5 ft. 5 in.; make, thin; complexion, brown; nose, prominent; mouth, small; teeth, well set; eyes, small, round, and dark; hair, black; hair on face, scanty; has a mild expression of countenance; bears two marks on the back, a mark on the eyebrow, and a scar on the face; birthplace and general residence, Weliwita, Galgedara, Kurunegala district; he is known to Jail Guards Karo Appu and Baban Nicholas Perera. A reward of Rs. 30 is oflered for the recapture of this prisoner.

### THE POLICE.

Name, Tibbotuwawe Appubamilagedara Kirihami; charged with house-breaking at Matale on the night of January 4, 1889; is a Sinhalese of the Wellala caste; religion, Buddhist; occupation, cultivator; age, 28 years; height, about 5 ft. 6 in.; make, thin; complexion, fair; mouth, small; eyes, black, small; hair, black, long, tied in a knot; has slight monstaches; beard, shaved; has a scar on the right side of the abdomen; birthplace, Tibbotuwawe, Matale; occasional residences, Tibbotuwawe and Ankumbara; haunts Orolla, Paragoda; wife and children are living at Tibbotuwawe; younger brother, Dingiri Banda, *alias* Punchi Banda, lives at Tibbotuwawe; is known to Korale Arachchi, Tibbotuwawe Hulangoma Arachchi, and P. C. 483 Dingiri Banda. Name, Hewabakuruge Jema; charged with having absconded from justice; is a Sinhalese of the Wahumpura caste; religion, Buddhist; occupation, cultivator; age, about 30 years; height, 5 ft.; complexion, brown; face, oval; hair, cut short; beard and whiskers, scanty; birthplace, Magalkanda, in Kalutara district; arms vaccinated; has a scar on the right cheek and a flower tattooed on left arm; is said to have goue to M\*nnar or Jaffna.

Name, Alfred E. De Vos; charged with criminal breach of trust at Simpang, State of Perak, between October 1, 1 1, and February 29, 1888; is a Burgher; religion, Protestant; occupation, clerk; age, about 18 years; height, about 5 ft. 4½ in.; make, rather stout; complexion, fair ; nose, thin, long ; teeth, well set ; eyes, gray, oval ; hair, light brown, parted on side ; hair on face, very slight; has freckles on the face ; is slightly round-shouldered ; stoops slightly ; birthplace, Pettah, Colombo ; general residence, New Chetty street, Colombo ; occasional residences, Bambalapitiya and Barber street ; haunts Pettah ; father, R. De Vos, is under Peris Mudaliyar, of Henaratgoda ; brothers and sisters are young ; many of the young clerks of the Pettah are bis friends ; he is known to Police Inspector Jonklaas, D. C. 813 Alwis, and many of the Burgher young men in Colombo. The accused returned from l'erak and got employment as clerk under Cargill & Co., whom he left after about two months on hearing that he was wanted at Perak.
