Order under Section 2 of "The Waste Lands Ordinances, 1897, 1899, and 1900," declaring the Lands to be Crown Property.

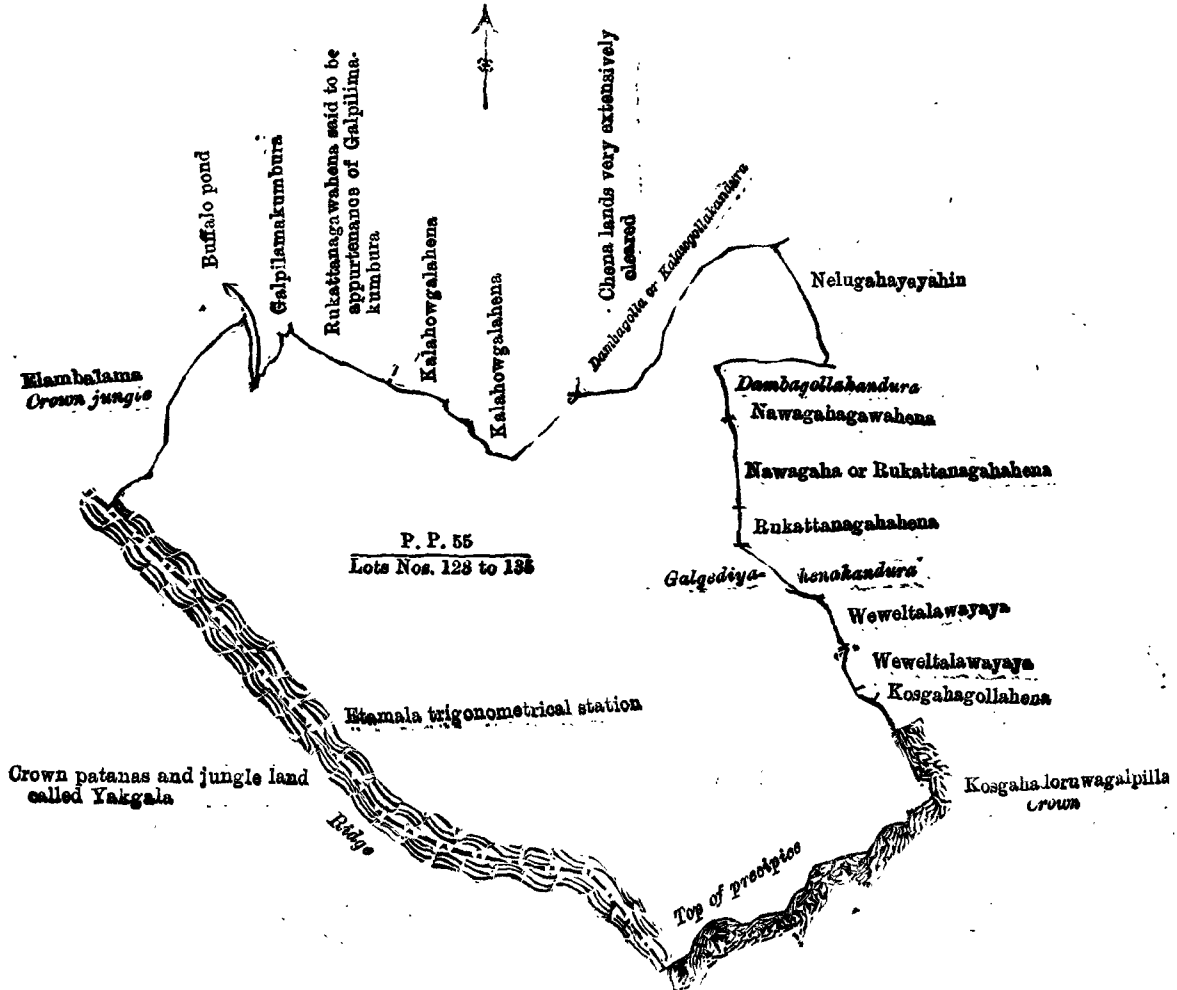
In the matter of the lands commonly called or known as Udaulpotakele, Udaulpotahena, &c., situate in the village of Galanihe in the Gampaha korale of Udukinda, in the Province of Uva, and of "The Waste Lands Ordinances, 1897, 1899, and 1900."

THE notice required by section 1 of "The Waste Lands Ordinances, 1897, 1899, and 1900," having been duly published in manner prescribed by that section in respect of the above-named lands (*vide* notice No. 700), and no claim having been made to the said lands or to any interest therein within the period of three months from the date specified in the said notice, I, John George Fraser, Special Officer appointed under section 28 of the said Ordinances, under and by virtue of the powers vested in me in that behalf by section 2 of the said Ordinances, do hereby on this 27th day of May, 1902, order and declare that the said lands, commonly called and known as Udaulpotakele, Udaulpotahena, &c., situate in the village of Galanihe

in the Gampaha korale of Udakinda, in the Province of Uva, and shown as lots 128, 129, 130, 131, 132, 133, 134, 135 in preliminary plan No. 55 of lands situate in the said village, a certified copy whereof is hereunto annexed, and containing in extent 211 acres 3 roods and 3 perches, as more fully described herein below, are the property of the Crown.

Description of Lands referred to.

Eight contiguous lots of land situated in the village Galanihe in the Gampaha korale of Udakinda, Province of Uva, containing in extent 211 acres 3 roods and 3 perches; bounded on the north by a buffalo pond, Galapilamakumbura, Rukattanagawahena, Kalagahagolahena, Dambagolla or Kalawgollakandura; east by Nelugahayayahin, Dambagollakandura, Nawagahagawahena, Nawagaha or Rukattanagahahena, Nawagaha or Rukattanagahahena,
