**NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.**

TAKE notice, that unless within three months from the 24th day of June, 1902, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Assistant Government Agent of the Kegalla District at the Kegalla Kachcheri and make claim to the said land or to some interest therein:

Such Assistant Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said land, to which no claim has been made, is the property of the Crown.

*Description of the Land referred to.*

Lot 669 on preliminary plan 6,849 called Medahena and Himbutupolehena, situated in the villages Pambagama and Pukunuwala in Panawal korale of Three Korales in the Kegalla District, containing in extent 274 acres, as described in the annexed plan, and bounded as follows : north by Kahalula-ela ; east by Nakanda-ela, village boundary of Godagampola village, Valiakgala rock, Valiakgalahena claimed by the Crown, Galaudehena and Muttelenahena claimed by H. Silinda and others ; south by Opatte-ela ; west by a portion of Opatte-ela and land described on T.P. 135,878 called Pambagama-makalana and Totagalakanda claimed by J. C. Kinmond, Esq.


