#### CEYLON.

Further information, dated June 5, has been received from Commander Boyle T. Somerville, R.N., H. M. Surveying Vessel "Sealark," concerning the pinnacle rock in Galle harbour reported by him on May 14, 1907. Close investigation in the locality has resulted in the discovery of two more rock-heads: (1) one of 27 ft. closely adjoining the 29 ft. already reported; and (2) one of 22 ft. (depths at low water in each case) at about 20 yards distant from it, and to the north-eastward; thus being the nearest to the course usually taken by vessels in and out of the harbour; and offering a serious danger to navigation. These rocks are separated from each other, and are also surrounded by depths of 37 to 42 ft.

of Bengal-Burma coast-Mergui harbour-BayAlteration in beacons—Light established.

The British Admiralty has given notice (No. 524 of 1907) that the under-mentioned beacons in Mergui harbour have been altered as follows:-

(a) The temporary beacon off Kalwin point, on the eastern side of the entrance to the harbour, has been replaced by an iron pile beacon, painted black, from which a white fixed unwatched light is exhibited, at an elevation of 25 ft. above high water, and visible in clear weather from a distance of 9 miles.
