## FINAL ORDERS.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Lands to be Grown Property.

In the matter of the lands commonly called or known as Rilaellepatana, Iluktennepatana, Kotala-arawepatana, Watugodapatana, Ankelipitiyepatana, &c., situate in the village of Weragama in the Dehiwinipalata korale of the Udukinda division, in the Province of Uva, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

THEREAS in pursuance of section 1 of the said Ordinances it was duly notified on the 9th day of June, One thousand Nine hundred and Five, that if no claim to the lands commonly called or known as Rilaellepatana, Iluktennepatana, Kotala-arawepatana, &c., situate in the village of Weragama in the Dehiwinipalata korale of the Udukinda division, in the Province of Uva, containing in extent 558 acres 3 roods and 15 perches, and shown as lots 1, 1b, 1c, 12, 13, 15, 25, and 27 in preliminary plan No. 102 and in the annexed certified tracing therefrom, was made to the Special Officer appointed under section 28 of the said Ordinances within the period of three months from the date specified in such notice, such lands would be deemed the property of the Crown and dealt with on account of the Crown (vide Notice No. 2,198):

And whereas (1) Gammahelagegedara Siatu of Weragama, (2) Palawattegedara Siatu of ditto, and (3) Gammahelagegedara Malhami of ditto made claim thereto; and whereas the said claimants have withdrawn their claims to the said lands, I, John George Fraser, Special Officer appointed under section 28 of the said Ordinances, under and by virtue of the powers vested in me in that behalf by section 4 of the said Ordinances, do hereby on this 24th day of October, 1905, order and declare, under section 4, sub-section (1), of the said Ordinances, that the said lands, as more fully described herein below, are the property of the Crown.


