NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899 AND 1900

TAKE notice, that unless within three months from the 28th day of November, 1902, the persons, if any, who claim any interest in the lands hereinafter mentioned or in any one or more of such lands, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899. and 1900." at his office at Galle and make claim to the said lands or any of them or to some interest therein.

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said lands or such of them, as to which no claim has been made, are the property of the Crown.

Description of Lands referred to.

The land commonly called or known as Kekunaghawalayaya, situated in the village of Kotapola in the Morawak korale of the Matale District, in the Southern Province ; containing in extent 35 acres 3 roods and 31 perches, shown as lot 29 in sheet O¹⁰ 50-58 and in preliminary plan 45, and in the annexed certified tracing therefrom, and bounded as follows : on the north by the Nilwala-ganga ; on the east by Watadeniyewatta claimed by Ratnayakaliyanage Don Davit Appuhami and others, Watadeniyekumbura claimed by ditto ; on the south by the Na-attedola, Medagoda-atura belonging to Crown ; on the west by Medagoda-atura belonging to Crown, the Na-attedola, the Nilwala-ganga.


