PROCLAMATIONS BY THE GOVERNOR.

In the Name of Her Majesty VICTORIA, of the United Kingdom of Great Britain and Ireland Queen, Defender of the Faith.

PROCLAMATION.

By His Excellency the Honourable ARTHUR HAMILTON GORDON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

ARTHUR GORDON.

WHEREAS by the 19th section of the Ordinance No. 10 of 1885 it is enacted that whenever the following events have occurred, viz. :—

- (a) the period fixed under section 7 for preferring claims has elapsed, and all claims (if any) made within such period have been disposed of by the Forest Settlement Officer; and
- (b) if such claims have been made, the period fixed for appealing from the orders passed on such claims have elapsed, and all appeals (if any) presented within such period have been disposed of by the Appellate Officer or the Supreme Court; and
- (c) all lands (if any) to be included in the proposed forest, which may be acquired under section 13, have become vested in the Crown—

the Governor Secretary's Office, Proclamation to be published in the *Government Gazette*, specify the limits of the forest which is to be reserved, and declare the same to be reserved from a date fixed by such Proclamation :

And whereas all things necessary for declaring the forest hereunder mentioned to be a reserved forest have been fulfilled and all times have elapsed, and it is expedient to specify the limits of such forest :

Now know all Men that We, the said Governor, do by this Our Proclamation proclaim the forest, the limits of which are set forth in the Schedule hereto, to be a reserved forest as from and after April 1, 1890 ; and We do hereby further specify the limits of the said reserved forest to be those set forth in the said Schedule, reserving nevertheless a right of way through the public path leading from Rambuka to Pannila, which is 3 ft. in width :—

SCHEDULE.

A tract of land known as the Wallankanda range of hills, situated in the villages Rambuka, Tanabala, and Tebugala, in the Uda pattu of Kukulú kóralé, in the district of Sabaragamuwa, in the Province of Sabaragamuwa; bounded on the north by the boundary of Atakalan kóralé, east by the same as far as Eldorado and Depedene estates, south by the limit of existing chenás adjoining Rambuka or Koswatta-gagga, and west by Endola and boundary of Nawadun kóralé.

Given at Nuwara Eliya, in the said Island of Ceylon, this Twenty-seventh day of March, in the year of our Lord One thousand Eight hundred and Ninety.

REPORT FOR THE YEAR 1889.

THE condition of the Ceylon Savings Bank is clearly and fully set forth in the Balance Sheet and Statements of Account attached.

The progress, though slower than could be desired, is steady, as shown by the Table of Totals under several heads for the past eleven years. This statement is deserving of consideration. Comparing 1889 with 1879, the number of depositors having accounts open at end of these years is 13,296 for 1889, against 7,706 for 1879, and the amount to credit of the depositors for these years is Rs. 2,321,950 for 1889, against Rs. 1,553,066 for 1879.

It is to be regretted that the advantages offered by the Bank are not more generally availed of.

We fail to get at the people in more or less remote villages.

The depositors are principally from the vicinity of large towns where there are kachcheries.

The difficulty experienced by villagers in corresponding with, and making remittance to the Savings Bank is the chief hindrance to extension of the advantages offered.

The table "Classification of Accounts open on December 31" shows that out of 13,296, 2,382 accounts are for sums under Rs. 5 and Rs. 3,004 between Rs. 5 and Rs. 20.

Accounts are frequently opened for one rupee, the cost of which to the depositor is 10 cents commission for an Inland Money Order and 5 cents for postage, making 15 per cent. on the first attempt to save; the process to be repeated with each succeeding deposit, and in addition to this there is loss of time to the depositor, who may have a long distance to travel to and fro.

This is clearly prohibitory, and fully accounts for the slow progress.

The Trustees and Managers feel they can congratulate the depositors on the condition of the Bank.
