A. M. ASHMORE, Colonial Secretary's Office, Colonial Secretary. Colombo, August 24, 1906. RULES OF CRIMINAL PROCEDURE FOR VILLAGE TRIBUNALS AND VILLAGE COMMITTEES.

#### I.-COMMENCEMENT OF PROCEEDINGS.

1. Complaints shall ordinarily be made verbally to the President or Chairman, who shall thereupon enter or cause to be entered on a separate sheet of paper

- (1) The number of the case.
- (2) The date of institution.
- (3)The names of the parties-complainant and defendant.

The offence charged. (4)

(5) The date and place when and where the offence is alleged to have been committed.

In the case of a complaint by an Irrigation Officer or a headman of a breach of a rule, the complaint may be in writing.

If the complaint is in writing, it shall be initialled and dated by the President or Chairman, and shall be numbered and filed as part of the proceedings. The President or Chairman shall supply by examination of the complainant any of the above particulars (except the first and second) which may have been omitted in the written complaint. A complaint may be made either by a private party or by a local headman.

2. The complainant (and de endant if present) shall give the names of his witnesses either verbally or in writing. If given verbally, the President or Chairman shall take down the names and residences of the witnesses ; if in writing, the list shall be initialled and dated by the President and filed with the proceedings.

3. If the parties and their witnesses are present at the time the complaint is made, or their presence can be secured without delay, the President or Chairman shall proceed to hear the charge at once, or if the defendant and witnesses are not present, shall fix a day for the hearing of the case, and may issue summons and subprenas requiring their attendance on such date.

4. A separate case shall be entered for each offence complained of.

(1) Provided that where more persons than one are charged with jointly committing the same offence or different offences triable by the Village Tribunal or Committee, committed at the same time and place and in the same transaction, they may be charged and tried together in the same case, but the number of persons thus charged and tried together shall not exceed twelve.

(2) Provided also that when several offences triable by the Village Tribunal or Committee are alleged to have been committed by the same defendant at the same time and as part of the same transaction, such defendant may be tried in the ame case for all such offences.

5. The President or Chairman new, on sufficient cause being shown by either complainant or defendant, allow a postponement of the hearing, in which event the date fixed for the hearing shall be notified to the parties either verbally or by a notice in writing issued by the President or Chairman and served in the manner prescribed for service of summons.

#### II.—PROCESS.

6. The summons (Form A) and subpœna (Form B) shall be ordinarily addressed to the village headman, who shall thereupon serve the same personally by delivering a copy thereof to the person named therein, and shall report such service to the President or Chairman.

7. If after due service of summons or subpone any defendant or witness refuse or neglect without sufficient cause to attend the Village Tribunal or Committee upon any date fixed for the hearing or further disposal of the case, the President or Chairman may issue a warrant (Form C) and cause the defendant or witness to be arrested and brought before the Village Tribunal or Committee.

#### III.—PROCEEDINGS ON NON-APPEARANCE.

8. If upon the return day of the summons or upon any day appointed for the hearing of the complaint the complainant shall not appear, and his absence shall not be sufficiently accounted for, the complaint shall be dismissed.

(1) Provided that the President or Chairman may once or oftener, at his discretion, instead of dismissing the complaint, adjourn the hearing thereof to another day and cause a notice to be served upon the complainant requiring him to attend before the Village Tribunal or Village Committee upon the day to which the hearing has been so adjourned, which notice shall be served n the manner prescribed for service of summons.

(2) Provided also that if such complainant within a reasonable time satisfy the President or Chairman that he was prevented from attending by accident or misfortune, and that his absence was not due to neglect on his part, the President or Chairman may allow him to re-open the case, whereupon the order of dsimissal shall be cancelled and the case shall proceed to trial.

#### IV.—PROCEEDINGS ON APPEARANCE : TRIAL.

9. When the defendant appears, the President or Chairman shall state the charge to him, and in the event of his pleading guilty shall forthwith pass sentence upon <sup>\*</sup> him. If the defendant pleads not guilty the President or Chairman shall record his statement and the names of his witnesses, if any, and shall issue subprenas to such witnesses as may be necessary. If after the

evidence of the complainant and his witnesses has been recorded no offence. appears to have been committed, the defendant shall forthwith be acquitted and discharged.

10. When the parties and the witnesses, or such of them as the President or Chairman or the parties themselves may require to be examined, have been heard, the President or Chairman shall then proceed to make a record of the judgment in the manner directed by sections 30 or 48 of the Village Communities' Ordinance, and shall forthwith pronounce such judgment in open court finding the defendant guilty or not guilty. The opinions of the Councillors shal, be entered in the record and shall be signed by them.

11. When there is a difference of opinion between the Chairman and the Committee or any of them, a record shall be made by the Chairman of such difference of opinion.

12. In the event of conviction the judgment shall state the offence of which the defendant has been convicted, and if the conviction is of a breach of a Village Committee or an irrigation rule, it shall specify the terms of the rule and its number and date of publication.

13 If the defendant is found guilty, the President or Chairman shall pro nounce sentence on him as the circumstances o the case shall in his opinion require, provided that the same shall not exceed the amount of punishment which may by law be inflicted.

14. Where a defendant is convicted of more than one offence a separate sentence need not be recorded or pronounced for each offence; but the President or Chairman may combine the punishment for such offences in one sentence, provided that in such sentence the full term of mprisonment or the maximum fine which a President or Chairman can inflict shall not be exceeded.

If the President or Chairman shall sentence the defendant to a term of imprisonment in default of payment of a fine, he shall make out a warrant of committal in the Form K.

15. If the defendant be found not guilty, he shall be forthwith acquitted and discharged.

#### V.-TIME AND PLACE OF SITTINGS.

16. The Village Tribunal or Committee may postpone the hearing of cases to any date without unreasonable delay.

17. It shall be competent to a President or Chairman, if he deems it necessary or advisable, at any stage of the proceedings after appearance of the parties, to adjourn the hearing or further action until the Village Tribunal or Committee has had an opportunity of inspecting the scene of the alleged offence or the irrigation work or property alleged to have been damaged. Provided that notice of the time and place of such inspection shall be duly given to the parties either verbally or in writing; and provided that they shall have an opportunity of being present at such inspection.

#### VI.-BAIL.

18. Where (a) a defendant or witness is brought up before a President or Chairman upon a warrant of arrest; or (b) where a defendant has been sentenced to fine or imprisonment in default of payment of the fine and has filed a petition of appeal; or (c) where a complainant or defendant has been fined, and the President or Chairman thinks fit to allow him time to pay the fine; or (d) where the offence disclosed appears to be of a serious nature, information of which should be laid before a Police Magistrate, the P e ident or Chairman may require such person to enter into a recognizance (Form D) with or without sure ies at the discretion of such President or Chairman—

- (1) To appear on a certain date before the Village Tribunal or Village Committee.
- (2) To appear and surrender in order that he may undergo his sentence of imprisonment
- (3) To pay  $\hat{h}$ ; fine on the date fixed for such payment
- (4) To app ar before such Magistrate within the period fixed in such recognizance.

The amount of such recognizance shall not exceed Rs. 50.

19. The President or Chairman may in default of such recognizance order the complainant or defendant to be remanded (Form E), or he may order such recognizance to be renewed for another date, and in default of such renewal may order the complainant or defendant to be remanded to prison until such adjourned date. Provided that in no case shall a complainant or defendant be remanded for a period exceeding ten days. 20. Whenever it is proved to the satisfaction of the President or the Chairman that any bond taken under the provisions of rule 19 has been forfeited, the President or Chairman shall record the grounds of such proof, and may call upon any person bound by such bond to pay the penalty thereof, or to show cause why it should not be paid. If sufficient cause is not shown, and the penalty is not paid, the President or Chairman may proceed to recover the same by issuing a warrant under the hand of the President or Chairman, directed to the Fiscal of the Province, for the attachment and sale of the movable or immovable property belonging to such person. Such warrant may be executed within the local limits of the jurisdiction of the Village Tribunal or Village Committee which issued it, and it shall authorize the distress and sale of any movable or immovable property belonging to such person without such limits, when endorsed by the Government Agent or the President of the Village Tribunal, or the Chairman of the Village Committee within the local limits of whose jurisdiction or the President or Chairman may in his discre ion remit any portion of the penalty mentioned, and enforce payment in part only.

#### VII.---APPEAL.

21. When an application has been made under the 52nd section of the Village Communities' Ordinance for relief against an order or sentence passed by a Village Tribunal or Village Committee, such application shall not stay the execution of such order or sentence, unless the party applying enter into a recognizance as provided for by rule 19, to appear before the Tribunal or Committee on a date to be notified to him by the President or Chairman by written notice served in the manner prescribed for service of summons and to undergo the sentence or pay the fine imposed on him. If the party making the application fail so to appear in obedience to such notice, it shall be lawful for the President or Chairman to issue a warrant to compel his appearance, and if on his appearing or being brought up he should fail to pay the fine, it shall be lawful for the President or Chairman of the Village Committee to issue a writ (Form F) to the Fiscal to levy the amount of the fine, by the attachment and sale of the movable and immovable property of such party.

(1 Provided that such fine shall not be levied where the alternative sentence of imprisonment in default of payment of the fine is carried out.

(2) Provided also that where the Fiscal has made return to the writ that the defendant or complainant has no property it shall be lawful for the President or ('hairman thereupon to sentence the complainant or defendant to a term of simple or rigorous imprisonment for any period not exceeding fourteen days.

22. Whenever immovable property has been sold under the provisions of rules 20 and 21 it shall be lawful for the Fiscal under whose direction the attachment and sale was carried out to execute a conveyance in favour of the purchaser, and a conveyance so executed shall vest the property sold in the purchaser in like manuer as if such conveyance had been executed by the person against whom the warrant for the attachment and sale of such immovable property was issued.

23. Where a person who has been committed to jail for default of payment of fine, or in pursuance of a sentence of imprisonment, files a petition of appeal, the Superintendent of the Prison shall deliver him to the Fiscal to be produced before the President or Chairman in order that he may give bail for his appearance to pay the fine or undergo the sentence.

24. It shall be the duty of the President or Chairman to see that the judgment or sentence of the Government Agent or of the Governor in appeal is duly carried out.

#### VIII.—Selection and Appointment of Councillors and Committeemen.

25. A list shall be prepared by the chief headman of all persons in the divisions or division or part thereof in which a Village Tribunal has been established who are qualified to act as Councillors, and such list shall be revised after every five years. The persons so qualified shall be summoned to act in rotation as their names appear on the list. Provided that it shall be competent for the President to admit any qualified man present at the sitting of the Village Tribunal to take his seat as Councillor out of his turn for the hearing of any case in which such person is not interested.

26. No person shall sit as Councillor in the hearing of a case in which he himself is interested either on his own behalf or on that of either party.

27. Every Councillor and Committeeman to be associated with the President or Chairman in the hearing of cases shall, before he begins to exercise the duties of his office, take and subscribe an oath in the Form G.

A 3

28. Any Committeeman who fails when duly summoned to attend a sitting of the Committee for the trial of cases without sufficient or reasonable cause shall be liable to punishment by fine not exceeding five rupees, and in default of payment of the fine to simple imprisonment for a term not exceeding fourteen days.

29. Not less than three members of the Committee shall be associated with the Chairman in the trial of cases.

#### IX.—REGISTER AND FINE BOOK.

30. A register of cases (Form H) and a fine book (Form J) shall be kept by the President or Chairman.

31. A duplicate copy of the entries in the fine book for the month shall be forwarded by the President or Chairman monthly to the Government Agent, together with the fines recovered.

#### X.—Records and Journals of Proceedings.

32. Every form of process shall be in either of the native languages in use in the division or subdivision which is understood by the persons to whom the process is addressed.

33. The register of cases, the journals of proceedings, and the minutes of evidence, the opinions of Councillors, the judgment, and sentence may be kept or recorded either in English or in the native language used by the parties or witnesses, or with which the Village Tribunal or Committee is most familiar.

(1) Provided that where any record is kept in English, and any party to such record requires a copy of any portion of the proceedings therein, he shall be entitled to receive from the President or Chairman a translation of such portion from English into his own language without being called upon to make any extra payment therefor.

(2) Provided also that if the opinions of the Councillors are taken down in English in the record they shall be read over and explained to such Councilor, in their own language by the President before they are signed by them.

#### Examinations for the Civil Service of India.

An open Competitive Examination for admission to the Civil Service of India will be held in London, under the subjoined Regulations, commencing on August 1, 1907.

The number of persons to be selected at this examination will be announced hereafter.

No person will be admitted to compete from whom the Secretary, Civil Service Commission, has not received on or before July 1, 1907, an application on the presecribed form, a copy of which is sent herewith. No question as to the delay or loss in the post of any such Application Form can be entertained. Candidates who delay their applications until the last days will do so at their own risk.

Acknowledgments of such Application Forms are sent, and any Candidate who has filled up and returned the printed Application Form but has not received an acknowledgment of it within four complete days should at once write to the Secretary, Civil Service Commission, Burlington Gardens, London, W. Failure to comply with this provision will deprive the Candidate of any claim to consideration.

The Order for admission to the Examination will be posted on July 18, 1907, to the address given on the Form of application. It will contain instructions as to the time and place at which candidates will be required to attend and as to the manner in which the fee ( $\pounds$  6) is to be paid.

#### REGULATIONS.

\* The following Regulations, made by the Secretary of State for India in Council. are liable to alteration from year to year.

1. An Examination for admission to the Civil Service of India, open to all qualified persons, will be held in London in August of each year. The date of the Examination and the number of appointments to be made for each Province will be announced beforehand by the Civil Service Commissioners.

No person will be deemed qualified who shall not satisfy the Civil Service Commissioners :----

(i.) That he is a natural-born subject of His Majesty.

- (ii.) That he had attained the age of twenty-two, and had not attained the age of twenty-four on the first day of August of the year in which the Examination is held.
- (N.B.—In the case of Natives of India it will be necessary for a Candidate to obtain a certificate of age and nationality issued under Notification of the Government of India, No. 2,252, dated August 21, 1888. as amended by Notification No. 404, dated May 19, 1898, and signed, should he be a resident in British India, by the Secretary to Government of the Province, or the Commissioner of the Division within which his family resides, or should he reside in a Native State, by the highest Political Officer accredited to the State in which his family resides.)
- (iii.) That he has no disease, constitutional affection, or bodily infirmity, unfitting him, or likely to unfit him, for the Civil Service of India.

(iv.) That he is of good moral character.

3. Should the evidence upon the above points be *prima facie* satisfactory to the Civil Service Commissioners, the Candidate, on payment of the prescribed fee, will be admitted to the examination. The Commissioners may, however, in their discretion, at any time prior to the grant of the Certificate of Qualification hereinafter referred to, institute such further inquiries as they may deem necessary; and if the result of such inquiries in the case of any Candidate should be unsatisfactory to them in any of the above respects, he will will be ineligible for admission to the Civil Service of India. and, if already selected, will be removed from the position of a Probationer.

The marks obtained by each Candidate, in respect of each of the branches in which he shall have been examined, will be added up, and the names of the several Candidates who shall have obtained, after the deduction above-mentioned, a greater aggregate number of marks than any of the remaining Candidates will be set forth in order of merit, and such Candidates shall be deemed to be Selected Candidates for the Civil Service of India, provided they appear to be in other respects duly qualified. Should any of the Selected Candidstes become disqualified, the Secretary of State for India will determine whother the vacancy thus created shall be filled up or not. In the former case the Candidate next in order of merit, and in other respects duly qualified, shall be deemed to be a selected Candidate.

If any Candidate is prevented by sickness or any other adequate cause from attending such examination, the Commissioners may, with the concurrence of the Secretary of State for India in Council, allow him to appear at the Final Examination to be held in the following year, or at a special examination.

10. The selected Candidates will also be tested during their probation as to their proficiency in Riding The examinations in riding will be held as follows :---

- Shortly after the result of the Open Competitive Examination has been declared, or at such time or times as the Commissioners may appoint during the course of the probationary year.
  - (2) Again, at the time of the Final Examination. Candidates who may then fully satisfy the Commissioners of their ability to ride well and to perform journeys on horseback will be awarded from 100 to 200 marks, according to the degree of proficiency displayed, to be added to their marks in the Final Examination. Candidates who fail to obtain 100 marks, but are reported by the Civil Service Commissioners to have reached a minimum standard of proficiency in riding, and are certified by the said Commissioners to be entitled to be appointed to the Civil Service of India, will, on their arrival in India, be subjected to such further tests in riding as may be prescribed by their Government, and shall receive no increase to their initial salary until they have passed such tests to the satisfaction of that Government.
- A Candidate who fails at the end of the year of probation to satisfy the Civil Service Commissioners that he has reached the minimum standard of proficiency in riding, will be liable to have his name removed from the list of Selected Candidates.

11. The Selected Candidates who, on examination, shall be found to have a competent knowledge of the subjects specified in Regulation 9, and who shall have satisfied the Civil Service Commissioners of their eligibility in respect of nationality, age, health, character, conduct during the period of probation, and ability to ride, shall be certified by the said Commissioners to be entitled to be appointed to the Civil Service of India, provided they shall comply with the regulations in force, at the time, for that Service.

12. Persons desirous to be admitted as Candidates must apply on Forms, which may be obtained from "The Secretary to the Civil Service Commissioners, London," at any time after the 1st December in the year provious to that in which the Examination is to be held. No person will be admitted to the Examination from whom the Secretary to the Civil Service Commissioners has not received on or before July 1 (or, if that date should fall upon a Sunday or public holiday, then, on or before the first day thereafter on which their office is open), in the year in which the Examination is to be held, an appliaction, in the handwriting of the Candidate, on the prescribed form.

The Civil Service Commissioners are authorized by the Secretary of State for India in Council to make the following announcements :---

- (i.) Selected Candidates will be allotted to the various Provinces upon a consideration of all the circumstances, including their own wishes; but the requirements of the Public Service will rank before every other consideration,
- rank before every other consideration,
  (ii.) An allowance amounting to £100 will be given to all Candidates who pass their probation at one of the Universities or Colleges which have been approved by the Secretary of State, viz., the Universities of Oxford, Cambridge, Dublin, Glasgow, Edinburgh, St. Andrews, and Aberdeen; Victoria University, Manchester; University College, London; and King's College, London; provided such Candidates shall have passed the Final Examination to the satisfaction of the Civil Service Commissioners, and shall, in the opinion of the Secretary of State, have conducted themselves well and complied with such rules as may be laid down for the guidance of Selected Candidates. The whole probation must ordinarily be passed at the same Institution. Migration will not be permitted except for special reasons approved by the Secretary of State.
- (iii.) The allowance of £100 will not be paid to any Selected Candidate until he has been certified by the Civil Service Commissioners to be entitled to be appointed to the Civil Service of India ; and every Certificated Candidate must, before receiving his allowance, give a written undertaking to refund the amount in the event of his failing to proceed to India.
- (iv.) All Candidates obtaining Certificates will be also required to enter into covenants, by which, amongst other things, they will bind themselves to make such payments as under the rules and regulations for the time being in force they may be required to make towards their own pensions or for the pensions of their families. The stamps payable on these covenants amount to £1.
- (v.) The seniority in the Civil Service of India of the Selected Candidates will be determined according to the order in which they stand on the list resulting f om the combined marks of the Open Competitive and Final Examinations.
- (vi.) Selected Candidates will be required to report their arrival in India within such period after the grant of their Certificate of Qualification as the Secretary of State may in each case direct.
   (vii.) Candidates who fail to satisfy the Civil Service Commissioners at the Final Examination
- (vii.) Candidates who fail to satisfy the Civil Service Commissioners at the Final Examination held in any year will be definitely rejected, and will not be allowed to present themselves for re-examination, unless it shall appear to the Secretary of State in Council, after reference to the Civil Service Commissioners, that such failure is due to circumstances wholly exceptional and beyond the control of the Candidate.

The Commissioners have been requested by the Secretary of State for India to draw the attention of selected Candidates to the prefatory note attached to this manuel, as it is considered important that it should be clearly understood that this compilation is not to be regarded in any other light than that of a constitumade for facility of reference, of certain information and rules, that it is by no means exhaustive, and that it is liable to such modifications as may from time to time be sanctioned by competent authority.

#### Clerkships (Class I.) in the Home Civil Service ; and Eastern Cadetships.

Syllabus showing the Extent of the Examination in certain Subjects for 1907.

English Composition.—An Essay to be written on one of several subjects specified by the Civil Service Commissioners on their Examination Paper.

English Language and Literature.—The Examination will be in two parts. In the one the Candidates will be expected to show a general acquaintance with the course of English Literature, as represented (mainly) by the following writers in verse and prose, between the reign of Edward III. and the accession of Queen Victoria :

Verse.—Chaucer, Langland, Spencer, Shakespeare, Milton, Dryden, Pope, Gray, Collins, Johnson, Goldsmith, Crabbe, Cowper, Campbell, Wordsworth, Scott, Byron, Coleridge, Shelley, Keats.

Prose.—Bacon, Sir Thomas Browne, Milton, Cowley, Bunyan, Dryden, Swift, Defoe, Addison, Johnson, Burke, Scott, Macaulay (Essays and Biographies).

A minute knowledge of the works of these authors will not be looked for in this part of the Examination. which will, however, test how far the Candidates have studied the chief productions of the greatest English writers *in themselves*, and are acquainted with the leading characteristics of their thought and style, and with the place which each of them occupies in the history of English Literature. Candidates will also be expected to show that they have studied in these authors the history of the English Language in respect of its vocabulary, syntax, and prosody.

The other part of the Examination will relate to one of the periods named below, which will follow each other year by year in the order indicated.

The Examination in this part will require from Candidates a more minute acquaintance with the history of the English Language and Literature, as illustrated in the chief works produced in each period, and will be based to a considerable extent, but by no means exclusively, on certain books specified each year by the Commissioners.\* The names placed under the dates are intended to suggest the general character of the literary development of the period, and, consequently, the natural limits of the Examination. All the works of Shakespeare, for example, will be regarded as falling within the period 1600 to 1700; all the works of Swift within the period 1700 to 1800; all the works of Scott and Wordsworth, and all the works of Macaulay within the period 1800 to 1832.

Italian Language and Literature.—Translation and Composition. Critical questions on the Italian Language and Literature. Conversation.

French Language and Literature.—Translation and Composition. Critical questions on the French Language and Literature. Conversation.

German Language and Literature.—Translation and Composition. Critical questions on the German Language and Literature. Conversation.

Latin Language and Literature.—Translation from Latin into English, Composition in Prose and Verse, or (as an alternative for Verse-Composition) an original Prose Composition in Latin. Critical questions on the Latin Language (including questions on Philology) and Literature.

Greek Language and Literature.—Translation from Greek into English, Composition in Prose and Verse, or (as an alternative for Verse-Composition) an original Prose Composition in Greek. Critical questions on the Greek Language (including questions on Philology) and Literature.

Sanskrit Language and Literature.—Translation from Sanskrit into English, and from English into Sanskrit. History of Sanskrit Literature (including knowledge of such Indian history as bears upon the subject); Sanskrit Grammar; Vedic Philology.

Arabic Language and Literature.—Translation as in Sanskrit ; History of Arabic Literature (including knowledge of such Arabic History as bears upon the subject) ; Arabic Grammar ; Arabic Prosody.

English Law.—Under the head of "English Law" are included the following subjects, viz. :--(1) Law of Contract; (2) Law of Evidence; (3) Law of the Constitution; (4) Criminal Law; (5) Law of Real Property; and of these five subjects Candidates are at liberty to offer any four, but not more than four.

English History.—The subject will include (a) the Political History of Great Gritain. Ireland, and the Colonies, (b) the Constitutional History of the United Kingdom. Candidates should be acquainted with the following authorities :—

# Fifteenth Annual Report of the Ceylon Public Service Mutual Guarantee Association, Year ended 30th June, 1906.

 $O^{N}$  30th June, 1906, there were on the books of the Association 775 members as against 668 on 30th June, 1905, showing an increase of 107 in membership.

2. The contributions received from the members during the year aggregated Rs. 7,174.50 as against Rs. 9,947.12 in the previous year.

3. A sum of Rs. 3,172.46 has been refunded to members on withdrawal from the Association or on account of over-remittance, as against Rs. 10,868.17 during the previous year.

4. During the year the Association was not called upon to make good any claims on account of defaulting members, but a sum of Rs. 2.50 was paid for stamp duty on the assignment of the bond of Mr. E. Sumanasekera, an employee in the Railway Department, on account of whose default the Association suffered a nett loss of Rs. 9.01 during the preceding year.

5. The Association having closed the 5th triennium of its existence, a sum of Rs. 5,467 66 became available for distribution on 1st July, 1906, amongst the members as profits. This enabled the apportionment of a dividend of 7 per cent. on the total contributions to credit of members on 30th June, 1906, absorbing in the aggregate a sum of Rs. 5,342 08 and leaving a balance of Rs. 12558 to credit of Profit and Loss account.

## COLOMBO WEEKLY HEALTH REPORT.

THE weekly return of births and deaths in the Colombo town for the week nded 18th August, 1906, is subjoined (A).

Births.-The total births were 88. The birth-rate per 1,000 was 26.5,\* as against 22.9 in the

Deaths.—The total deaths were 128. The death-rate point,000 was 38.5,\* as against 41.2 in the previous week and 25.2 in the corresponding week of last year.

Causes of death.-No persons died from cholera; smallpox, or measles; 20 died from diarrhœa and dysentery; 33 from phthisis, bronchitis, and pneumonia; 8 from different kinds of fever; and 9 from infantile convulsions.

In/antile deaths.-Of the 128 total deaths, 33 were of infants under 1 year of age, as against 24 in the corresponding week of the previous year.

5. Exhibits may bear the name of the estate from which they are exhibited or any other distinctive mark.

All exhibits to be accompanied by a ticket giving the name of the exhibitor and the number of the 6. the class in which the article is offered for competition.

7. The number to be attached to the article exhibited should be that given in the List of Awards as specified in the Catalogue.

8. No single exhibit can compete for more than one prize ; this does not prevent an exhibitor from entering duplicate samples for other prizes.

15. Entries must state the nature of the exhibit, the weight (where it can be given), and the probable space required at the Exhibition.

16. Entries for machinery, requiring power, are extended to August 13th, 1906.

17. Entries of all exhibits except machinery requiring power to reach the Secretary on or before September 6th.

18. Exhibitors sending machinery, to be driven by hand or power, will be expected to provide their own assistants to work the machinery.

Competitors not resident in Ceylon may compete for all prizes marked Open to Ceylon and Abroad, and for the special prize for the best commercial sample of Rubber in the Show ; exhibitors from Malaya and India respectively are alone eligible for the Gold Medals offered for the best exhibits of Rubber from these countries.
