## PRELIMINARY NOTICES.

### Notice under Ordinance No. 1 of 1897 as amended by Ordinance No. 1 of 1899.

TAKE notice, that unless within three months from the 1st day of August, 1906, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in either of them, appear before the Hon. the Government Agent, Kandy, and make claim to the said lands or to some interest therein :

Such Government Agent, in pursuance of the powers in him vested by Ordinance No. 1 of 1897, will declare by writing under his hand that the said lands, or any part of them to which no claim has been made, are the property of the Crown.





Situation : Udawelipitiya village in Medagam pattu.


