NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 19th day of December, 1902, the persons, if any, who claim any interest in the land hereinafter mentioned, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said land or to some interest therein:

Such Special Officer, in pursuance of the powers vested in him by the said Ordinances, will declare by writing under his hand that the said land, to which no claim has been made, is the property of the Crown.

Description of the Land referred to.

The land commonly called or known as Wewelwaha-natura, situated in the village of Kotapola in the Morawak korala of the Matara District, in the Southern Province, containing in extent 61 acres and 9 perches shown as lot 328 in sheets O₂-10¹⁵ and O₃-11¹⁵ and preliminary plan 45, and in the annexed certified tracing therefrom, and bounded as follows: on the north by Wewelwakumburuya claimed by Korawego Don Thomas and others; on the east by Wewelwaha-deniyakumbura sold by Crown to K. Wattu and another (T.P. 118,892), Okandahena claimed by D. D. W. Jayasuriya, the village limit of Mologgamuwe; on the south and west by the footpath.

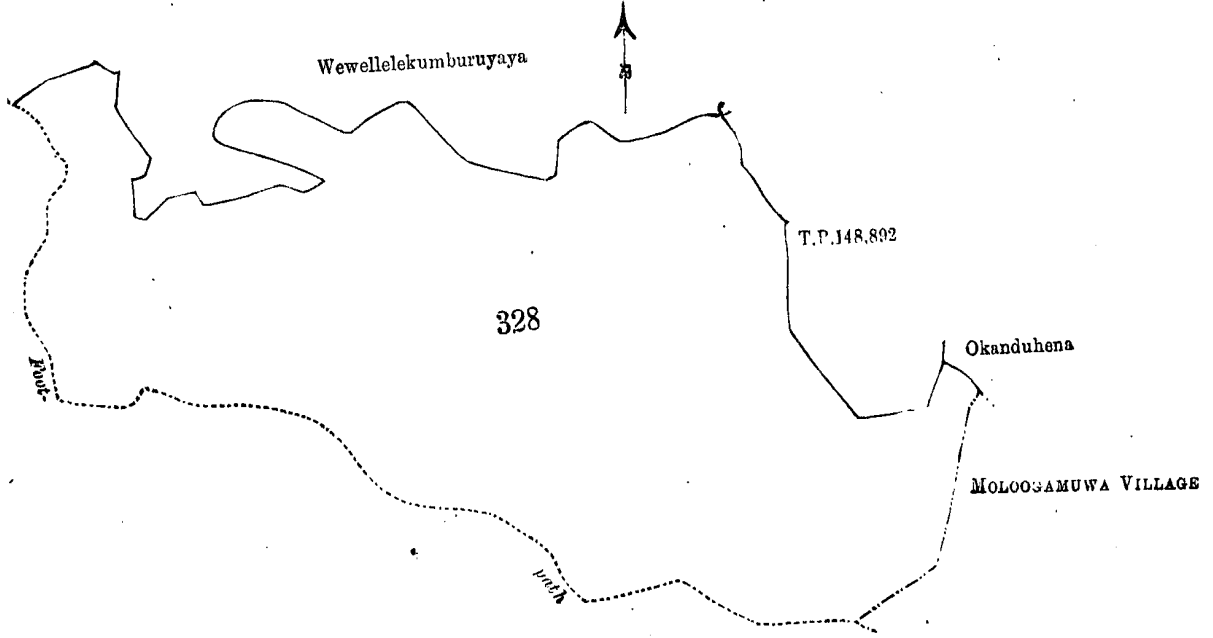
