"THE CACAO THEFTS PREVENTION ORDINANCE, 1904."

W HEREAS by Proclamations dated November 11, 1904, and September 11, 1907, respectively, issued under the provisions of section 2 (1) of "The Cacao Thefts Prevention Ordinance, 1904," the said Ordinance was declared to be in force within the limits of the places defined and set forth in the schedules thereto:

VITAL STATISTICS.

COLOMBO WEEKLY HEALTH REPORT.

THE weekly return of births and deaths in the Colombo town for the week ended May 2, 1908, is subjoined.

Births.—The total births were 90. The birth-rate per 1,000 per annum was 26.1,* as against 27.3 in the preceding week and 23.0 in the corresponding week of last year.

Deaths.—The total deaths were 131. The death-rate per 1,000 per annum was 42:3,† as against 34:2 in the previous week and 29:5 in the corresponding week of last year.

Causes of death.—No person died from cholera, smallpox, or measles; 18 died from diarrhoea and dysentery; 12 from phthisis; 24 from bronchitis and pneumonia; 2 from different kinds of fever; and 17 from infantile convulsions.

Infantile deaths.—Of the 131 total deaths, 42 were of infants under 1 year of age, as against 22 in the corresponding week of the previous year.

* Calculated on the estimated population on July 1, 1908, viz., 180,262.

† The rates given for this and the preceding week are the corrected rates, i.e., the rates calculated for the population of the town estimated on July 1, 1908, on the basis that its age- and sex-constitution is the same as for the Island. The rate shown for the corresponding week of last year is the crude rate.
