MINUTES BY THE GOVERNOR.

EXAMINATIONS FOR CLERKS IN THE NATIVE LANGUAGES AND ACCOUNTS.

1. His Excellency the Governor has been pleased to direct that elementary book-keeping be made a compulsory subject for the competitive examinations to be held after January 1, 1909, for entrance into Class III. of the Clerical Service.

2. Every clerk appointed between January 1, 1906, and December 31, 1908, to Class III. of the Clerical Service will be required to pass an examination in the subjects hereinafter specified to entitle him to promotion to Class II. The term " clerk " includes interpreters and translators.

- 3. The subjects of the examination will be (a) the two vernacular languages, Sinhalese and Tamil; and (b) the system of accounts employed in Government Offices. Clerks required to take up the examination under this section will however be permitted, should they so desire, to take up the higher standard examination prescribed under section 5 below for clerks appointed from or after January 1, 1909.
 - 4. The examination in Sinhalese and Tamil will be divided into-
 - (a) Conversation and interpretation.

(b) Reading and writing.

5. Every clerk appointed from or after January 1, 1909, to Class III. of the Clerical Service will be required to pass an examination in a higher standard of Book-keeping, in addition to the examination under section 3 (b) above, to entitle him to promotion to Class II.

6. Clerks of Sinhalese, Tamil, Malay, and Moor parentage will be required to pass in conversation and interpretation and in reading and writing in both languages, or in one language and accounts, or in one language and accounts and the examination under section 5 above, as the case may be.

7. Clerks of other parentage will be required to pass in accounts, or in accounts and in the examination under section 5 above, as the case may be, and in conversation and interpretation in one or the other of the two languages named.

8. In the examination under section 4(a) above the candidate will be tested in conversation so as to satisfy the examiner as to his power of understanding natives of different classes and of making himself understood by them both in common conversation and in the course of official business. He will also be required to act as interpreter between the examiner and natives perfectly ignorant of English, the interpretation to be on matters connected with ordinary official business. The candidate will be required in this examination to obtain a minimum of 50 per cent. of the total marks in the vernacular which has been spoken by, or familiar to, him as a child, and a minimum of 33 per cent. of the total marks in the other vernacular if he be required to pass in a second language.

9. In the examination under section 4 (b) above the candidate will be required to write an English translation of two short Sinhalese or Tamil reports from headmen, written in different running hands, to translate a short English order to a headman into Sinhalese or Tamil, and to read and translate an' extra extract from a Sinhalese or Tamil notarial deed and from the proceedings of a Gansabhawa case put into his hands for the first time. The candidate will be required in this examination to obtain a minimum of 50 per cent. of the total marks in the vernacular which has been spoken by, or familiar to, him as a child, and a minimum of 33 per cent. of the total marks in the other vernacular if he be required to pass in a second language.

10. Candidates for the examinations under section 3 (b) and section 5 above will be required to obtain a minimum of 50 per cent. of the total marks in accounts or in accounts and book-keeping, as the case may be.

11. The examination will be conducted on the above system of marks, and the time allotted to each subject will be fixed by the examiners.

12. The examination will be held half-yearly in Colombo, and a candidate may take up the various subjects, if he so desire, in two sections at two separate periods section (a) consisting of Sinhalese, section (b) of Tamil, or section (c) of accounts or accounts and book-keeping, as the case may be.

 \pm 13. The expenses of all clerks attending an examination will be paid by Government at the rates laid down in the Minutes on Travelling Allowance, provided the examiners certify that the candidate was, with the knowledge exhibited by him, reasonably justified in presenting himself for examination.

14. The Minute dated December 13, 1907, published in the Gazette of the same date, is hereby cancelled.

Now know Ye that We, the said Governor, in exercise of the powers vested in Us by the said section of the said Ordinance, do hereby proclaim and declare that the said road of 17 mile in length, leading from the Norton bridge to the Glengariff factory in Dikoya, in the District of Kandy, Central Province, constructed by the proprietors of Vellai-oya, Dandukelawa, Glengariff, Donnybrook, and Hardenhuish estates, shall, as from and after January 1, 1909, be treated as a road made under the said Ordinance, "The Estate Roads Ordinance, 1902."

The examination in the Criminal Procedure Code prescribed under the Minute of March 26, 1900, for officers in the Fourth Class of the Civil Service, will also be held on July 28, 1908, as well as at the Kandy Kachcheri.

It is also hereby notified that candidates will be given the option of using Codes in the examination in the Criminal Procedure Code and the Penal Code; they must, however, state when sending in their names what their decision is, as the character of the papers set for those who use Codes and those who do not will be different.



VITAL STATISTICS.

COLOMBO WEEKLY HEALTH REPORT.

THE weekly return of births and deaths in the Colombo town for the week ended June 13, 1908, is subjoined.

Births.—The total births were 85. The birth-rate per 1,000 per annum was $24 \cdot 7$,* as against 27.3 in the preceding week and 23.0 in the corresponding week of last year.

Deaths.—The total deaths were 119, including the death of a town resident who died in the Infectious Diseases Hospital at Kanatta. The death-rate per 1,000 per annum was $38.4,\dagger$ as against 38.7 in the previous week and 31.0 in the corresponding week of last year.

Causes of death.—No person died from cholera, smallpox, or measles; 14 died from diarrhœa and dysentery; 12 from phthisis; 21 from bronchitis and pneumonia; 12 from different kinds of fever; and 9 from infantile convulsions.

Infantile deaths.—Of the 119 total deaths, 30 were of infants under 1 year of age, as against 26 in the corresponding week of the previous year.

* Calculated on the estimated population on July 1, 1908, viz., 180,262.

† The rates given for this and the preceding week are the corrected rates, *i.e.*, the rates calculated for the population of the town estimated on July 1, 1908, on the basis that its age- and sex-constitution is the same as for the Island. The rate shown for the corresponding week of last year is the crude rate.
