THE following rules made by the Director of Irrigation for the Batticaloa District of the Eastern Province, under section 56 (3) of "The Irrigation Ordinance, 1906," after consultation with the Government Agent, and which have been approved by the Governor in Executive Council, are published for general information.

Rules framed under the Irrigation Ordinance, No. 16 of 1906, for the Batticalov District of the Eastern Province to be observed by the Proprietors and Oultivators of Irrigable Lands under Major Irrigation Works.

1. The works are in charge of the Director of Irrigation, and the term "Irrigation Engineer" when employed in these rules refers to the Irrigation Officer appointed by him to exercise control over the works.

The term "Superintendent" refers to the Irrigation Headman appointed to supervise the cultivation over a tract or series of tracts of fields. When no Superintendent has been appointed, his duties will be performed by the Irrigation Engineer.

The Vaddai Vidane is the minor Irrigation Headman in charge of a subdivision of the above tracts or series of tracts.

The Adigari is the assistant of the Vaddai Vidane.

2. The Superintendent shall be appointed by the Director of Irrigation. The Vaddai Vidanes shall be appointed by the Director of Irrigation, who, if he considers it desirable, shall request the proprietors to nominate them.

The Adigaris shall be nominated by the Vaddai Vidanes. The nomination must be approved by the Irrigation Engineer, and the Vaddai Vidanes are responsible for the acts of their assistants.

3. The Vaddai Vidanes shall have entire supervision of all works of irrigation and paddy cultivation within their respective divisons, subject to instructions from and the control of the Irrigation Superintendent. They shall enforce the following rules, and bring all breaches of the same before the Irrigation Superintendent in order that prosecutions may be entered. Both Superintendents and Vaddai Vidanes shall be liable for any neglect of duty proved to the satisfaction of the Irrigation Engineer as for a breach of the rules.

4. The Vaddai Vidanes shall be entitled to receive from the cultivators one marakal of paddy for each avanam sown as Vaddai Vidane's share; and when an Adigari has been appointed, one marakal per avanam in addition shall be set apart for Adigari's share; if more than one Adigari has been appointed, this share shall be divided proportionately between them. The whole or any portions of these payments may be withheld if, in the opinion of the Irrigation Engineer, the work has been improperly performed, and he may, if he consider it necessary, cause the amount withheld to be paid to any person who has acted for a Vaddai Vidane or an Adigari.

5. As the season for cultivation approaches, whether it be munmari, kalavelama, or pinmari, a Village Council meeting of the proprietors of lands concerned shall be convened in the manner required by paragraph 22, chapter VI., of Ordinance No. 16 of 1906. The meeting shall be convened and presided over by an Irrigation Officer holding the deputation of the Government Agent as required by paragraph 22, chapter VI., of the Irrigation Ordinance referred to above, and the date of the meeting shall be fixed by him.

6. The meeting convened as in the last paragraph shall—

(a) Determine the order in which the different vaddais shall be sown.

- (b) Determine the date for the commencement of cultivation and the method of cultivation in each vaddai.
- (c) Determine the kind of paddy to be sown in each vaddai.
- (d) Elect Vaddai Vidanes if required by the Director of Irrigation to do so.
- (e) Determine the place and manner in which black cattle and buffaloes are to

be confined during cultivation.

7. Should it not be possible to commence cultivation on the date fixed, the Irrigation Superintendent shall grant such extension as appears to him necessary, and shall decide what portions of the tracts are to be cultivated if the water available is insufficient.

8. The Irrigation Superintendent shall cause the decisions of the meeting under rule 6 or his own decisions under rule 7 to be published by beat of tom-tom or otherwise, and all proprietors shall be bound to commence cultivation on the day fixed.

9. Each proprietor shall deliver to the Vaddai Vidane not later than on the day fixed for the commencement of cultivation a list of the mullecaran and cultivators to be employed in his field. This list shall be in a form approved by the Irrigation Superintendent, and shall bear the signatures of the proprietor and of the mullecaran and cultivators or their marks made before two witnesses. From the date of the delivery of the list the mullecaran and cultivators become liable for all works of cultivation, and in the event of neglect or default without sufficient reason are liable to prosecution. The proprietor must deliver the list to the Vaddai Vidane, or give notice in writing that he does not intend to cultivate before the date fixed for cultivation under rule 6, even if that date should have been extended by the Irrigation Superintendent.

10. The list referred to in rule 9 shall also state how many cattle and buffaloes the proprietor or his lessee intends to retain in the field for the purposes of cultivation, with the name of the person who shall be responsible for their removal at the close of cultivation.

11. The list shall also state the number of black cattle and buffaloes to be disposed of by the proprietor or lessee before the commencement of cultivation in the manner required by rule 6 (e) with the names of the persons who are to watch them. One watcher must be provided for every 25 head of cattle and buffaloes, whether used in cultivation or not, and the watchers must sign the list, and shall be responsible for failure to properly perform their duties like the other cultivators.

12. Should it appear to the Director of Irrigation necessary, he may cause Vaddai Vidanes and Adigaris to be appointed to specially enforce the rules 10 and 11, and shall cause them to be paid from the maintenance vote for the works.

13. Should it be found that any proprietor does not intend to cultivate his share, the Vaddai Vidane shall submit the matter to the Irrigation Superintendent, who may allow such share to be cultivated by any other proprietor or cultivator in the tract. Such other proprietor or cultivator shall not be liable for any payment to the proprietor of the land, but shall be liable for everything required by these rules for the season's cultivation to the same extent as if he were the proprietor of the field thus apportioned to him.

14. No proprietor shall be exempt from contributing everything required by these rules for the season's cultivation if his land shall be uncultivated, unless he has given proper notice under rule 9 or his land shall have been excluded under rule 7. In the event of his becoming liable for any work and failing to perform it, the Irrigation Engineer shall inform the Government Agent in writing of the estimated cost thereof. The Government Agent shall advance the sum necessary from the Irrigation Fine Fund if he has a sufficient balance, and shall proceed to recover the amount, together with costs and fines, as provided in Irrigation Ordinance, No. 16 of 1906.

15. All channels shall be cleared by the cultivators in proportion to the respective shares of the proprietors.

16. Trees or jungle likely to occasion damage by giving cover to birds or wild animals shall be removed by the cultivators of the land whereon they may be growing.

17. Paths between cultivated places shall be kept open by the cultivators according to the limits prescribed by ancient custom and in proportion to their respective shares.

18. The periods during which water shall be issued to the different vaddais shall be fixed by the Irrigation Superintendent, and the distribution of the water within the vaddai shall be regulated by the Vaddai Vidane. During the period in which his vaddai is entitled to receive water, the Vaddai Vidane thereof may cause any dam which impedes the flow of water thereto to be cut, and any channel which is depriving it of water to be closed. Excepting during that period, he may interfere with no dam or channel outside his vaddai.

19. If any person shall wilfully prevent water from flowing to the field below his own, or shall obstruct the flow of surplus water from the field on a higher level, or shall in any other way interfere with the general distribution of water, the Vaddai Vidane shall proceed to the spot with witnesses and open the gaps or remove the obstruction himself, and no person shall issue, distribute, cut off, divert, or use the water in any manner except in accordance with his instructions.

20. The fence round the whole vaddai shall be measured by the Vaddai Vidane within three days of sowing being completed, and by him apportioned to the culti-

vators of each proprietor in proportion to the extent of the proprietor's field without regard to whether the fence adjoins his field or not. If fresh sticks are required the Vaddai Vidane shall inform the Irrigation Superintendent, who will obtain a license for him to have them cut.

21. The cultivators shall finish the fence. which shall be of stakes, within the time fixed by the Vaddai Vidane, and each cultivator shall construct a watch hut in the centre of the portion of the fence erected by him. The cultivators shall keep both fence and watch hut in repair, and shall keep regular watch in accordance with the orders of the Vaddai Vidane.

22. The mullecarans shall accompany the Vaddai Vidane or his Adigari with lights on their rounds at night until such time as the Vaddai Vidane considers this no longer necessary.

23. Should any portion of any tract ripen before the rest from any cause, the cultivators thereof shall be allowed to reap and store their crop, but shall continue to watch the field and preserve the fence until the crops of the remainder of the vaddai have been reaped and stored. Should any portion of a tract not ripen until, after the reaping of the crops sown in accordance with the decision in rule 6 (c) either on account of default in sowing in proper time or because of the sowing of a

different kind of paddy, the cultivators of the other portion of the tract shall not be bound to continue preserving the fence and watching the field until that portion of the tract ripens.

24. After the reaping is over the Vaddai Vidane shall order the removal of the fence, and shall cause the fence sticks to be heaped by the cultivators in such places as he may direct. No one shall remove fence sticks without the consent of the Vaddai Vidane.

The threshing-floor shall be cleared and fenced with a strong fence of stakes 25. by the joint labour of all the cultivators. The paddy shall be stacked there, and the cultivators shall take their turn in watching the stacks.

No paddy shall be removed from the threshing-floor at the termination of **26**. the harvest until the shares due to the Headmen under rule 4 and the wages due to all persons engaged in the harvest and the hire of cattle have been paid.

27. Village tanks, dams, minor channels, water-courses, or other minor works shall be repaired or improved by the proprietors, whenever the Irrigation Engineer shall consider it necessary. The work to be performed by each proprietor shall be in proportion to the extent of land dependent on the work in question held by him.

28. Should any new channel be required either outside or inside any field, it shall be constructed by the proprietors interested in proportion to their holdings as in rule 24. The channel will be set out and pegs put in under the orders of the Irrigation Engineer. All proprietors must grant way leave for such channels, even though their land may not be benefited thereby.

29. No new tank, dam, channel, or other work shall be constructed without the consent of the Irrigation Engineer. If new tanks or dams are necessary he will order their construction, and determine by whom they are to be made.

Should any proprietor fail to perform the work required under rules 27, 28, 30. and 29 within the time fixed by the Irrigation Engineer, it shall be done, and the cost of doing it, together with costs and fines, recovered as provided in rule 14.

31. No person shall in any way alter or injure any ridge or boundary between two fields in the same tract. On information that such alteration or injury has been effected, the Vaddai Vidane shall proceed to the spot with witnesses and restore the boundary to its original state. Such restoration can only be done within eight days of the commission of the offence.

32. The owners and cultivators of all land which may have been or may hereafter be bought from the Crown or from others shall become liable to the provisions of these rules, and shall be entitled to secure water from any of the channels which may be most advantageous to their land so soon as it shall be declared irrigable and included in the specification of land irrigable from the work. Such owners and cultivators shall in all respects enjoy the privileges and rights that belong to the owners and cultivators of the lands already irrigable.

33. A Village Council may be convened as in paragraph 5 whenever the Irrigation Engineer considers it desirable to obtain the advice or assistance of the proprietors in any matter concerning the cultivation.

34. These rules are to be enforced by the Irrigation Engineer and such other Irrigation Officers and Headmen as may from time to time be appointed, and breaches of the rules are punishable as provided in the Irrigation Ordinance, No. 16 of 1906.

35. All previous rules are cancelled.

THE following rules made by the District Committee, Kandy, under section 12 of "The Buddhist ²ATemporalities Ordinance, 1905," which have been approved by the Governor and the Executive Council, are published for general information.

Rules framed by the District Committee, Kandy, under Section 12 of the Buddhist Temporalities Ordinance, No. 8 of 1905.

1. Three members of the District Committee shall form a quorum.

2. In the absence of the President at any meeting, one of the members present shall be elected as President for the occasion.

The Committee shall appoint one of their members as Honorary Secretary 3. for the working of the Ordinance, and shall employ as many clerks and messengers as may be found necessary.

The Honorary Secretary shall enter in a book the business to be placed before 4. each meeting, and shall record in another book the minutes of the proceedings of each meeting, and the minutes shall be read and confirmed from time to time at every subsequent meeting, the President signing such confirmation.

5. Every question coming before the meeting shall be decided by a majority of votes. Whenever the votes of members present happen to be equally divided, the President shall, besides his vote as a member, have a casting vote.

6. The meetings of the Committee shall be held at the office of the Committee in Kandy on the first Saturday of every month at 2 P.M. The Committee shall have the power, however, to meet at any other time or place in the district upon forty-eight hours' notice in writing being given to the members of the time and place of each meeting.

7. The President shall have the power to convene a special meeting of the Committee at any time by giving the other members not less than forty-eight hours' notice thereof in writing, and it shall be his duty to convene such meeting if and whenever any two or more members by application in writing request him to convene such a meeting.

8. In the event of the Diyawadana Nilameship of the Dalada Maligawa or the Basnayaka Nilameship of a dewale become vacant, the President shall convene a meeting of persons entitled by section 17 of the Ordinance to vote at the election of a Diyawadana Nilame or a Basnayaka Nilame. The President shall preside at such meeting, but in his absence or in the event of his being a candidate a President shall be chosen by the electors present. All candidates appointed at such elections shall hold certificates of recognition under the hand of the President, and such certificates shall be the only proof of appointment.

9. The President shall likewise convene from time to time a meeting of the Committee for the election of a trustee or trustees for each temple or vihare under section 17 of the Ordinance. The President shall preside at such meeting, but in his absence or in the event of his being a candidate, a President shall be chosen by the electors present. All candidates appointed at such elections shall hold certificates of recognition under the hand of the President, and such certificates shall be the only proof of appointment.

10. A candidate for a Diyawadana Nilameship, Basnayaka Nilameship, or trusteeship shall possess all the qualifications described in section 8 of the Ordinance, and the fact of possessing such qualifications shall be verified by an affidavit affirmed to by him.

11. If any trustee of a temple to whom due notice in writing with a certified copy of the charge or charges preferred against him has been given fail, without showing sufficient cause, to answer such charge or charges, the inquiry shall be proceeded with in his absence. Any such trustee feeling aggrieved by such *ex parte* decision shall be entitled to ask for a re-hearing, provided he shall show sufficient cause for his default of appearance at the inquiry.

12. At the end of each financial year the trustees shall deposit in a bank, to be selected by the Committee, all surplus funds which they may have in their hands, and shall under the directions of the Committee draw therefrom all such sums as may be actually required for the use and benefit of the different temples.

13. All moneys, whether small or large, received by trustees under the names of gamanhiga and murapalu, which come within the meaning of the terms "offerings," "rents," "issues," and "profits" in section 21 of the Ordinance shall, be faithfully and correctly accounted for by every trustee, and its hall be the duty of every trustee to keep a receipt book in duplicate (in a form to be issued by the Committee) and to enter therein receipts for all sums and other things received by them as rents and issues. A copy of such receipt shall be issued to the person from whom such rents and issues have been received, and the counterfoil thereof shall be retained as a voucher and produce when accounts are rendered.

14. No trustee or any incumbent priest shall on any pretext whatever sell or otherwise dispose off any movable property of any temple without first obtaining, the sanction in writing of the Committee, and in case of such sanction being obtained the sale shall be by public auction.

15. Every trustee shall within three months of his appointment furnish full and

or otherwise alienated before the passing of the Ordinance.

16. No trustee shall grant any lease of temple land without the sanction in writing of the Committee, and every trustee who, with the permission of the Committee, grant a lease of land belonging to any temple, shall forward a copy of such lease to the Committee to be filed in their office.

17. The Committee shall have the power, whenever they deem it necessary or expedient so to do, to authorize one or more of their members or any person or persons to be deputed by them to inspect and report upon the condition and management of any temple, and the lands belonging thereto sought to be leased and the expenses of such inspection shall be paid out of the funds of the particular temple concerned.

18. The Committee shall have power to inspect and examine all the books and movable property and moneys of any temple and the accounts and papers of any trustee by deputing one or more of their members for the purpose at any time and as often as the Committee deem such inspection necessary. 19. All repairs to temples and all improvements thereto shall be effected by the trustees themselves or by giving the same on contract with the approval and direction of the Committee.

20. Money and all other offerings made to any temple, including the Dalada Maligawa, shall be verified by the Diyawadana Nilame in the manner following on the last day of the month:—In the case of the Dalada Maligawa by the Diyawadana Nilame and by one of the Maha Nayaka Theros of Asgiriya and Malwatte College, who at the time is directly in charge of the management (tewakarima); in the case of other Buddhist temples by the trustees Adika Bhikkus and Thewakarna Bhikkus; and in the case of dewalas by Basnayaka Nilames and the Kapuralas (lay priests) and the Lekamas.

21. All trustees shall half-yearly in each year make full returns (in the Form A hereto annexed) of all movable property and moneys in their hands and forward them to the Committee.

22. In the event of the property of a temple or vihare being given in charge of the trustee thereof, it shall be the duty of the member of the district to give charge of the same in the presence of two witnesses and the incumbent of the temple. The member shall be bound to fill up three forms (Form B hereto annexed), one of which shall be delivered to the incumbent of the temple, one to the trustee, and the other to the Committee; and it shall be the duty of the trustee to deliver to the incumbent such property as may be required by him for the use of the temple and obtain two receipts from him, one of which shall be retained by the trustee and the other shall be forwarded by him to the Committee.

23. In the event of the property of a dewale (other than the four dewales in Kandy) being given in charge of the trustee thereof, it shall be the duty of the member of the district to give charge of the same in the presence of two witnesses. The member shall be bound to fill up two forms (Form B hereto annexed), one of which shall be delivered to the trustee and the other shall be forwarded to the Committee.

24. In the event of the property of the four dewales in the town of Kandy being given in charge of the respective trustee or trustees thereof, it shall be the duty of the President of the Committee to give charge of the same in the presence of two witnesses. The President shall fill up two forms (Form B hereto annexed), one of which shall be delivered to the trustee and the other to the Committee.

25. In the event of the property of the Dalada Maligawa being given in charge of the trustee thereof, it shall be the duty of not less than five persons out of the body of persons consisting of the President and a member of the District Committee, two Ratemahatmayas to be nominated by the Committee, one Basnayaka Nilame out of the four dewalas in Kandy, and two High Priests of the Malwatte and Asgiriya Vihares to give charge of the same and obtain five receipts (in the Form B 1 hereto annexed) from the trustee, one of which shall be delivered to the trustee, one to the High Priest of the Malwatte Vihare, one to the High Priest of the Asgiriya Vihare, one to the Hon. the Government Agent, and one to the Committee.

26. It shall be the duty of the trustees to keep a book of receipts and disbursements and to make a statement of such accounts at the close of every half-year (in the Form C hereto annexed), and the trustees shall sign a declaration at the foot thereof that the accounts are "true and correct," and shall transmit the same within thirty days from the end of each half-year to the nearest District Court. The District Court upon receipt of the statement shall commission such person as it-thinks fit to examine and audit such accounts, and such auditor shall be entitled to such remuneration as the court shall determine. The trustee shall be bound at the same time to send a copy of such accounts to the District Committee for its information and guidance.

27. It shall be the duty of the trustee on or before October 31 in each year, to prepare and transmit to the District Committee a statement showing the nature and amount of the probable receipts and the particulars of the proposed disbursements for the next ensuing year.

28. It shall be lawful for the District Committee to revise such statement, and such statement after being revised and passed shall be returned to the trustee, who shall on no account exceed any item of expenditure specified in such statement without the previous sanction in writing of the District Committee.

29. Every temple shall contribute an amount proportionate to its income for defraying the expenses already incurred or to be incurred by the Committee in carrying out the provisions of this Ordinance.

30. The President shall on or before June 30 in each year prepare and submit to the Committee

(a) Estimates showing the probable receipts of each temple within his jurisdiction.

(b) Estimates of proposed disbursements for the next ensuing year.

31. The Committee shall carefully revise the estimates laid before them by the Président, and shall assess and determine the amounts which each temple shall contribute.

32. The President shall deposit in a bank selected by the Committee all contributions from temples, and shall make disbursements under the directions of the Committee by cheques to be drawn by the President and a member of the Committee authorized to draw such cheques. At every monthly meeting of the Committee the President shall submit a statement of receipts and expenditure, and produce his bank books and cheque book for inspection.

33. The Karaka, Sangha Sabhawa of the Malwatte Vihare shall constitute the board of electors for selecting and appointing incumbents to any Buddhist temple belonging to that college and not falling within any special tenure.

34. The Maha Nayaka and Anu Nayaka Theros of each vihare shall ex-officio be President and Vice-President of each Sangha Sabhawa respectively.

35. In the event of any incumbency other than the incumbencies above described becoming vacant, the President shall convene a meeting of the Sangha Sabhawa by giving not less than fourteen days' notice in writing to its members.

36. Candidates for incumbencies shall be persons well read in Dhammavinaya and well-qualified teachers holding certificates of qualification as such from a board of examiners chosen by the two colleges of Malwatta and Asgiriya.

37. Each Sangha Sabhawa shall, in accordance with Buddhistical law or Dhammavinaya, elect and appoint a qualified and well-conducted person as incumbent of each temple under its jurisdiction, and shall report such appointment to the District Committee. If the District Committee approve of the election, a certificate of recognition shall be issued to the incumbent under the hand of the President, and such certificate shall be the only proof of appointment to such temple.

38. The board shall elect one of their members to be Honorary Secretary, who shall keep two bound books, in one of which he shall enter the names of the respective candidates, and in the other of which he shall record the proceedings of the meetings of the board. The Honorary Secretary shall within three days of such meeting present the books to the President and Vice-President of each Sangha Sabhawa, who shall sign the proceedings so recorded on being satisfied with their accuracy.

39. In case the President is a candidate for an incumbency, the Vice-President shall preside, and if both be candidates, a President shall be chosen by the electors present.

40. Each candidate shall be proposed by one member and seconded by another.

41. The election shall be decided by a majority of votes, each elector signing his name under the name of the candidate for whom he votes. Whenever the votes happen to be equally divided, the President shall have a casting vote, besides his own vote.

42. Every charge or charges preferred against any incumbent or Tewakarna Bhikku of any temple, whether held under any special tenure or not, shall be referred through the District Committee to the Sangha Sabhawa of the college to which such incumbent or Tewakarna Bhikku belongs. The Sangha Sabhawa shall make a careful inquiry into the charge and forward the full proceedings of the case, together with their decision, to the District Committee, who shall have power either to adopt or reject such decision or institute a fresh inquiry. The District Committee shall have power to dismiss from any incumbency any Bhikku found guilty of any offence which, in their opinion, disqualifies him from holding the incumbency, and shall have further the power to stop his maintenance and prevent him from officiating in the temple of which he was incumbent.


43. If any incumbent or Tewakarna Bhikku, to whom due notice in writing with a certified copy of the charge or charges preferred against him, fail, without showing sufficient cause, to appear and answer such charge or charges, the inquiry shall be proceeded with in his absence. Any incumbent who may feel aggrieved by such ex parte decision shall be entitled to ask for a re-hearing, provided he shall show

sufficient cause for his default of appearance at the inquiry.

44. Cases referred by the District Committee to Sangha Sabhawa shall be inquired into and decided within the time fixed by that Committee. If the inquiry be delayed without reasonable cause, the District Committee shall have the right of recalling the papers and holding the inquiry themselves, and act as provided for by so much of rule 42 as empowers the District Committee to deal with cases without reference to the Sangha Sabhawa.

45. No incumbent shall remove any Tewakarna Bhikku from office or interfere, with the performance of his duties or stop his maintenance without first obtaining the permission in writing of the District Committee.



VITAL STATISTICS.

COLOMBO WEEKLY HEALTH REPORT.

L is subjoined.

Births.—The total births were 98. The birth-rate per 1,000 per annum was 28.4,* as against 24.7 in the preceding week and 23.6 in the corresponding week of last year.

Deaths.—The total deaths were 111. The death-rate per 1,000 per annum was 35.8,† as against 38.4 in the previous week and 31.6 in the corresponding week of last year.

Causes of death.—No person died from cholera, smallpox, or measles; 14 died from diarrhœa and dysentery; 6 from phthisis; 25 from bronchitis and pneumonia; 8 from different kinds of fever; and 14 from infantile convulsions.

Infantile deaths.—Of the 111 total deaths, 26 were of infants under 1 year of age, as against 24 in the corresponding week of the previous year.

* Calculated on the estimated population on July 1, 1908, viz., 180,262.

[†] The rates given for this and the preceding week are the corrected rates, *i.e.*, the rates calculated for the population of the town estimated on July 1, 1908, on the basis that its age- and sex-constitution is the same as for the Island.
