FINAL ORDERS.

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances, 1897, 1899, 1900, and 1903," admitting Land to be Private Property.

In the matter of the land commonly called or known as Minidegodamukalana, situate in the village of Kuda Badullagammana, in the Wegam pattu korale of the Wellassa division, in the Province of Uva, and of "The Waste Lands Ordinances, 1897, 1899, 1900, and 1903."

W HEREAS in pursuance of section 1 of the said Ordinances it was duly notified on May 18, 1906, that if no claim to the land commonly called or known as Minidegodamukalana, situate in the village of Kuda Badullagammana, in the Wegam pattu korale of the Wellassa division, in the Province of Uva, containing in extent 12 acres 3 roods and 30 perches, and originally shown as lot 27 in topographical plan M 3/1 and now shown as lot 4,309 in preliminary plan 1,313 as described in the annexed certified tracing therefrom, was made to the Government Agent of the Province of Uva within the period of three months from the date specified in such notice, such land would be deemed the property of Crown, and dealt with on account of the Crown (vide Notice No. 2,449):

And whereas (1) Walawwegedara Kiri Banda, (2) Walawwegedara Tissahami Korala, (3) Walawwegedara Tissahami, (4) Kiwulgamawatte Hudu Banda, and (5) Wegamagedara Hudu Kuma, for herself and on behalf of the minor Ratmallegedara Tissahami, as duly appointed guardian over the minor, all of Kuda Badullagammana made claim thereto, and I, Herbert White, Government Agent of the Provinceof Uva, made due inquiry into such claim; I, with the consent of His Excellency the Governor, do hereby admit the claim of the said claimants to the said land, as more fully described herein below, under section 4, sub-section (1), of the said Ordinances.
