SOUTHERN PROVINCE.

GALLE DISTRICT.

Paddy: the maha crops are thriving well.

Miscellaneous: food supply of the people sufficient, although prices ran high. Imported articles of food available in any quantity; vegetables and fish equal to the demand; coconuts scarce and dear.

Prices of staple food: rice, Rs. 14 to Rs. 15 per bag; paddy, Rs. 2.50 per bushel; fine grain, Rs. 2.50 per bushel.

Health of the people: satisfactory. A few cases of dysentery.

Health of cattle: there has been no murrain. A few cases of hoof-and-mouth disease in Gangaboda pattu.

Other products: the crop of coconuts below the average.

Rainfall: 3.81 in.

SALES OF ARRACK, TOLL, AND OTHER RENTS.
