Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900. and 1903." declaring Land to be Crown Property.

In the matter of the land commonly called or known as Radagehéna, Wakamullagodella, Alutgodalkoratuwakade, Alutgodawattehenkella, situate in the village of Pallewakmulla, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly notified on November 29, 1907, that if no claim to the land commonly called or known as Radagehena, Wakamullagodella, Alutgodakoratuwakade, &c., situate in the village of Pallewakmulla, in the West Giruwa pattu of the Hambantta District, in the Southern Province, containing in extent 99 acres and 12 perhes and shown as lot 8 in preliminary plan No. 246, and in the annexed certified tracing therefrom was made to John Murray Davies, Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in such notice, such land would be deemed the property of the Crown, and dealt with on account of the Crown (vide Notice No. 2,896):




