## MUNICIPALITY OF COLOMBO.

## Minutes of Proceedings of a General Meeting of the Municipal Council of Colombo held at the Municipal Office held on Friday, September 18, 1908.

The Council met this day at 3 P.M., pursuant to notice dated September 12, 1908. Present :--Mr. E. M. de C. Short, Chairman; Mr. C. P. Dias; the Hon. Mr. F. A. Cooper, C.M.G.; Sir Allan Perry, Kt.; Mr. H. A. Jayewardene; Major A. W. de Wilton; Mr. H. Tiruvilangam; Mr. R. S. Temple-ton; Mr. M. F. Khan; Mr. L. B. Fernando; Mr. A. Fairlie; Mr. N. H. M. Abdul Cader; Mr. Arthur Alvis; Mr. H. L. de Mel; Mr. G. H. Alston; Mr. E. G. Jayewardene; and Dr. David Rockwood. The Minutes of August 21, 1009, having been minuted and a corry theoref having been sent to each March.

The Minutes of August 21, 1908, having been printed, and a copy thereof having been sent to each Member of the Council, were taken as read.

Resolved-That the Minutes of August 21, 1908, be confirmed.

Pursuant to notice, Mr. C. P. Dias moved that this Council do co-operate with the Principal Civil Medical Officer in maintaining a separate ward at the Infectious Diseases Hospital for Muhammadan female patients suffering from smallpox, and in employing female Muhammadan attendants to serve in such ward.

Mr. N. H. M. Abdul Cader seconded.---Carried.

2. Pursuant to notice, Mr. C. P. Dias moved that the Chairman do cause a building to be set apart for the detention of Muhammadan female contacts removed to the Segregation Camp.

Mr. N. H. M. Abdul Cader seconded.—Carried.

3. Pursuant to notice, Mr. C.P. Dias moved that the Chairman do request the Medical Officer of Health-(1) to employ female inspectors only to search houses in which Muhammadan females live, and in which smallpox patients are suspected to be concealed ; (2) to order a female inspector or female Muhammadan attendant to accompany Muhammadan female patients suffering from smallpox to the Infectious Diseases Hospital.

Mr. N. H. M. Abdul Cader seconded-Carried.

4. Pursuant to notice, Dr. David Rockwood moved that steps be taken to prevent the employment of deaf persons as drivers of vehicles and rickshaw coolies.

Mr. C. P. Dias seconded.

Resolved .-- That the matter be referred to the Standing Committees on Finance and Assessment and on Law and General Subjects for consideration and report.

5. Pursuant to notice, Dr. David Rockwood asked what has been done in the matter of the use of motor horns on vehicles other than automobiles.

The Chairman replied that the question of the use of motor horns and flare lamps has been laid before the Government, and a decision is expected shortly.

6. Pursuant to notice, Dr. David Rockwood moved that a return be made of the total amount of tax paid under warrants during the year, 1907, and the charges respectively recovered under sections a, b, c, d, and e of clause 150 of Ordinance No. 7 of 1887.

Mr. H. A. Jayewardene seconded.-The return was laid on the table.

7. Pursuant to notice, Dr. David Rockwood inquired what steps have been taken to widen Laurie's road, Bambalapitiya, and moved for papers.

The Chairman intimated that the matter is under the consideration of the Works Committee and undertook to make inquiries into the matter of the improvement of the junction of Laurie's road with the Galle road.

8. Pursuant to notice, Dr. David Rockwood moved that the improvement of the Kollupitiya end of Turret road corner, which was sanctioned by the Council, be included in next year's Budget.

Mr. H. L. de Mel seconded.-Carried.

9. Pursuant to notice, Dr. David Rockwood presented a petition from the residents of Polwatta in regard to the insanitary condition of Polwatta ditch.

10. Pursuant to notice, the Chairman moved that the selection of Mr. H. P. Beling of the General Treasury for the post of Head Clerk, Secretary's Department, made in accordance with the Council's resolution No. 13 of August 21, 1908, be confirmed by the Council.

Mr. C. P. Dias seconded.-Carried.

Laid over for further inquiries. The Committee regrets that it is not yet able to make a definite recommendation as was desired by the Council at the last meeting. (4) Papers re widening of Maradana bridge.

- (5) Papers re lighting of Panchikawatta road and Skinner's road South to Armour street with electric street arc lamps.
- The Committee does not recommend to Council to consider the Company's proposal at present. (6) Papers re lighting of tramway routes from Fort Railway Station to Saunders' road and Racquet Court to New Moor street with electric arc lamps.
- The Committee does not recommend to Council to consider the Company's proposal at present.
- (7) Papers re sale of Gould's pump, &c., to the Director of Public Works issued to him on loan for

- (11) Letter from Municipal Engineer, No. 959 of August 25, 1908, asking that a sum of Rs. 5,000 be provided at once to carry out the work of filling up old drains in Gas Works street. Recommended.
- (12) Letter from the Inspector-General of Police No. 3,345 of September 2, 1908, re cattle seizing in Colombo by Police Constables.

The Committee sees no reason why cattle seizers for the town of Colombo should be any longer appointed, it being in the Committee's opinion the duty of the police to keep the streets clear of straying animals.

(13) Papers re transfer of the Water-rate Clerk from the Secretary's Department to the Waterworks Department, and employment of an additional clerk for the Waterworks Department on an initial salary of Rs. 500 per annum, with annual increments of Rs. 50.

The addition of one clerk to the Waterworks Department, on a salary of Rs. 500 and increments according to the Clerical Scheme, is recommended.

The Chairman moved that Council do resume and that the resolutions passed in Committee be adopted. Mr. C. P. Dias seconded.-Carried.

15. Report of the Special Committee appointed to inquire into the present administration of the General Cemetery, Kanatta, was brought before the Council, having been previously printed and circulated. The Chairman moved that the report be adopted, and that the Chairman be authorized to give effect to

the recommendations as early as circumstances permit of.

Sir Allan Perry, Kt., seconded.—Carried. 16. Report of the Special Committee appointed to consider the correspondence on the subject of additional sources of Municipal Revenue asked for by the Council, was brought before the Council, having been previously printed and circulated.

The Chairman moved that the report of the Committee be adopted, and that the matter be brought up again with full information as to the state of the Council's finances when the rate for 1909 comes to be considered

Mr. E. G. Jayewardene seconded.-Carried.

17. Chairman's Minute on the appointment of an Assistant Superintendent to the Colombo Fire Brigade was brought before the Council, having been previously circulated.

The Chairman moved that the matter be laid over for consideration at next meeting.

Mr. H. A. Jayewardene seconded.-Carried.

18. Papers re Supplies to Drainage Works for 1909 and whether the Resident Engineer can obtain them

from local firms were brought before the Council, having been previously circulated. The Chairman moved that in the opinion of this Council the supply of materials for the Drainage Works should not, in view of the facts placed before the Council, be governed by the Colonial Regulations.

Mr. G. H. Alston seconded.-Carried.

19. Papers re extension of the Young Men's Christian Association building at the Racquet Court with Chairman's Minute thereon were brought before the Council, having been previously circulated.

Mr. C. P. Dias moved that this Council would not oppose the appropriation of the small additional areas asked for by the Association, provided a guarantee is given by the Association that applications for further extensions are not made in the future.

Mr. A. Fairlie seconded.—Carried.

20. Papers re appointment of a Waterworks Inspector were brought before the Council, having been previously circulated.

The Chairman moved that for the reason given in the Municipal Engineer's letter No. 1,084 of September 18, 1908, Mr. R. J. Hudson be appointed Waterworks Inspector on the salary advertised.

The Hon. Mr. F. A. Cooper, C.M.G., seconded.

Mr. H. A. Jayewardene moved as an amendment that Mr. D. J. W. Samarakone be appointed. Mr. H. L. de Mel seconded.

The Chairman moved that in the opinion of this Council any arrangement by which the Council becomes entitled to a portion of the time of the Colombo Police Magistrate without paying for it is unsatisfactory, and that it be recommended to the Government that the sum guaranteed by Chairman's letter No. 140 of July 23, 1908, be looked upon as the Council's contribution towards the salaries of the two Colombo Magistrates, and that the Council shall in consideration thereof become entitled to a full statutory day's sitting daily in the Municipal Court.

## Minutes of Proceedings of a Meeting of the Municipal Council of Galle held at the Municipal Office on Öctober 10, 1908, at 2 p.m.

Present : Mr. L. W. Booth, Chairman ; Dr. E. Ludovici ; Mr. F. E. Abeysundera, ; Mr. F. J. de Vos, Mr. E. D. Perera ; Mr. M. Makan Markar ; Mr. H. F. Tomalin ; and Mr. A. C. Hayley. 1. The Minutes of Meeting held on September 12, 1908, were read and confirmed.

Pursuant to notice, Mr. H. F. Tomalin moved-That the General Manager, Ceylon Government Railways, be requested to consider the necessity for revising the arrangements at the Galle Railway Station so as to give greater convenience to passengers using the railway.

Mr. F. E. Abeysundera seconded.

Resolved-That Mr. Tomalin be requested to submit the details of his complaint in writing, to be forwarded to the General Manager of the Ceylon Government Railways for favourable consideration.

Pursuant to notice, Mr. A. C. Hayloy moved-(1) That this Council do draw the attention of the General Manager of the Ceylon Government Railways to the delay of nearly 10 minutes that is occasioned to the 2.55 P.M. Down train from Maradana by its having to wait at Gintota to enable the 6 P.M. Up train from Galle to pass, and to request that this be obviated by enabling the Down train to arrive at Galle prior to the departure of the Up train.

(2) That this Council do draw the attention of the General Manager of the Ceylon Government Railways to the feasibility of effecting a further acceleration to the time of arrival of the 2.55 P.M. Down train at Galle by allowing the 2.10 P.M. Down train to proceed as far as Alutgama, whereby the necessity of stopping at the stations between Kalutara South and Alutgama might be obviated in the case of the former of these trains, and to request that this alteration and the subsequent times of arrival appearing in the time table be amended accordingly

Mr. Makan Markar seconded.-Carried.

4. Report of the Special Committee appointed on September 12, 1908, to report to the Council what measures if any should be adopted in connection with the Hon. the Colonial Secretary's Circular No. 87 of June 19 last re prevention of malaria.

Resolved—That the report be circulated and brought up at the next meeting of the Council. 5. Report of the Special Committee appointed on September 12, 1908, to inquire into and report on a suitable place for the interment of carcases of animals.

Resolved—That the report be adopted. The owner of land being paid cents 50 for each animal buried

in his premises. 6. Interim report of the Special Committee appointed on September 12, 1908, to report re registration of dairies.

Resolved-That the recommendations be adopted.

Letter dated September 10, 1908, from B. W. Leefe, re poverty in Galle.

Resolved-That although this Council is in full sympathy with the object of Mr. Leefe's suggestion, it regrets its inability to take action thereon as provision has not been made in section 46 of the Ordinance No. 7 of 1887 authorizing the Council to expend any portion of its funds for the purpose of relieving the poor.

Colonial Auditor's remarks for the month of July, 1908. Laid on the table. Draft Ordinance to amend the old Ordinance No. 7 of 1887, with the Hon. the Colonial Secretary's letter No. 26 of September 23, 1908.

Resolved—That a Special Committee composed of Messrs. D. G. Goonawardena, F. J. de Vos, and A. C. Hayley, two to form a quorum, be appointed to report on the proposed amendments.

## The Health Officer's Report for the Month of October, 1908.

Scavenging was well attended to. Drainage.—The flushing of built drains was not satisfactorily attended to. The bazaar drains require repairs and cementing very badly. Some drains are wanting in fall and cannot be kept clean. Water supply.—Drinking water from Labodowa was good. The water supply from Bikke to the Fort

has proved a failure as some houses up Church street and Middle street get very little or no water.

Alleys were kept clean.

Dairies were well kept.

Bakeries were kept in good order.

Markets were well kept. Cattle 240 and goats 211 were passed during the month.

Slaughter-house and cattle shed were well kept.

Night soil depot was well kept.

Latrines were well kept.

General Health.-Two cases of chickenpox, two of measles, and two of enteric (one doubtful) were reported during the month. The last (9th) smallpox patient who got the infection from Henry Goonesekera's (who was infected in Colombo, and whose case was reported on August 19) house, was Talpe Liyanage Asena of house No. 16, Minuwangoda, who was removed to the Infectious Diseases Hospital on September 18. No other cases occurred in connection with Henry's case. On the 16th instant Asing Atchy of Ettiligoda was removed to the Infectious Disease Hospital, suffering from smallpox of seven days' duration---infection from Colombo. Her two daughters, Kaija Umma and Isa Umma developed smallpox in the Segregation Camp, and were removed to the Infectious Diseases Hospital on the 25th and 28th respectively.

The Registrar of Deaths has reported 12 deaths from phthisis and 6 from other tubercular diseases this month, out of a total of 95 deaths. Tubercular diseases count about double the number of deaths from any other disease; the mischief those suffering from this infectious disease can do is not recognized, and healthy members living in the same house expose themselves to the contagious influence in a variety of ways, and the disease continues to spread, claiming more victims than any other infectious disease. The necessity for taking preventive measures as suggested in my quarterly report of December 31, 1897, is apparent and urgent and deserves the serious consideration of the Council. Since my report of 1897 referred to, wherein I drew attention of the Council to the dangers of leprosy, an Ordinance has been passed for the segregation of lepers. I hope the Council will take action in this more infectious and fast spreading disease.
