(2) Schedule III of that Notification is hereby amended as follows : -

a. By the repeal of Paragraph 5 and the substitution therefor, of the following :-

“5. A non-refundable fee of Rupees Ten Thousand (Rs. 10,000) shall be paid when applying for a new license or renewal of license” ;

b. By the repeal of Paragraph 6 and the substitution therefor, of the following :-

“6. Every license shall be valid for a period of one year. The License which is issued in the middle of the year shall be issued for the remaining period of the year” ;

c. By the repeal of Paragraph 7 and the substitution therefor, of the following :-

“7. Every license issued under the Excise Ordinance shall be subject to a license fee set out in Schedule I and such fee shall be charged on a pro-rate basis in the case of a new license issued for a part of a year. The payment shall be made at least seven working days prior to the date of commencement of the relevant financial year. However, if the fee is not received by the relevant Divisional Secretary at least seven working days after the commencement of a financial year, an additional period of four weeks shall be allowed to make payment subject to a penalty of 1% of the value of license fee. After the period of four weeks, Penalty shall be 3% of the value of license fee.” ;

- d. By the omission of words and figures of Rs. 7,500/- or Paragraph 27 and the substitution of the words and figures of Rs. 10,000/- ;
- e. By the repeal of Paragraph 28 and the substitution therefor, of the following :-
- “28. The fee for transfer of license shall be Rs. 10,000/-” ;
- f. By the repeal of Paragraph 29 and the substitution therefor, of the following :-
- “29, If the transferee who is not a legal heir of the transferor, the new application for transfer of license shall be as follows :
- i. FL 04 type liquor license shall be Rs. 15,000,000/-
- ii. Any other liquor license shall be Rs. 1,500,000/-”.

IT is hereby notified that the Excise Notification No. 984 issued by the Honourable Minister of Finance by virtue of the powers vested in him by Section 25 read with Section 32 of the Excise Ordinance (Chapter 52), as ammended from time to time, and published in the *Gazette Extraordinary* No. 1945/17 dated 15.12.2015 to cancel the Excise Notification No. 926 of *Gazette Extraordinary* No. 1680/24 dated 19.11.2010 and Excise Notification No. 974 of *Gazette Extraordinary* No. 1901/19 dated 13.02.2015 effective from 15.12.2015, was passed by parliament on 10.03.2016.
