PROCLAMATION.

By His Excellency Sir HENRY EDWARD MCCALLUM, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Aide-de-Camp to His Majesty the King, Governor and Commander-in-Chief in and over the Island of Ceylon,

with the Dependencies thereof.

WHEREAS by Proclamation dated February 18, 1897, issued under the provisions of section 2 of the Small Towns Sanitary Ordinance. No. 18 of 1892, the village of Eravur, in the Eastern Province, was brought under the operation of the said Ordinance, and the limits of the said village were defined therein for the purposes of the said Ordinance :

And whereas it is expedient to alter the limits of the said village of Eravur as defined in the said Proclamation of February 18, 1897 :

Now know Ye that We, the Governor of Ceylon, in exercise of the powers vested in Us by section 2 of the said Ordinance and with the advice of the Executive Council, do hereby amend the said Proclamation of February 18, 1897, and declare that the limits of the said village of Eravur, in the Eastern Province, shall for the purposes of the said Ordinance be as the same are defined in the schedule hereto annexed as from and after February 1, 1909.

And We do in all other respects confirm the said Proclamation of February 18, 1897.

Given at Kantalai, in the said Island of Ceylon, this Twenty-fifth day of January, in the year of Lord our One thousand Nine hundred and Nine.

GOVERNMENT NOTIFICATIONS.

T is hereby notified that the following rules made by the Government Agent, Central Province under the provisions of section 23 of the Butchers' Ordinance, No. 9 of 1893, in respect of the public slaughter house situated at Pussellawa in the said Province, have for the purpose mentioned in the said Ordinance been confirmed by the Governor in Executive Council, and are published for general information.

RULES.

1. No person licensed to carry on the trade of a butcher in the planting district of Pussellawa shall slaughter any cattle at any place other than the slaughter-house for cattle on Haldummalagahahena in Pussellawa; bounded on the east by the road to Nuwara Eliya, south by land claimed by Somasundere, and on the west and north by land claimed by Gabriel de Silva.

2. The shed on the Crown land called Nidanwatta: bounded on the north by Crown land, east by Nidanwatta, south by high road to Pussellawa, and west by road to court-house, is hereby appointed as the spot in which, as required by section 12, sub-section (1), of Ordinance No. 9 of 1893, the butchers at Pussellawa shall expose to public view all cattle intended for slaughter for a period of not less than 24 hours immediately preceding the time of slaughter.

3. No cattle shall be slaughtered at the aforesaid slaughter-house except on such days and between such hours as may be determined by the Government Agent, Central Province, notice of which shall be posted at the said slaughter-house.

4. No animals shall be slaughtered for human food until after the animal has been inspected and approved by the Medical Officer at Pussellawa as fit to be slaughtered for human food. Animals rejected as unfit for slaughter shall be immediately removed.

5. The said Medical Officer may prohibit the slaughter of any animal notwithstanding that it has been approved as aforesaid, if it should before slaughter be found to be diseased or otherwise unfit to be slaughtered for human food.

6. If on any animal which has been approved as aforesaid being slaughtered the carcase shall appear diseased or unfit for human food, the said Medical Officer shall cause the meat to be immediately destroyed or disposed of so as to prevent its being exposed for sale or used for human food.

7. The person in charge of the slaughter-house shall not permit the slaughter of any animals which have not been approved as aforesaid as fit to be slaughtered for human food, or the slaughter of which the said Medical Officer has prohibited as provided by rule 5.

8. No person shall remove from the slaughter-house, except under the directions of the said Medical Officer any meat which the latter has declared to be unfit for human food.

9. The fee for slaughtering shall be 75 cents for each head of cattle.

10. The person in charge of the slaughter-house shall keep a register in the form annexed of all cattle brought to the slaughter-house.

THE following by-laws framed under section 5 of "The Dog Registration Ordinance, 1901," for the several places in the Colombo District of the Western Province specified in the schedule to the Proclamation dated July 31, 1908, are published for general information.

BY-LAWS REFERRED TO.

A registration fee of 25 cents per annum shall be paid upon each dog kept 1. within the proclaimed limits.

2. Such registration fee shall be due on and after January 5, and shall be paid in advance before March 31 in each year to the proper authority.

3. To facilitate the recovery of such registration fee, the occupier of every house within the proclaimed limits shall on or before December 31 of each year furnish to an officer authorized by the Government Agent to demand the same a list, in the form in schedule annexed, of dog or dogs kept in such houses, and the names of the owners thereof.

4. On payment of the registration fee on any dog, the Government Agent or officer authorized by him shall, unless the owner provides his own collar to be stamped, furnish the owner with a stamped collar to be worn by such a dog on payment of a fee of 25 cents

5. Every inhabitant within the said limits becoming possessed of any dog or dogs after the furnishing of the list referred to in by-law 3 shall furnish the officer appointed by the Government Agent mentioned in the said by-law with an additional list of such dog or dogs within one month after acquiring the same, and the owner of such dog or dogs shall become liable to the registration fee for the current year within 15 days after the list required by this by-law becomes due.

It shall be lawfull for the officer appointed by the Government Agent to require the production of any dog for which registration is applied for, and to decline to issue a certificate of registration until it is produced.

7. It shall be lawful for the Government Agent or person authorized by him to refuse to issue a certificate of registration or to cancel a certificate already issued for any dog which in his opinion is so maimed or diseased as to be unfit to live. or which is habitually ill-treated or continually neglected by its owner.

8. The owner of every dog for which a certificate has been refused or cancelled shall on being noticed to do so produce the dog at the house of the officer appointed by the Government Agent at a time to be stated in the notice and deliver it to the said officer, and every such dog may be destroyed or otherwise disposed of as the Government Agent shall think fit.

9. It shall be lawful for the officer appointed by the Government Agent to have all stray dogs seized, and deal with them in terms of sub-section (1) and (2) of section 10 of the Ordinance No. 25 of 1901.

A certificate of the registration of the candidate's birth showing him to be on March 29, 1909, between the ages of 18 and 21, and a certificate of good character signed by a responsible person,* to the satisfaction of the Director of Public Instruction, must be attached to the form of application. If a certificate of birth for a previous examination was sent in, reference may be made to it by mentioning name and date of examination. Affidavits will in no circumstances be accepted. In the case of candidates who submit certificates of registration in the register of past birth, the certificates will only be accepted after consideration of the evidence by which the dates of birth were established. If the name appearing in the birth register differs, either by alteration or addition, from the name by which the candidate is known, the parent or guardian should, before obtaining a certificate, apply to the Registrar-General or his Assistant for such alteration in the manner set forth in section 7 of Ordinance No. 23 of 1900.

3. Clerks in Government service, from whatever funds they may be paid, who have completed three years' satisfactory service and are not members of the Customs, Postal, Survey, or Railway Departments, and those clerks employed by Provincial and District Road Committees whose appointments date prior to July 1, 1875, are eligible for examination irrespective of age and without fee. Their applications (in the same form, Schedule A) for admission to the examination should be forwarded to the Director of Public Instruction through the Heads of their Departments.

4. Applications are to reach the Director of Public Instruction not later than 2 P.M. on Friday, February 19, 1909; any applications received after that hour, by whatever cause delayed, will be absolutely rejected.

5. The Director of Public Instruction will return to the candidate his application, approved or disapproved as the case may be, after taking, if necessary, the orders of Government thereon. The approved application shall constitute the candidate's ticket of admission to the examination. Candidates presenting themselves for examination must produce to the officer appointed to supervise the examination their forms of application approved by the Director of Public Instruction. A candidate not producing such form, whatever may be the reason for his not so doing, will be refused admittance to the examination.

6. The examination will be held at Colombo only, in the place and under the supervision of the officer specified in Schedule B. Heads of Departments are required to grant to officers of their Departments, whose applications to present themselves for examination have been returned to them approved by the Director of Public Instruction, leave to present themselves at the examination.

7. The examination will be competitive. The number of places assigned for competition will be thirty.

8. The successful candidates will be required to pass a medical examination as to their physical fitness for service in any part of the Island.

9. The subjects for examination are those set out in Schedule C to this notice. The examination shall be held in two parts. The first part a qualifying examination in Handwriting, Spelling, Arithmetic, and Bookkeeping. Any candidate failing to obtain two-thirds of the marks allotted for Handwriting, half those allowed for Spelling and Arithmetic respectively, and one-third of those allowed for Bookkeeping shall be excluded from the remainder of the examination. Special attention will be paid to Handwriting, and candidates whose writing is untidy or illegible or contains defects in the formation of letters will be r gorously excluded. The kind of writing preferred will be that generally shown as the "Civil Service" hand. The second part of the examination shall be in the remaining subjects in Schedule C. Should a candidate obtain less than one-third of the aggregate marks for the three subjects—Composition, General Paper, Précis Writing—or less than one-fourth marks in any other subject, or, if he be a Sinhalese or Tamil, less than one-half of the marks in his native language, such marks shall not be counted in his favour. In all the written papers marks will be deducted for bad writing and mistakes in spelling.

10. Clerks of the description given in section 3 above, who have served Government continuously for over six years, will be llowed to compete amongst themselves, and will be eligible, if they obtain a minimum of 66 per cent. in Writing and 33 per cent. in the other compulsory subjects, for seven of the appointments offered for competition. Three of the appointments will be reserved as prizes for deserving clerks of the same description, who have served Government continuously for ten years and upwards to be selected irrespective of examination. No service under the age of sixteen years will be reckoned for this purpose.

- A candidate desirous of offering any language or languages other than those named above should submit his proposal for the consideration of the Matriculation Board. The normal notice of such proposal is six months before the beginning of the Matriculation Examination for which he enters. Candidates giving less than six months' notice are advised that it may not be possible to make arrangements for papers to be set at the next Matriculation Examination, even though the language be approved.
- Proposals to take a particular language, other than those mentioned above, must be accompanied by a special fee, additional to the regular Matriculation fee of £2. This fee will be returned should the proposed language not be accepted by the Matriculation Board, but in no other The amount of this additional fee varies with the language selected, and can be case. ascertained on application to the External Registrar.

(d) Pages 243-44, omit the syllabuses of the examination in Spanish, Portuguese, Italian, Modern Dutch, Arabic, Hebrew, Sanskrit, and Chinese.


This specification provides for the repairs to the Elakake girls' school.

To remove the entire roof of the school, re-construct same with the necessary pitch, using tie beams 23 ft. by 4 in. by 8 in., and truss same, with kingposts 4 in. by 4 in. and struts 3 in. by 4 in., wall plates 4 in. by 6 in., rafters 3 in. by 2 in., and reepers 2 in. by $\frac{1}{2}$ in.; tiles to be replaced with overlap of 3 in., ridge tiles to be large, one laid in mortar.

One pillar to be rebuilt, and all pillars to have 2 in. planks laid on same with wood posts 4 by 4 on half wall to support wall plates; a window 3 ft. by 4 ft. to be put in room with shutters complete.

Floor of room to be laid with flat bricks. Kitchen, cadjan roof to be displaced and constructed with undecayed timber from school house. same to be tiled. Beams to be tarred, and door and window painted.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended January 23, 1909.

Births.—The total births registered were \$1 (11 Burghers, 46 Sinhalese, 8 Tamils, 11 Moors, 4 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1909, viz., 182,058) was 23-2, as against 27-5 in the preceding week and 24-9 in the corresponding week of last year.

Deaths.—The total deaths registered were 128 (5 Europeans, 9 Burghers, 57 Sinhalese, 32 Tamils, 20 Moors, 4 Malays, and 1 Other), including the death of a town resident who died in the Infectious Diseases Hospital at Kanatta. The death-rate per 1,000 per annum was 36.7, as against 47.5 in the previous week and 37.1 in the corresponding week of last year.

Infantile Deaths.—Of the 128 total deaths, 23 were of infants under one year of age, as against 39 in the preceding week and 35 in the corresponding week of the previous year.

Still Births.—The number of still births registered during the week was 9.

Selected Causes of Death.—There were no deaths registered from Cholera. Five deaths were registered in the town from Diarrhea and 11 from Dysentery.

2. Fourteen deaths were registered from *Phthisis* (against 20 in the previous week and 13 the average during last year), of which 3 each were in St. Paul's and Maradana, 2 each in St. Sebastian, New Bazaar, and Slave Island, and 1 each in Kotahena and the General Hospital (a patient whose residence was not known). One death was registered from *Bronchitis*, and 10 from *Pneumonia*.

3. Eight deaths were registered from *Enteric Fever* (against 18 in the previous week and 8 the average per week for last year), of which 5 were in Maradana, and 1 each in Kotahena, New Bazaar, and Kollupitiya. During the week 32 cases of Enteric Fever were reported, against 31 in the previous week.

4. Four deaths were registered from *Smallpox* in the Infectious Diseases Hospital at Kanatta, of which I was from St. Paul's Ward and the three others from outside the town. The former alone is here taken into account. There were reported during the week 3 cases of Smallpox (as against 8 in the previous week); also 34 cases of Chickenpox, and 16 of Measles.

State of the Weather.—The mean temperature of air was $79\cdot3^{\circ}$, against $79\cdot4^{\circ}$ in the preceding week and $78\cdot9^{\circ}$ in the corresponding week of the previous year. The mean atmospheric pressure was $29\cdot962''$, against $29\cdot986''$ in the preceding week and $30\cdot036''$ in the corresponding week of the previous year. The total rainfall in the week was $1\cdot39''$, against nil in the preceding week and nil in the corresponding week of the previous year.
