SEASON REPORTS FOR THE MONTH OF JANUARY, 1909.

EASTERN PROVINCE.

TRINCOMALEE DISTRICT.

Rainfall : defective.

Paddy : munmari crop in ear.

Tobacco : plants growing.

Coconut : (1) condition of crop, medium ; (2) actual crop, 177,940 ; price, Rs. 30 to Rs. 40 per 1,000.

Fishery : good.

Health of people : normal.

Health of cattle : foot-and-mouth disease at Kantalai subsiding.

Prices of staple articles : paddy, Rs. 2.62 per bushel ; rice, Rs. 6.44 per bushel.

NORTH-WESTERN PROVINCE.

KURUNEGALA DISTRICT.

Katugampola Hatpattu.—Paddy : maha harvest is being reaped. Some fields are ripening ; prospects not very favourable. Fine grain : crops are being reaped ; prospects are bad owing to failure of rain. Flowering and prospects of coconuts : fair. Few showers during the early part of the month.

Health of people : bad. Fever prevails to a great extent, but it was not so bad as it was in December. There are stray cases of measles and chickenpox.

Health of cattle : fair.

Dewameddi Hatpattu.—Paddy : crops ripening, some being reaped, crops bad. No rain when young ; prospects bad. Fine grain : crops being reaped and harvested ; owing to drought the young plants withered away ; this particularly on new clearings. Flowering and prospects of coconut : owing to drought flowering not good ; prospects fair. Approximately 311,976 nuts plucked. Few slight showers only, insufficient for crops, but was opportune for some.

Health of people : there was an epidemic of malaria ; measles, too, prevailed to some extent.

Health of cattle : fair.

Wanni Hatpattu.—Paddy crops are partly in ear and are partly earing ; later sowings are young. The limited areas under crop have water, and prospects seem favourable. There are solitary cases where water may fail. Fine grain crops : some are being reaped, while some are maturing. 2,270 acres under coconuts. No chenas worked this month. 480 acres of owita lands cultivated this month. Prospects : crops have succeeded, and are being taken in. It rained 14th, 15th, 17th, 18th, and 19th instant.

Health of people : malarial fever, cough, and cold prevailed.

Health of cattle : good.

Weudawili Hatpattu.—No paddy and chena lands were sown during last month. The weather was not favourable for cultivation. There was rain during the beginning of the month for a few days. The crops of lands cultivated during the previous months were partly earing and partly young. The crops of the greater part of land cultivated was spoiled by drought.

The health of people was bad ; there were fever cases everywhere in the interior.

The condition of cattle was good.

Dambadeni Hatpattu.—Paddy crops matured, and about to be gathered ; prospects bad because the rainfall was bad. Fine grain : crops gathered ; prospects bad owing to bad rainfall. It rained three days during the month.

Health of people : bad.

Health of cattle : satisfactory.

Hiriyala Hatpattu.—Paddy crops earing and maturing ; prospects not favourable owing to want of rain. Fine grain : crops maturing and reaping ; prospects fair. No rain. There were few showers of rain in some korales.

Health of cattle : indifferent. Cattle are dying in the northern korales on account of the last year's long drought.

Health of people : unsatisfactory. Fever is not subsiding. Large mortality and some distress at Maduragoda and several hamlets. Special measures have been taken, and conditions had greatly improved by the end of the month.
