FINAL ORDERS.

Order under Section 2 of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Lands to be Crown Property.

In the matter of the lands commonly called or known as Pinnaketiyahenekella, Kolongahahenekella, Kitulagodahena, Pelawattehena, Pelabogahahena, Kahatahena, Ratadehigahahena, Galgodahena, &c., situate in the village of Udajulampitiya, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

THE notice required by section 1 of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," having been duly published in manner prescribed by that section in respect of the above-named lands (*vide* Notice No. 3,116), and no claim having been made to the said lands or to any interest therein within the period of three months from the date specified in the said notice, I, John George Fraser, Special Officer appointed under section 28 of the said Ordinances under and by virtue of the powers vested in me in that behalf by section 2 of the said Ordinances, do hereby on December 12, 1908, order and declare that the said lands as more fully described herein below, situate in the village of Udajulampitiya, in the West Giruwa pattu of the Hambantota District, in the Southern Province, and shown as lots 5, 5a, 8, 9, 10, 12, 15, 17, 19, 31, 32, 33, 34, 53, 57a, 66, 69, and 70 in preliminary plan No. 387 and in the annexed certified tracing therefrom, and containing in extent 586 acres 1 rood and 24 perches, are the property of the Crown.

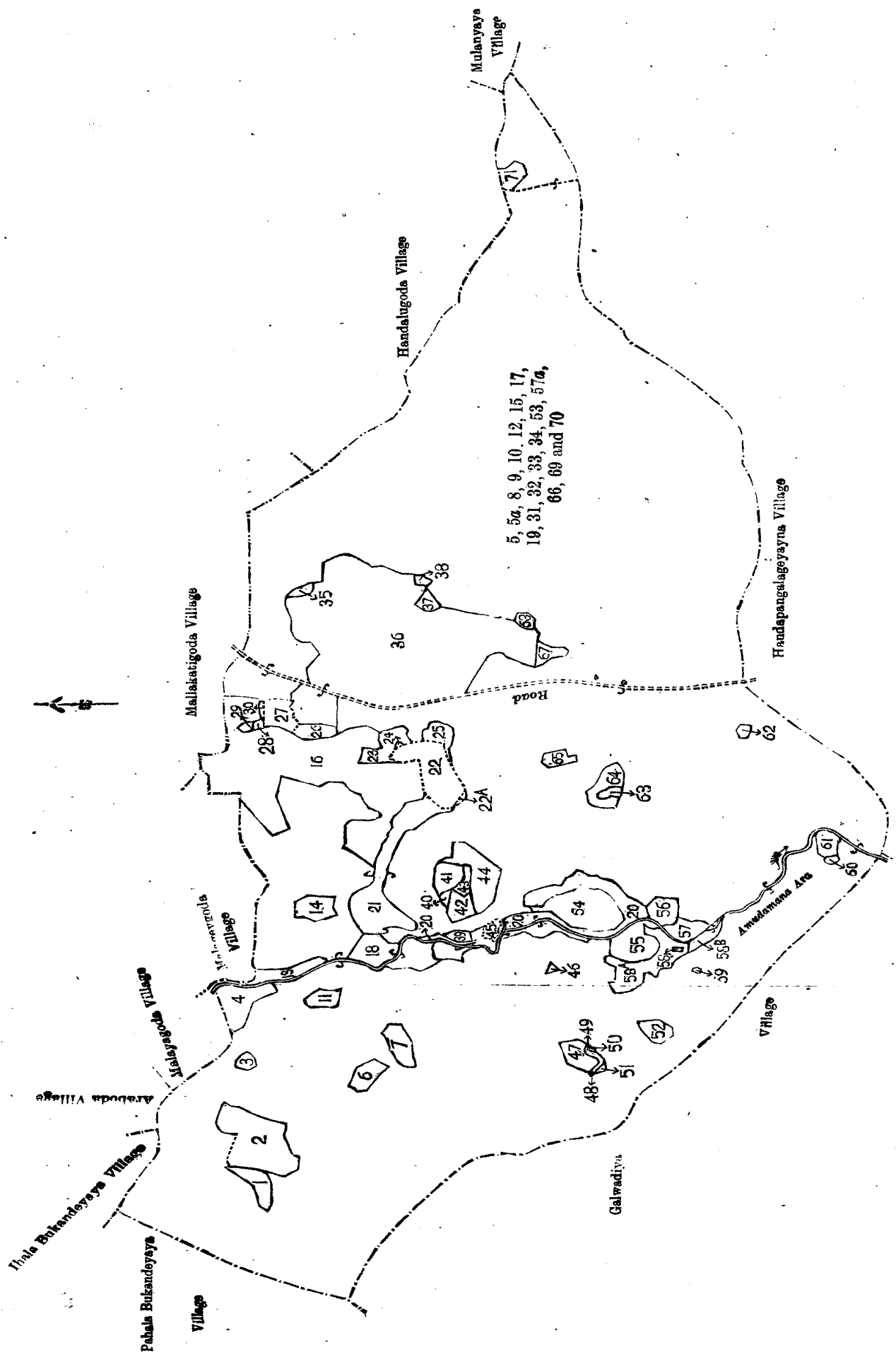

Order under Section 4, Sub-section (1), of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

In the matter of the land commonly called or known as Paragahahena, Indigahahena, Godellaudahena, situate in the village of Waduwadaniya, in the Giruwa Pattu West of the Hambantota District, in the Southern Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, 1903."

WHEREAS in pursuance of section 1 of the said Ordinances it was duly declared and notified on September 20, 1907, that if no claim to the land commonly called or known as Paragahahena, Indigahahena, Godellaudahena, situate in the village of Waduwadaniya, in the Giruwa Pattu West of the Hambantota District, in the Southern Province, containing in extent 8 acres 2 roods and 16 perches and shown as lot 22 in preliminary plan No. 223, was made to Walter Ernest Wait, Special Officer appointed under section 28 of the said Ordinances, within the period of three months from the date specified in the said notice, such land would be deemed the property of the Crown and dealt with on account of the Crown (*vide* Notice No. 2,338):

And whereas Senarat Arachchige Sabehamy Vel-Vidane of Waduwadaniya made claim thereto, and I, Walter Ernest Wait, Special Officer appointed under section 28 of the said Ordinances, made due inquiry into such claim; and whereas I and the said claimant, with consent of His Excellency the Governor, came to an agreement in writing concerning the said land, under section 4, sub-section (1), of the said Ordinances; whereby it was ordered that in pursuance of the agreement afore-mentioned, that the said claimant should pay to the Assistant Government Agent at Hambantota a sum of Rupees Thirty (Rs. 30) for 2 acres of lot 22 on or before August 12, 1908; and whereas it was further agreed that in default of such payment his claim to the said portion of lot 22 should be considered to have been withdrawn, and the said lot should be declared the property of the Crown; and whereas the said claimant has failed to make the said payment by the due date in pursuance of the above-mentioned agreement, I, Walter Ernest Wait, Special Officer appointed under section 28 of the said Ordinances, under and by virtue of the powers vested in me in that behalf by section 4 of the said Ordinances, do hereby on December 9, 1908, order and declare under section 4, sub-section (1), of the said Ordinances, that the said land, as more fully described herein below, is the property of the Crown.

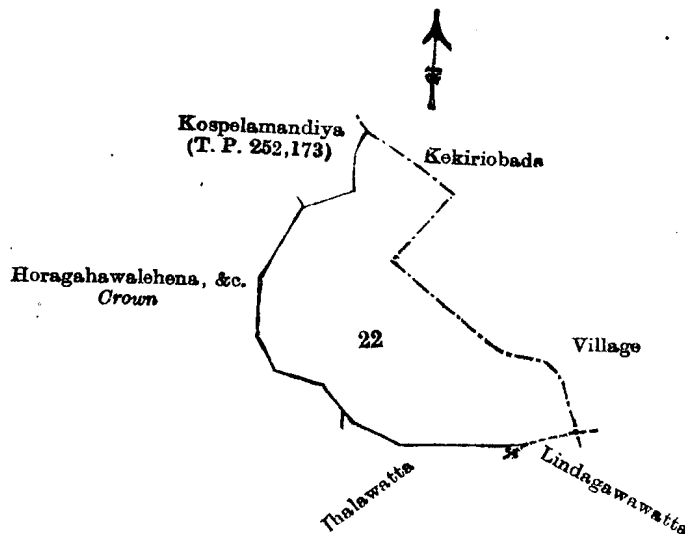
