MINUTE BY THE GOVERNOR.

ITH reference to paragraph 5 of the Minute of February 25, 1909, regarding examinations for members of the Civil Service, HIS EXCELLENCY THE GOVERNOR has been pleased to order that in the second examination Law and Accounts should be separate sections to be taken up at separate periods should candidates so desire it.

- 2. This section as amended will also apply to the examination for members of the Local Division of the Civil Service.
 - 3. Section 5 of the Minute will now read as follows:—

"At their first examination candidates will be examined in Sinhalese or Tamil (whichever they may prefer), in Law, and in Accounts; at their second, in Law, Accounts, and both languages; and in this second examination candidates may take up the various subjects, if they so desire it, in four sections at four separate periods, section (a) consisting of Law; section (b) consisting of Accounts; section (c) consisting as the language taken up by them at their first examination; and section (d) consisting of their second language."

By His Excellency Sir Henry Edward McCallum, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Aide-de-Camp to His Majesty the King, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by a Proclamation bearing date March 10, 1909, issued under the provisions of section 2(1) of the Cacao Thefts Prevention Ordinance, No. 8 of 1904, the said Ordinance was declared to be in force within the limits of the places defined and set forth in the schedule to the said Proclamation:

And whereas it is expedient that the limits of the places in which the said Ordinance was declared to be in force as aforesaid should be more correctly described:

Now know Ye that We, the Governor of Ceylon, in exercise of the power vested in Us by section 2 (2) of the said Ordinance, do hereby alter the said Proclamation by substituting for the schedule thereto the schedule hereunder appended.

And We do in all other respects confirm the said Proclamation of March 10, 1909.

Given at Nuwara Eliya, in the said Island of Ceylon, this Thirty-first day of May, in the year of our Lord One thousand Nine hundred and Nine.

IS EXCELLENCY THE GOVERNOR has been pleased, with the approval of the SECRETARY OF STATE FOR THE COLONIES, to sanction the following proposals for improving the efficiency of the Volunteer Forces of the Colony.

The number of non-efficient Volunteers in some Corps is unduly large. Inefficients—as distinct from non-efficients-will be struck off before the end of the volunteer year, and efficient strength of units wil be shown instead of paper strength. Where detachments at outstations prove to be unsatisfactory both as regards numbers and efficiency they will be disbanded. Every effort must be made to encourage members of the Volunteer Corps to attend Camp.

3. It was found that the month of July is not as convenient for the annual camp as had been

anticipated. Camp will in future be held in the second half of the month of June.

4. Mounted Rifles.—Attention will be paid to dismount d work and also to scouting. The strength

of the Corps will be increased by 50 men, making the establishment 250, instead of 200 as at present.

5. The Ceylon Planters' Rifle Corps.—The establishment of this Corps will be reduced from 800 to The men employed on the Railway (about 55 strong, of whom 30 form part of F Company), most of whom are unable to attend the annual camp, will be struck off the strength of the Corps and will form a section of Railway Engineers, 50 strong.

6. Ceylon Light Infantry.—The General Officer Commanding the Troops has kindly promised to arrange for those officers of this Corps who are in a position to do so to undergo a course of Company Drill at evening parades of the Regulars. At the conclusion of this course certificates of efficiency will be granted to those officers who qualify for them. Officers in possession of these certificates will be specially considered for promotion. The number of drills required for efficiency will in the case of absentees from annual inspection be increased from 9 to 12, and physical drill will as far as possible form a part of every drill parade. Recruits with 32 inches chest measurement will still be admitted, but at the end of 12 months' service and physical training any member having less than 33 inches chest measurement will be specially reported upon for the consideration of the Commandant as to his retention in his unit. establishment of the Corps will be reduced from 1,400 to 1,200. A special corps of 50 Engineers will be formed for Field Telegraphs, Searchlights, and simple Military Engineering.

7. Cadets.—The Cadet Battalion will be re-organized on entirely new lines with effect from

January 1, 1910. Details will be notified later.

8. Volunteer Reserve.—The present Ordinance, which does not allow of any one residing in the towns belonging to the Reserve except with the special sanction of the Governor, will be amended, and the Reserve properly organized into branches of the service units. Drills for Reservists will be optional, but every member of the Reserve will be required to fire an annual course and qualify in musketry in order to earn the lower capitation grant for the Corps. Those Reservists who attend the full number of drills required for efficiency in the case of active members of the Corps will earn the full grant.

Musketry.—Attention will be paid to collective effort and service conditions as distinct from individual effort and bull's-eye shooting. Donors of prizes for shooting will be invited to give them for shooting under service conditions. Government assistance with ammunition will be specially devoted to improving the shooting of indifferent shots. Disappearing targets will be provided at the different ranges wherever possible. Field firing will be encouraged wherever possible. Courses of lectures on fire direction and control will be given to units and detachments by the Staff Officer to the Commandant at centres such as Colombo, Kandy, Galle, and Badulla. Also by Adjutants who visit outlying detachments during the year.

Candidates are required to send in their names not later than June 30, 1909.

Gentlemen in the Civil Service should state in their applications whether they are presenting themselves for the first or second examination, and whether they intend taking up Sinhalese or Tamil, and whether they wish to have the option of using Codes.

Examination for the Local Division of the Civil Service of Ceylon

- 1. An Examination for admission to the Local Division of the Civil Service will be held in Colombo in or about October next. The prospects and conditions of the Service are set out in the Minutes governing the Local Division of the Civil Service published in the Government Gazette of April 2, 1909. The number of persons to be selected at this Examination will be announced hereafter.
- 2. No person will be admitted to compete who has not received a nomination from His Excellency the Governor.
- 3. Applications for nominations should be sent to the Principal Assistant Colonial Secretary—the envelope to be marked "Local Division, Civil Service"—on or before June 30. No question as to the delay or loss in the post of any such application can be entertained.
- 4. Nominations will be limited to candidates who have passed the Senior Standard of the Cambridge Local Examination, the London Matriculation, or any other public examination which may be deemed to be of an equally high standard.
 - 5. Every applicant must furnish satisfactory proof-
 - (a) That he is a natural-born British subject born in Ceylon of parents permanently resident in the Island.
 - (b) That he had attained the age of 19 and had not attained the age of 24 on January 1, 1909.

(c) That he is of good moral character.

- 6. Applicants should attach to their applications—
 - (1) Birth certificate.
 - (2) A certificate of character from the head of the school at which the applicant was educated.
 - (3) A statement showing where he was educated, examinations passed, degrees taken, &c., present occupation, and how he has spent the time since he left school.
 - (4) A medical certificate that the applicant is of sound constitution, possessed of good sight, and otherwise physically qualified for the Service.
 - (5) Particulars of property possessed by the applicant, showing the situation and nature of the land or property. It should also be stated in the case of landed property whether it is ancestral or recently acquired.
 - (6) Any athletic distinctions obtained by the applicant should be stated, also whether the applicant is a Volunteer, and whether he is able to ride.

- 7. The list of candidates to whom nominations have been granted will be published in the Government Gazette. No communication with regard to nomination, unless made in reply to inquiries, will be entertained after June 30.
- All candidates after nomination will be required to undergo a medical examination by a Board before the examination by the Civil Service Commissioners. The fee for the medical examination will be Rs. 10.50. The fee for the examination will be Rs. 25.

- 10. All candidates may offer subjects 1, 2, and 3 inclusive, with one of the languages 5, 6, 7, 8, and one of the subjects 9, 10, and 11. They may also offer one additional subject selected at pleasure from the list, i.e., not more than six subjects in all must be selected.
 - 11. A syllabus is appended showing the range of the examinations in the various subjects.
 - 12. No subjects are obligatory, nor will any text books be prescribed for any subject.

Syllabus of Subjects.

English Composition.—The standard of positive merit will be looked for in logical arrangement of thought and in accuracy and propriety of expression, but large deductions of marks will be made for faults of writing and spelling.

(Candidates are also warned that for similar faults in the use of the English language similar deductions

will be made from the marks obtained in other subjects.)

Geography.—Simple questions in descriptive and general Geography.

English History.—The general paper in this subject will be confined to events subsequent to the Norman Conquest. It will test whether the candidates are accurately acquainted with the facts of English History, and also possess an intelligent knowledge of the meaning of the facts.

The paper on the fixed period will be confined to English History subsequent to the downfall of Walpole It will require from the candidates more minute knowledge than the general paper, and will have special

reference to our Colonies and Dependencies.

Mathematics I.—Arithmetic; Algebra, up to and including the Binomial Theorem; the theory and use of Logarithms; Euclid, Books I.—IV. and VI.; Plane Trigonometry, up to and including solution of triangles; Mensuration.

Mathematics II.—Further questions and problems on the syllabus of Mathematics I.; Elementary Solid Geometry, including Euclid, Book XI., Propositions 1 to 21, Book XII., Propositions 1 and 2; Geometrical Conic Sections; Statics, the equilibrium of forces acting in one plane and of parallel forces, the centre of mass, the mechanical powers; Dynamics, uniform and uniformly accelerated rectilineal motion, uniform circular motion, falling bodies and projectiles in vacuo; Hydrostatics, including the pressure of fluids, specific gravities, floating bodies, barometric heights. In Statics, Dynamics, and Hydrostatics a knowledge of the construction and use of the more simple instruments and machines will be expected.

Latin.—Passages selected from the authors usually read in schools will be set for translation into English. Passages from English authors will be given for translation into Latin prose and verse, but candidates will be allowed, in the place of verse composition, to answer questions of a simple character, which will test whether

they possess a fundamental knowledge of the grammar of the language, and such an elementary acquaintance with Roman History as is required for the intelligent study of the books they have read.

French.—Translations of unseen passages from French into English and from English into French.

The passages for translation will be taken mainly from standard authors, and a few simple questions may be asked on the passages set, as to the structure and character of the language, and allusions of obvious and

German.—The passages for translation will be taken mainly from standard authors, and in other respects

the examination will proceed on the same lines as in French.

Natural Science Subjects.—The standard of examination in these subjects will be such as may be reasonably expected from the education given at schools possessing appliances for practical instruction, such as a laboratory, &c. A knowledge of the metric system will be expected.

Chemistry. - The laws of chemical combination and decomposition, and the preparation, classification, and properties of the principal metallic and non-metallic elements, and of such of their compounds as are treated of in inorganic chemistry.

Heat.—The elementary portion of the subject.

Physics.—The elementary properties of electricity, magnetism, light and sound.

Physiography, i.e., Physical Geography.

Geology. - Chiefly economic, including the recognition of the more familiar minerals and rocks and their properties and uses.

SCHEDULE.

CHAPTER IV.

Construction of Drains and Buildings.

Householders to build proper approaches over road drains.

43. The owner or occupier of any house, land, or premises adjoining any street, by the side of which a drain shall have been made or excavated, shall not construct or place over any such drain any bridge, platform, building, or structure of any kind, except by and with the written permission of the chairman, and subject to such condition as the chairman shall deem necessary to impose, and in such manner as he shall direct. And such owner or occupier shall maintain such bridge, platform, building, or structure of any kind in good order to the satisfaction of the chairman; and it shall be lawful for the chairman, if it shall come to his knowledge that any parties have access to any house, land, or premises so situated without such bridge, platform, building, or structure as aforesaid, or by some bridge, platform, building, or structure not constructed or placed as aforesaid, to give notice to the owner or occupier thereof forthwith to construct, or place, or alter the same, or in the event of his failing to maintain in good order such bridge, platform, building, or structure, or the drain thereunder, to give notice to the said owner or occupier to put the same in good order; and if he shall fail to fulfil the requirements of any notice so given within thirty days from the service of the said notice, or within fourteen days from such service, should the chairman state in the notice that the matter is one of urgency, the owner or occupier, as the case may be, shall be guilty of an offence, and the chairman may cause the work to be done, and the costs and expenses thereof shall be paid by such owner or occupier.

Chairman may require yard or alley to be drained.

44. It shall be lawful for the chairman, should he deem it necessary, to require by notice in writing the owner or owners of any yard or ground adjoining a building or the owner or owners of any alley, road, or path between buildings or ranges of buildings, to have such yard, ground, alley, road, or path paved to a distance, not exceeding 15 feet, from any such building or buildings or range of buildings, as the case may be, in such manner as the chairman shall direct, and to lay sufficient drains or pipes to the nearest municipal sewer or drain for the purpose of draining such yard, ground, alley, road, or path within such reasonable time as the chairman shall appoint. Such drains or pipes shall be of such materials, of such size, or such level, and with such fall, and shall be carried to such point of junction with the said municipal sewer or drains as the chairman shall appoint, provided that the chairman shall supply to such owner on application, at cost price, the materials necessary for the drains or pipes which he is required to lay. If such owner or owners shall fail to comply with the requirements of such notice within the time appointed he or they shall be guilty of an offence, and the chairman or any officers and workmen authorized by him may enter upon the premises and cause the required work to be done, and the costs thereof shall be paid by the owner.

Provided that should the nearest municipal sewer or drain be more than one hundred feet from such yard, ground, alley, road, or path, no such notice shall be issued without the previous consent of the council.

And private sewers to be ventilated.

45. It shall be lawful for the chairman to require, by notice in writing, the owner of any private sewer or drain, whether under or outside his building, to fix such pipes as the chairman may consider necessary for the proper ventilation of such private sewer or drain within such reasonable time as the chairman shall appoint. Such ventilation pipes shall be of such size and materials and shall be carried up to such height as the chairman shall direct. If such owner shall fail to comply with the requirements of such notice within the time appointed he shall be guilty of an offence, and the chairman or any officers and workmen authorized by him may enter upon the premises and cause the required work to be done, and the costs thereof shall be paid by such owner.

Construction of a drain through land intervening between land to be drained and public drain or sewer.

- 46. When it shall be found necessary under section 195 of "The Municipal Councils' Ordinances, 1887, 1890, and 1896," to construct or lay a covered drain or pipe communicating with some sewer or drain, and it is requisite for the construction or laying of such drain or pipe to carry the same through any land or lands intervening between the building or premises required to be drained and a public drain or sewer, it shall be lawful for the chairman, or for any officer of the municipality acting under his written authority in that behalf, to enter into or upon such intervening land or lands and to carry on and complete the construction or laying of such drain or pipe, after giving, two days' notice to the owner or occupier of such intervening land or lands of the chairman's intention to do so, and neither the owner, lessee, or occupier of such land shall alter, remove, or re-construct such drain or pipe without the written consent of the chairman.
- 46 A. Any person, on whom a notice has been served under section 195 of "The Municipal Councils" Ordinances, 1887, 1890, and 1896," to construct or lay a covered drain or pipe communicating with some sewer or drain, may apply to the chairman for a certificate that it is requisite for the construction or laying of such drain or pipe to carry the same through any land or lands intervening between the building or premises required to be drained and a public drain or sewer, and the chairman may, if he sees fit to do so, issue a written certificate to that effect to such person. It shall be lawful for such persons, at any time after the issue of such certificate, and after paying or tendering to the owner or owners of the intervening land or lands reasonable compensation, to enter into or upon such intervening land or lands with all necessary and proper servants, labourers, workmen, carriages, and animals and other means, and to carry on and complete the construction or laying of such drain or pipe, after giving two days' notice to the owner or occupier of such intervening land or lands of his intention to do so. The amount of such reasonable compensation and if necessary the apportionment thereof shall, in case of dispute, be referred to the decision of two arbitrators, one nominated by such person and the other by the owner or owners of such land or lands. The arbitrators shall, before proceeding to inquire into the amount of the reasonable compensation, appoint in writing an umpire; and should the arbitrators fail to agree on the amount of the reasonable compensation or the apportionment thereof, they shall refer the point or points on which they disagree to the said umpire, whose decision shall be final. Should the owner or owners fail, within ten days after they have all received notice to do so, to appoint an arbitrator, the arbitrator appointed by such person shall decide the amount and apportionment of the compensation.

Owners of new buildings, &c., to give notice to chairman of completion thereof. 47. Any person or persons erecting or enlarging or improving any building, renewing, or repairing, or altering the frontage of the same, or any person or persons who may build any drain or bridge, platform, or structure over a drain, or any privy, or cesspool, or any person or persons who may be required by the chairman, by virtue of powers conferred on him by law, to build, alter, or repair any building, drain, privy, or cesspool, shall give notice in writing of the work to the chairman within fourteen days after completion thereof.

Conditions for erection of buildings.

47 A. It shall not be lawful for any person to erect a house or hut for the purposes of a dwelling-place, or permit the same to be occupied as a dwelling-place, except under the following conditions:—

The walls shall in no case be built of cadjan, but of mud and wattle, brick, cabook, or other suitable material, to allow of being properly plastered and whitewashed.

Every room to be used for human habitation shall have at least one door not less than six feet by three feet, and at least one window not less than three feet by two feet.

The floor shall always be higher than one foot from the ground, provided the council shall be at liberty to require a higher standard according to situation.

Between any two ranges or blocks of huts there shall be a clear space of at least fifteen feet.

It shall be lawful for the council to cause any house or hut erected contrary to the provisions of this by-law to be taken down at the expense of the owner, if within one month after written notice to him to alter or take down the same he shall fail or neglect to do so.

Any person who shall, without the sanction of the chairman, build, renew, or cause to be built or renewed any building or portion of a building with thatch, leaves, straw, grass, or shingle, or other inflammable material of whatever description shall be guilty of an offence.

¿Buildings unfit , for human , habitation.

- 47 B. (1) If for any reason any building intended for or used as a dwelling shall appear to the chairman to be unfit for human habitation, he shall cause any municipal officer to apply to the municipal magistrate to prohibit the further use of such building for such purpose; and the said magistrate, after such inquiry as he thinks fit to make, may, by written order, make a prohibition as aforesaid, or may pass such other order as he shall deem just and proper.
- (2) When any such prohibition has been made, no owner or occupier of such building shall use or suffer the same to be used for human habitation until the chairman certifies in writing that the causes rendering it unfit for human habitation have been removed to his satisfaction, or the municipal magistrate, by a written order, withdraws the prohibition aforesaid.

Insanitary huts and sheds.

47c. If the chairman is of opinion that any building, or range of buildings used either as a dwelling or as a stable or for any other purpose, is likely by reason of its being built without a sufficient height, or without proper means of drainage, or on account of the impracticability of scavenging, or owing to the manner in which it and other huts or sheds are crowded together, to cause risk of disease to the inmates thereof or to the inhabitants of the neighbourhood, or is for any reason likely to endanger the public health or safety, he may by written notice, which shall be affixed to some conspicuous part of such hut or shed, require the owner or occupier thereof, or the owner of the land on which such hut or shed stands, to remove or alter such hut or shed, or to take such order for the improvement thereof as the chairman shall deem necessary.

CEYLON GOVERNMENT RAILWAY.

Scheme for Training of educated or First Grade Apprentices for Advancement in the Service of the Locomotive Department of the Ceylon Government Railway.

- 1. Object of Schema—The object of this scheme is to encourage the employment of educated and intelligent Ceylonese with a view to their being specially trained for promotion to the posts of Workshop and Shed Chargemen, Assistant Locomotive Foremen, and Engine Drivers of the locally-trained grades.
 - 2.4 Agreement.—All apprentices under this scheme will be required to sign a five-year' agreement.
- 3. Educational Qualifications.—All candidates must have passed the Eighth Standard examination or the Cambridge Local Junior examination (except in very special cases approved by Government), and must produce a certificate of good character from the principal of the school where educated.
- 4. Age and Physique.—Candidates must not be less than 15 or more than 18 years of age at the time they begin their apprenticeship, and must produce certificate of birth. They must be of good physique, the appointment being subject to medical examination.
 - 5. Periods of Apprenticeship.—(a) For promotion to Chargemen and Assistant Locomotive Foremen:—

- 6. Engagement.—Preference will be given to applicants whose parents are or nave been employed on the Ceylon Government Railway.
- 7. Training.—An apprentice, should he desire it, can by special arrangement be trained for one trade only, such as turner, fitter, smith, boiler-maker, carriage-builder, &c., but in such a case he can only expect advancement in the special trade selected by him. He must be trained as a mechanic in the turning, fitting, and erecting shops, and in the drawing office (if there is a vacancy), should he desire promotion to the grades mentioned in paragraph 1.
- 8. Increments.—Increments will be given only upon satisfactory reports regarding an apprentice's good conduct, diligence, and ability.
 - 9. Leave.—No pay will be given to workshop apprentices when on leave.
- 10. Probation.—All candidates for apprenticeship must serve three months on probation prior to being taken on as apprentices. Such probationers will be paid 50 cents a day, and this time will not count towards apprenticeship.
- 11. Dispensing with Services.—If an apprentice's conduct is not satisfactory, the Locomotive Engineer has the power to terminate his agreement without previous notice or assignment of cause for so doing.
- t 12. Certificates.—Certificates will not be given to apprentices who leave the service prior to completion of their agreement.
- 13. Permanent Employment after completion of Apprenticeship.—No guarantee of permanent employment will be given after completion of apprenticeship, but should there be vacancies subsequent employment will be given to those who have given entire satisfaction.
- 14. Locally-trained Drivers, 2nd grade, Rs. 1,200 per annum rising to Rs. 2,000 per annum. Locally-trained Drivers, 1st grade, Rs. 2,100 per annum rising to Rs. 2,400 per annum.

Overtime and other allowances will be in accordance with the sanctioned scale.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended May 29, 1909.

Births.—The total births registered were 79 (1 European, 7 Burghers, 47 Sinhalese, 10 Tamils, 12 Moors, 1 Malay, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1909, viz., 182,058) was 22.6, as against 20.1 in the preceding week, 24.1 in the corresponding week of last year, and 25.5 the weekly average for last year.

Deaths.—The total deaths registered were 127 (3 Burghers, 68 Sinhalese, 30 Tamils, 17 Moors, 3 Malays, and 6 Others). The death-rate per 1,000 per annum was 36.4, as against 29.8 in the previous week, 34.5 in the corresponding week of last year, and 36.5 the weekly average for last year.

Intantile Deaths.—Of the 127 total deaths, 27 were of infants under one year of age, as against 24 in the preceding week. 32 in the corresponding week of the previous year, and 31 the average for last year.

Still Births.-No still births were registered during the week.

Selected Causes of Death.—Nineteen deaths were registered from Pneumonia and 6 from Bronchitis.

- 2. Seventeen deaths were registered from Philicis (against 13 in the previous week and also the weekly average for last year), of which 3 each were in St. Paul's and Kotahena Wards, and 2 each in Maradana (exclusive of hospitals). Slave Island. Kollupitiya, and the General Hospital.
- 3. Fourteen deaths were registered from Enteric Fever (against 7 in the previous week and 8 the weekly average for last year), of which 3 were in Kotahena, 2 each in Pettah, New Baraar, Maradana (exclusive of hospitals), and the General Hospital, and I each in St. Paul's, Slave Island, and Kollupitiya. During the week 19 cases of Enteric Fever were reported, against 14 in the previous week.
- 4. Six deaths were registered from Diarrhea, 2 from Dysentery, and 6 from Infantile Convulsions, 57 from other causes.

State of the Weather.—The mean temperature of air was 83:3°, against 84.7° in the preceding week and 83:2° in the corresponding week of the previous year. The mean atmospheric pressure was 29:909 in., the same as in the preceding week, and 29:911 in the corresponding week, of the previous year. The total rainfall in the week was 1:04 in., against 0:24 in. in the preceding week and 0:66 in. in the corresponding week of the previous year.
