PROCLAMATION.

By His Excellency Sir Henry Edward McCallum, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

NOW Ye that We, the Governor of Ceylon, in exercise of the power in Us vested by section 1 of Ordinance No. 7 of 1909, intituled "An Ordinance to provide for the erection and maintenance of permanent Landmarks to define the Boundaries of Land alienated by the Crown," do hereby appoint and ordain that the said Ordinance shall come into operation on January 1, 1910.

Given at Colombo, in the said Island of Ceylon, this Fourteenth day of December, in the year of our Lord One thousand Nine hundred and Nine.

WHEREAS by virtue of the Coinage (Ceylon) Order, 1892, the Ceylon five-cent piece and the Ceylon quarter-cent piece, being two of the subsidiary coins specified in the third schedule to the said Order, are legal tender in Ceylon:

And whereas by the Ceylon (Coinage) Order, 1909, His Majesty, by and with the advice of His Privy Council, has been pleased to order—

- (1) That the Ceylon five-cent piece and the Ceylon quarter-cent piece specified in the third schedule to the Coinage (Ceylon) Order, 1892, shall cease to be current or legal tender in the Colony;
- (2) That the said Order should come into operation upon the date to be fixed in that behalf by Proclamation of the Governor of the Colony in Council:

Now therefore We, the said Governor of Ceylon, in pursuance of the said Ceylon (Coinage) Order, 1909, and with the advice of the Executive Council, do by this Our Proclamation direct that the said Ceylon (Coinage) Order, 1909, shall come into operation upon the First day of July, 1910.

Given at Colombo, in the said Island of Ceylon, this Thirteenth day of December, in the year of our Lord One thousand Nine hundred and Nine.

WHEREAS by an Order of Her late Majesty in Council dated February 6, 1892, it was amongst other things provided that subsidiary coins might be from time to time coined for Ceylon under the direction of the Master of Her Majesty's Mint or at one of Her Majesty's Mints in British India of the denominations, weights, and fineness specified in the third schedule to the said Order, and that those coins should have the obverse and reverse impressions specified in Article 2 of the said Order, and that each such coin should be a legal tender for the amount of its denomination:

And whereas by the said Order it was further provided that if the Governor of Ceylon from time to time requests any new coins of less value than the rupee, whether of silver, copper, or mixed metal, to be coined, and the Commissioners of Her Majesty's Treasury approve such request, those new coins might be so coined under the direction of the Master of Her Majesty's Mint or at one of Her Majesty's Mints in British India, and that such new coins should have either the impressions directed by the said Order for the coins specified in the third schedule thereof or such other impressions as might be approved by the Master of Her Majesty's Mint and the Commissioners of Her Majesty's Treasury:

And whereas We, the aforesaid Governor of Ceylon, have requested that a new subsidiary coin should be coined of the denomination, value, composition, weight, and fineness set out in the schedule hereto, and the Commissioners of His Majesty's Treasury have approved of such request, and the said new subsidiary coin has been coined having for the obverse impression His Majesty's effigy with the inscription "Edward the Seventh, King and Emperor," and for the reverse impression that specified in the second clause of Article 2 of the said Order, which impressions have been approved of by the Master of His Majesty's Mint and the Commissioners of His Majesty's Treasury:

And whereas by Article 5 of the said Order it was provided amongst other things that, subject to the conditions in the said article contained, a tender of payment of money in Ceylon should, in the case of coins of copper and mixed metal, be legal tender for the payment of an amount not exceeding one-half coins were coined, the said article should, after the date fixed by the Governor in a Proclamation made with the approval of the Commissioners of Her Majesty's Treasury and one of Her Majesty's principal in the third schedule to the said Order, apply to the new coins as if the schedule to the Proclamation were added to the third schedule:

Now know Ye that We, the aforesaid Governor of Ceylon, hereby in pursuance of Article 5 of the above recited Order of Her late Majesty in Council, and with the approval of the Commissioners of His Majesty's Treasury and one of His Majesty's principal Secretaries of State, proclaim and direct that from and after January 1, 1910, Article 5 of the above recited Order of Her late Majesty in Council, dated February 6, 1892, shall apply to the subsidiary coin, the particulars whereof are set forth in the schedule hereto:

By His Excellency Sir Henry Edward McCallum, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by section 53 of "The Courts Ordinance, 1889," it is enacted that it shall be lawful for the Judges of the Supreme Court from time to time to frame, constitute, and establish such general rules and orders of court as to them shall seem meet for regulating the pleading practice and procedure where not specially provided for by "The Civil Procedure Code, 1889," upon all actions, suits, prosecutions, and other matters, civil or criminal, to be brought in the Supreme Court and in all courts subordinate to it, and generally to frame, constitute, and establish all such general rules and orders as may be necessary for giving full and complete effect to the provisions of the said Ordinance: Provided always that no such rules, orders, regulations, or forms shall be repugnant to or inconsistent with any of the provisions in the said "The Courts Ordinance, 1889," or any other Ordinance contained:

And whereas it is also enacted that all rules, orders, or regulations when so framed shall be laid before the Legislative Council if then in Session, and if not then in Session, then as soon as possible after the commencement of the next ensuing Session, and if within forty days after their being so laid before the Legislative Council any of such rules, orders, or regulations be objected to by the Legislative Council, the said Council may by resolution annul any such rules, orders, or regulations:

And whereas it is also enacted that such rules, orders, and regulations as shall not be so annulled by the said Council within the said period of forty days shall be proclaimed in the Government Gazette, and shall come into force upon the publication thereof or on such other day as may be specified in such Proclamation:

And whereas the rules set out in the schedule hereto for the better preparation and more convenient and speedier hearing of land cases in the first instance and on appeal have been framed by the Judges of the Supreme Court and laid before the Legislative Council; and whereas the period of forty days after their being so laid before the Legislative Council has expired, and the said rules have not been objected to by the said Council:

It is hereby proclaimed that the rules set out in the schedule hereto for the better preparation and more convenient and speedier hearing of land cases in the first instance and on appeal have been framed by the Judges of the Supreme Court, and it is hereby declared that the same shall come into force as from and after the date hereof.

SCHEDULE.

Rules of Court.

Order for the better preparation and more convenient and speedier hearing of Land
Cases in the first instance and on Appeal made by the Judges of the
Supreme Court under Section 53 of "The Courts
Ordinances, 1889 and 1901."

We, the Honourable Sir Joseph Turner Hutchinson, Chief Justice of the Island of Ceylon, and the Honourable John Page Middleton and the Honourable Alexander Wood Renton, Puisne Justices of the Superme Court, do hereby, in exercise of the powers given by "The Courts Ordinances, 1889 and 1901," and all other powers enabling us in this behalf, make the following rules for the better preparation and more convenient and speedier hearing of land cases in the first instance and on appeal:—

- 1. In every action or proceeding in a District Court or Court of Requests in which the title of the parties to land is in issue, the plaintiff's proctor shall file with his memorandum of documents an abstract of the plaintiff's title in chronological order, and the defendant's proctor with his answer shall file a similar abstract of title for the defendant, showing the particulars set forth in the Schedule A hereto.
- 2. In any case in which the question of pedigree arises, the proctor for the party relying on it shall file with his plaint or answer a paper containing the pedigree on which he relies.
- 3. Where an appeal is entered in any such case as aforesaid, the proctor for the party appealing shall file in the District Court or Court of Requests a memorandum, to be forwarded with the petition of appeal to the Supreme Court, containing a list of all documents received in evidence on both sides, showing their markings by the Court, and briefly stating their nature, and by whom and to whom they are made, e.g., "P 1. Lease—defendant to plaintiff, dated May 24, 1891;" "D 1. Conveyance—plaintiff to defendant, dated June 19, 1901; ""P 2. Extract from record in D. C., Colombo, 2,071."
- 4. The documents to be provided under these rules shall be written legibly or typed on good paper and signed by the proctor who furnishes them.
- 5. The costs of preparing the documents shall be costs in the cause, and shall be charged as set out in the Schedule B hereto.
 - 6. These rules may be cited as "The Civil Procedure Rules, 1909."

GOVERNMENT NOTIFICATIONS.

THE following copy of an Order of His Majesty the King in Council of November 21, 1908, providing for the recognition in the United Kingdom of the load line certificates issued to German ships by the German authorities on and after January 1, 1909, is published for general information.

The King's Most Excellent Majesty in Council.

W HEREAS by section 445 of "The Merchant Shipping Act, 1894," it is enacted that where the Board of Trade certify that the laws and regulations for the time being in force in any foreign country and relating to overloading and improper loading are equally effective with the provisions of that Act relating thereto, His Majesty in Council may direct that on proof of a ship of that country having complied with those laws and regulations, she shall not, when in a port of the United Kingdom, be liable to detention for non-compliance with the said provisions of that Act, nor shall there arise any liability to any fine or penalty which would otherwise arise for non-compliance with those provisions:

And whereas by section 1 of "The Merchant Shipping Act, 1906," provision, as is more particularly therein mentioned, is made for applying to foreign ships when in ports in the United Kingdom certain sections of "The Merchant Shipping Act, 1894," which relate to load line without prejudice to any direction of His Majesty in Council given under the said section 445 of the last-mentioned Act:

And whereas the Board of Trade have certified that certain statutory regulations which have been approved by the German Government relating to overloading, so far as regards the assignment of load lines to German ships on and after January 1, 1909, are equally effective with the corresponding regulations in force in this country respecting the assignment of load lines to British merchant ships:

Now, therefore, His Majesty in Council doth direct that on proof that German ships have complied with the aforesaid German regulations, such ships shall not, when in ports of the United Kingdom, be liable to detention for non-compliance with the provisions of the Merchant Shipping Acts relating to overloading, nor shall there arise any liability to any fine or penalty which would otherwise arise for non-compliance with those provisions.

IT is hereby notified for general information that His Excellency the Governor, with the advice of the Executive Council, has been pleased to amend rules 4 and 8 of the rules regulating the pensions to be granted to Public Servants of this Colony, promulgated by Notification dated December 9, 1908, and to substitute therefor, with the sanction of the Secretary of State for the Colonies, the following rules.

AMENDED RULES.

4. Acting service in an office carrying claim to pension will, when continuous with permanent employment, be allowed to reckon as service for pension, provided no other officer was earning pension for the same period in respect of the same office. And a Public Servant who has been transferred from a non-pensionable to a pensionable office will be entitled to reckon his service in the former, if it has been continuous with his subsequent service in the latter capacity. The service of a Public Servant under sixteen years of age does not count for pension, but may count for a long service allowance granted under section 29 of this Minute.

Mode of Calculation of Pension, &c.

8. The pension or gratuity awarded to a Public Servant shall be computed upon the salary drawn by him at the time of his retirement in respect of the permanent office or offices then held by him, provided that he shall have held such office or offices, or an office or offices to which the same fixed salary or incremental scale of salary is attached, for at least three years; otherwise the pension shall be calculated upon the average of the salaries attached to the permanent offices held by such person during the three years next preceding the commencement of such pension. Provided that where an officer retires within three years of his promotion to a higher class or grade, he shall have the option of claiming either a pension calculated in manner aforesaid or a pension calculated on the salary which he was receiving immediately before his promotion to the higher class or grade. In case of native sergeants of the Police Force, pension will be calculated on the salary drawn at the time of retirement, even if such salary was not drawn throughout the preceding three years, if the officer has served in the class in which he is serving at the time of his retirement for such three years.

T is hereby notified that an examination under the Regulations of February 25, 1909, for gentlemen in the Civil Service will be held in the Council Chamber on Monday, January 17, 1910, at 10.30 A.M., and following days, namely:—

Monday, January 17 . . Sinhalese Thursday, January 20 . . Law Friday, January 21 . . Accounts Wednesday, January 19 . . Law Saturday, January 22 . . Tamil

The examination in the Criminal Procedure Code prescribed under the Minute of March 26, 1900, for officers in the Fourth Class of the Civil Service, will also be held on January 18, 1910, as well as at the Kandy Kachcheri.

It is also hereby notified that candidates will be given the option of using Codes in the examination in the Criminal Procedure Code and the Penal Code; they must, however, state when sending in their names what their decision is, as the character of the papers set for those who use Codes and those who do not will be different.

The examination for officers in the Police Department, and the *vivâ voce* examination in the native languages for officers in the Public Works Department, the Irrigation Department, the Forest Department, and the Railway Department, will be held at the same time and place.

Candidates are required to send in their names not later than December 31, 1909.

Gentlemen in the Civil Service should state in their applications whether they are presenting themselves for the first or second examination, and whether they intend taking up Sinhalese or Tamil, and whether they wish to have the option of using Codes.

The hours of examination will be from 10.30 a.m. to 1.30 p.m. and from 2 p.m. to 5 p.m., exclusive of the viva voce examinations, which will be specially arranged for.

"THE GAME PROTECTION ORDINANCE. 1909."

IS Excellency the Governor in Executive Council, in exercise of the powers vested in him by section 27 (a) and (b) of the above-named Ordinance, and with the advice of the Executive Council, is pleased to make the following regulations for the protection of fish within the territorial and inland waters of the Island.

REGULATIONS REFERRED TO

WESTERN PROVINCE.

- 1. Lunawa Lake.—The use of the nets called "ma-del," "nool-del," "kachchi-del" is prohibited in the Lunawa lake of the Salpiti korale within the Colombo District of the Western Province of this Island.
- 2. Sea Coast of Alutkuru Korale North.—The use of the net called "waliwalai" is prohibited along any part of the sea coast of Alutkuru Korale North in the Western Province, from the mouth of the Maha-oya on the north to Kepungoda on the south.
- 3. Negombo Lake.—The use of the net commonly known as "maha-dela" or "karawali," "wali-del" or "waliwalai," "rena-del" or "renawalai" is prohibited in the Negombo lake within the following limits:—Bounded on the north by the shore of the island of Duwa, the town of Negombo, and the village Taladuwa; on the south by the shore of the Pamunugama and Dandugama villages; on the east by the shore bordering the road from Colombo to Negombo between the 15th and 22nd miles; and on the west by a strip of land along the shore from Duwa to Pamunugama.
- 4. Panadure Lagoon.—The catching of fish by means of gunny bags, or the use of any of the description of nets known as "ran-dela" or "kulu-dela" or "ara-dela" is prohibited in the Panadure lake, a portion of the Panadure river, as specified hereunder. That portion of the Panadure river known as the Panadure lagoon lying within the following limits:—North by the bank of the river lying in the village Indibedda; east by the Angulu-eliya lake and the bank of the river in the villages Horetuduwa, Gorakane, Sarikkamulla, Henemulla, Pallimulla, Gorakapola, Walana, and Pattiya North; south-west by the sea; west by the bank of the river lying in the villages Egoda Uyana, Katukurunda, Koralawella, Moratuwella, Digarolla, and Rawatawatta in Palle pattu of Salpiti korale.
- 5. Panadure Angulu-cliya.—The gunny bag mode of catching fish, or the use of "ran-dela" or "kulu-dela" or "ara-dela" is prohibited in the Angulu-cliya, a portion of the Panadure river, as specified hereunder. That portion of the Panadure river known as the Angulu-cliya lying within the following limits:—A line drawn from Ambalantotupola in Indibedda straight to the opposite bank in the village Deltara; a line drawn from Parattetotupola in Panadurebadda straight to the opposite bank in the village Dampe; and a line drawn from Panturawalkada in Indibedda straight to the opposite bank in the village Horekele.
- 6. Bolgoda Lake.—The catching of fish by means of gunny bags or the use of the description of nets known as "ran-dela" or "kulu-dela" or "ara-dela" is prohibited in that portion of the Panadure river known as Bolgoda lake as specified hereunder:—North-west by the Angulu eliya lake; north-east by the bank of the river lying in the villages Dampe, Madapata, and Kahapola in the Palle pattu of Salpiti korale, Kindelpitiya, Medagama, Alutgama, Ramukkana, Bolgoda, Maswila, and Galtude in the Raiygam korale; south by the bank of the river lying in the villages Kudagoneduwa, Mahagoneduwa, Mestiya, Weregama in the Waddubadde; west by the bank of the river lying in the villages Talpitiya, Madupitiya, Imbulhiya, Mahabellane, and Urakaduwa in Talpitibadda, Maha Aruggoda, Malmulla, Hirane, Galtude, Ambalanduwa, Totawatta, Kehelwatta, Paratta, Gorakana in Panadurehadda.
- 7. Colombo Harbour.—The use of the kind of nets known as "wella-del" and "madi-del" is prohibited within the following limits of the sea:—The area commencing from the lighthouse of the North-eastern arm of the Breakwater of the Colombo Harbour, thence along the Breakwater and along the coast northwards to a point indicated by a beacon erected north of the Dikowita outlet, thence due west to a buoy placed two miles out at sea, thence to the buoy placed at the Unagala rock, and thence to the lighthouse of the North-eastern arm.

NORTHERN PROVINCE.

- 1. Elephant Pass.—The use of casting nets and drag nets is prohibited in the Jaffna lake within a radius of half a mile of the causeway and bridge at Elephant pass in the Pachchilaipali and Karachchi divisions of the Jaffna District of the Northern Province.
- 2. The use of the following kinds of nets, viz., (1) the drag net called "arakkuddivalai"; (2) the net called "kudduvalai," which consists of the drift net called "valivalai," to which are attached one or more bags called "madivalai," similar

to those used with the drag net and weighted or not weighted at the bottom; and (3) the drift net called "valivalai" in any form, with or without weights, and with or without "madivalai" or other appendages, is prohibited in—

- (a) Jaffna Lagoon and Islands.—The area bounded by a line running along the northern shore of the Jaffna lagoon from a point two miles north of the Punnalai causeway to Chundikkulam (the boundary running up the Uppar as far as the Uppar bridge); thence along the southern shore of the lagoon from Chundikkulam to Kalmunai point, from Kalmunai point to the western point of Palaitivu; thence to the south-western corner Nainativu; thence to the southern point of Analaitivu, along the western coast of that island and from its northern point to the northern point of Eluvaitivu; thence to the north-western point of Karaitivu; and thence to the point on the shore of the lagoon two miles north of Punnalai causeway.
- (b) West Coast Jaffna to Mannar.—The area bounded by a line running from Kalmunai point to the western point of Palaitivu; thence to the western point of Iranaitivu; thence to the western limit of Pesalai village; and thence along the northern shore of Mannar island, the Mannar causeway, and the western coast of the Northern Province to Kalmunai point.
- (c) Tondaimannar and Vallai.—The area bounded by a line running from the eastern end of the Tondaimannar bridge along the shore of the inlet to the northern end of the Vallai bridge, along the Vallai bridge to its southern end; thence along the western shore of the inlet to the western end of the Tondaimannar bridge and along that to its eastern end.

SOUTHERN PROVINCE.

- 1. No "dalkandas" shall be cast in shore of a line from Mahawattagalla in Tennekongewatta to Katimanagalla.
- 2. Inshore of a line from Gandara Tuduwe to Hambangalla in Mudiyansegewatta the Dondra fishers shall, during the months of April and May each year, be at liberty to use five "dalkandas" per day; provided, however, that such "dalkandas" shall be cast between sunrise and 9 A.M.
- 3. Dondra fishers wishing to avail themselves of the provisions of the foregoing rule shall obtain permit from the Patabende of Dondra; each permit shall be available for one day, i.e., for the day named therein
 - 4. No "dalkandas" more than six fathoms square shall be used in the bay.

Note.—All the four rules affect the Bay of Gandara and the fishers of Gandara and Dondra South.

EASTERN PROVINCE.

- 1. Destruction of Fish.—Any person who kills or takes, or attempts to kill or take, fish by means of poison, dynamite, or other explosive, or by any means not in accordance with local custom, shall be liable to a fine.
- 2. Prohibited Nets.—The use of the nets specified hereafter is prohibited in the waters mentioned below:—
 - Koralai Pattu.—"Karaivalai," "silvalai," "polvalai," "nittuvalai," and adsalvalai" may not be used in Panichchankeni-aru and Mukattuvaram and Valachenai-aru Mukattuvaram.
 - Bintenna Pattu.—The use of any kind of net is prohibited in pools which are used for drinking and bathing.
 - Manmunai North.—The use of the net called "karaivalai" is absolutely prohibited in any part of the Batticaloa lagoon and on the sea coast for a distance of half a mile due north and south of the spot where the said lagoon meets the sea.
 - The use of any kind of net is prohibited in that portion of the said Batticaloa lagoon lying between its junction with the sea and a straight line drawn due east from the southern end of Maddikali-odai to the opposite shore of the said lagoon.
 - The use of all nets, save the net called "veechuvalai," is prohibited between the line described above and a straight line drawn due west from Puthumuhattuvaram (Dutch Bar) to the opposite shore of the Batticaloa lagoon.
 - The use of all nets, save the nets called "veechuvalai" and "sanal veechuvalai," is prohibited in that part of the said lagoon lying between the aforesaid line drawn from Puthumuhattuvaram (Dutch Bar) and a line drawn through the Kallady ferry from the landing stage near the Batticalos. Fort to the landing stage at Kallady.
 - Batticaloa Fort to the landing stage at Kallady.

 The use of the net called "polvalai" or "adasalvalai" is prohibited in that part of the said lagoon lying between the aforesaid line drawn through Kallady ferry and a straight line drawn due east from the southern extremity of Timilativu to Buffalo island and a line drawn due east from the southern extremity of Buffalo island to Arapattai, on the opposite shore.

The use of the net called "silvalai" is prohibited from December 1 in each year to March 31 of the following year, and the use of the net called polvalai" is prohibited from April 1 to November 30 in every year to the south of the places named in the preceding rule.

Manmunai South.—The use of "karavalai" is absolutely prohibited in any

part of the Batticaloa lagoon and in any tanks or rivers. The use of "silvalai" and "polvalai" is prohibited in Attiyamunmarikuda, Pirappankuda, Puranvelikuda, and Kokkadicholaikuda.

Eruvil and Porativu.—The use of "karavalai," "adasalvalai," "silvalai," and "polvalai" is prohibited in the following waters:—Ondachchimadom odai Kallarodei Natanaikuda.

madam-odai, Kallar-odai, Natanaikuda, Irippitikuda, Tampalvattaikuda, and Chenaturaikuda.

Karavaku Pattu.—The use of "silvalai;" "polvalai," "adasalvalai," and "karaivalai" is prohibited in the following waters:—Periyakal-"silvalai;" luttu-odai, Periyanilavanai Periyakulam, Periyanilavanai Vaddikulam, Turainilavanai Kumarapodiyarkulam, and Pandiruppu Settukuda. Sammanturai.—The use of "karaivalai" in rivers and streams is abso-

lutely prohibited.

Akkarai Pattu.—The use of "karaivalai," except in the sea, is absolutely prohibited. The use of "silvalai," "polvalai," and "adasalvalai" is prohibited in the following waters :- Konavattai, Tillai-aru, Koraika-

lappu, and Periyakalappu.

Panawa Pattu.—The use of "karaivalai," "silvalai," "polvalai," and "adasalvalai" is prohibited in the following waters:—Timittarkalappu, Komarikalappu, Murungantanakalappu, Koddukalkalappu, Arugamakalappu, Duvaikalappu, Kudakallikalappu, Panawakalappu, Panakagala, Kunnugala, Salawakalappu, Vakarakalappu, Ittigala, Andaragala, and Yagala.

NORTH-WESTERN PROVINCE.

Puttalam Lake.—The use of the net called "arukaddivalai" in Tamil or "addasi-del" alias "pita-dela" in Sinhalese in the inlets along the east shore of the Akkarai Pattu North between the northern point of Dutch Bay called Uchchamunai to the north and Kalmunai point to the south, and adjoining the villages of Tilliadi, Mutwal, Dutch Bay, Kurusadimunai, Pasikkuda, Kandakkuda, Palakuda, and Kalmunaikuda, and also along the said west shore of the Pomparippu pattu between Vellamundal to the north and Anaikutti to the south, and adjoining the villages of Karativu and Ambalam in the Kalpitiya division of the Puttalam District, in the North-Western Province, is prohibited.

"THE GAME PROTECTION ORDINANCE, 1909."

IS Excellency the Governor in Executive Council being satisfied that the Ceylon Fishing Club has made adequate arrangements for preserving and protecting trout in the waters mentioned in Schedule I. has been pleased, in exercise of the powers vested in him by section 16 (1) of the above-named Ordinance, to concede to the Club or Association, known as the "Ceylon Fishing Club," the exclusive right of taking trout in such waters until further order, and subject to the rules of the said Club set out in Schedule II. hereto, which rules the Governor in Executive Council, in exercise of the powers vested in him by section 16 (2) of the said Ordinance, has been pleased to approve.

SCHEDULE II.

Rules of the Ceylon Fishing Club approved by the Governor in Executive Council.

Preamble.—The Ceylon Fishing Club is formed for the purpose of stocking the streams and lakes of Ceylon with trout and other suitable fish that afford good sport, and of regulating the fishing of such streams and lakes as may be stocked.

1. Any resident in the Island after being duly proposed and seconded for election as a member of this Club shall be balloted for by the Managing Committee, one black ball in five to exclude.

The term "resident" shall apply only to those persons who have lived six months in the Island or purpose becoming permanent colonists, provided that all Military Officers serving in Ceylon and all Naval Officers serving in the East India Station be considered as residents.

- The annual subscription shall be Rs. 15, and shall be payable in January of each year. Any member failing to pay his subscription before the commencement of the fishing season is liable, at the discretion of the Committee, to have his name deleted from the list of members.
- 3. Licenses to fish for trout shall be issued by the Assistant Government Agent, Nuwara Eliya, at the following rates to-

These rates include the Government stamp duty of Rs. 5 on each license.

The sums received for the licenses, less the stamp duty, shall be credited to the Club on receipt.

At the end of the season the Honorary Secretary of the Club may apply to Government for refund of the sums expended on the stamps.

A license authorizes the use of one rod only.

Lady relatives can fish on full members' licenses on taking out a license on a revenue stamp of Rs. 5.

Fish taken on such licenses shall be reckoned against the members' licenses.

No fish shall be kept on any license in excess of the number prescribed from time to time by the Managing Committee and notified on the back of the license.

Note.—It is recommended that all members when fishing should carry a disgorger.

4. All waters above 4,000 ft. have been leased by the Club, and subject to note (a). Club licenses should be held by all persons fishing therein.

Note (a).—Persons holding licenses from the Board of Improvement, Nuwara Eliya, to fish for carp in Lake Gregory and the Barrack Plains Lake may do so only during the open season for trout.

Such licensees may fish in the Barrack Plains Lake all the year round, but the following regulations must be complied with (these waters having been leased by the Fishing Club) :-

- (a) They shall not fish within the area set apart from time to time by the Ceylon Fishing Club for trout fishing.
- (b) They shall at once return to the water all trout accidentally caught.
- 5. Fishing in all Club waters shall be with a fly. Fishing with artificial spinning bait is allowed where notified as permissible and in the lakes within the limits demarcated by notice boards. Fishing with live or dead bait (including worms) is prohibited. No restrictions are placed upon the bait to be used for trout in the lakes outside trout fishing limits.
- (a) Any fish under 15 inches caught with worm should at once be returned to the water.
- The close season shall be fixed annually at a duly convened General Meeting, and the Government Agents shall be asked to proclaim the same.
- 7. No trout fishing shall be allowed during the close season, except by special permission of the Managing Committee for stocking or breeding purposes.
 - No member or licensee shall fish in Club waters before 6 A.M. or after 7 P.M.
- All trout under the limit prescribed by the Managing Committee shall be at once returned to the water.
- 10. Two General Meetings shall be summoned by advertisement in the local papers every year. One within thirty days of the close of the fishing season, and the second during the Nuwara Eliya Gymkhana Meeting, nine to form a quorum. At the first-named meeting a Committee and Managing Committee for the ensuing year shall be elected, and the accounts of the Club shall be submitted. A Special General Meeting may be summoned on the requisition of five members.
- 11. No rule shall be altered or amended except at a General Meeting of the Club; sufficient notice of such proposed alteration or amendment shall be given to the Honorary Secretaries to allow them to give each member of the Club ten days' notice of such alteration or amendment.

12. The Committee shall consist of twenty members, with power to add to their

A meeting of the Committee shall be held once annually or oftener as occasion may require, five to form a quorum.

13. The general management of the Club shall be carried on by a Managing Committee of ten members (exclusive of the Secretary or Joint Secretaries), three to form a quorum, who shall be elected at the General Meeting at the close of the season. In the case of vacancies on the Managing Committee, the remaining members shall have power to fill up such vacancies for the current year.

Note.—The Managing Committee are entrusted with the management of all the streams in charge of the Club, and shall notify from time to time what streams or part of streams they propose to fence, and for what periods. The Managing Committee are authorized to declare any waters fenced for any one season.

- 14. A Secretary (or Joint Secretaries) shall be appointed to carry on the business of the Club, subject to the approval of the Managing Committee.
- A return of all fish killed shall be rendered on the back of the license, which shall be returned to the Honorary Secretary on the expiration of the license.

 All fish killed on the Horton Plains shall, in addition, be entered in a book kept

for the purpose at the Horton Plains Resthouse.

- 16. Any infringement of the rules of the Club shall subject the offending member to a fine or expulsion from the Club at the discretion of the General Committee. In a case of expulsion at least nine members shall vote and shall carry a majority of two-thirds.
- Any person fishing without a license or without having applied for a license shall be prosecuted, unless he condones the omission to the satisfaction of the Managing Committee.
 - Conditions on the back of the licenses to be as follows:-

(1) No netting shall be allowed under any consideration.

(2) Fly fishing only is permitted in the streams, except when spinning is notified as permissible, any fly or artificial spinning bait in the lakes within the notice boards.

(3) No fishing is allowed during the close season.

(4) No fishing is permitted before 6 A.M. or after 7 P.M.

- (5) All fish under the size prescribed by the Managing Committee shall at once be returned to the water.
- (6) The license only entitles the licensee to take and kill trout, but gives no right to fish in private waters leased by the Ceylon Fishing Club, except by private arrangement with owners or licensees.

(7) The limit of fish to be killed by any one member during the current season shall be fixed by the Managing Committee.

(8) This license is issued on condition that the holder thereof shall return the same with the number of fish caught and the number kept, and that no new season's license shall be issued till the above is complied with.

(9) This license authorizes the use of one rod only.

(10) It is recommended that all members should carry a disgorger when fishing.

- (11) That all fish caught and kept alive and any ova obtained therefrom be considered the property of the Club, and be at its absolute disposal if called for at any time; and further, all fish over size prescribed by the Managing Committee shall be included in the number allowed to be taken.
- (12) All license-holders are bound by the rules of the Ceylon Fishing Club.
- (13) The number of fish to be kept on each monthly, weekly, and daily licenses shall be prescribed by the Managing Committee.

IT is hereby notified that His Excellency the Governor in Executive Council, in exercise of the powers vested in him by section 11 of the Game Protection Ordinance, No. 1 of 1909, has been pleased to fix the following rates as royalty to be levied on the removal of elephants, whether wild or tame, from the Island to any place beyond the seas :-

"THE CEYLON POST OFFICE ORDINANCE, 1908."

T is hereby notified that His Excellency the Governor, in exercise of the power vested in him by section 47 (1) of the above-named Ordinance, and with the advice of the Executive Council, has been pleased togmake the rules appended hereto, relating to Inland Telegraph Money Orders, in substitution for the rules notified on October 25, 1909, and published in the Government Gazette No. 6,337 of October 29, 1909, with effect from January 1, 1910.

RULES.

Inland Telegraph Money Orders.

- 1. Offices.—Money may be transmitted by means of Telegraph Money Orders from all Post Offices at which ordinary Money Orders are issued and paid, and may be transmitted to the same offices.
- 2. Charges.—The charge for an Inland Telegraph Money Order is the cost of the telegram of advice calculated at the ordinary rates for telegrams and the usual Money Order Commission.
- 3. Private communication in Telegram of Advice.—The remitter may, on paying for the additional words required, have a short private communication added to the official telegram of advice. He may also, if he so desires, prepay the cost of a telegraphic reply to such communication.
- 4. Crossing of Order.—The remitter may give directions that the order shall be crossed for payment through a Bank, and may name the particular Bank through which he wishes payment to be made.
- 5. Express Charges.—If the order is to be delivered at the payee's address, and that address is beyond three miles from the Telegraph Office of Destination, the remitter should prepay the ordinary express charges for delivery of telegrams, otherwise the order will be delivered by post.
- 6. Limit of Amount.—No single Telegraph Money Order may be issued for more than Rs. 600, and may not include any sum less than Re 1.
- 7. Hours of Business.—The hours for the issue and payment of Telegraph Money Orders are the same as those for telegraph business, except that no Telegraph Money Order business is transacted between 9 P.M. and 7.A.M.
- 8. Payment subject to Possession of Funds.—Payment of a Telegraph Money Order is subject to the possession by the Office of Payment of sufficient funds for that purpose.
- 9. Application Form.—When a Telegraph Money Order is applied for, the remitter must fill up a Money Order Application Form, inserting the necessary particulars in the spaces provided.
- 10. Remitter to give Particulars.—The remitter must state on the form whether the order is to be delivered at the address of the payee or to be called for at the Office of Payment. In the former case, he must furnish a sufficient address of the payee to ensure delivery. In the latter case, the words "Post Office" should be inserted as the address, and the remitter should inform the payee of the despatch of the order and of the name of the Post Office at which he must apply for it, unless this is already known to the payee.
- a Bank, the words & Coy. and the name of the particular Bank, if it is to be telegraphed, must be written upon the application form.
- 12. Receipt for Order.—The remitter must hand the application form to the Counter Officer, together with the amounts for (1) the Money Order and Commission, (2) the telegram and express charges (if any). The Counter Clerk will fill up a printed receipt form, entering on it the number of the Money Order, sign it, impress the date stamp on it and hand it, to the remitter.
- 13. Payment.—The Money Order will be paid in the same manner, and subject to the same precautions, as in the case of an ordinary Money Order.
- 14. Verification of Name or Amount.—In the event of an application being made for payment of a Telegraph Money Order by a person giving a name not in agreement with the name of the remitter or payee as advised by telegraph, or asking for an amount differing from the sum telegraphed, he may send a paid service telegram of inquiry to the Issuing Office to verify the name or amount. Should there prove to be an error in the telegram of advice due to the fault of the Department, the sum paid for the service telegram will be refunded.
- 15. Direction for Crossing Orders.—A payee may direct that all his Telegraph Money Orders may be crossed at the Office of Payment in order to secure the communication of the remitter's name. This direction must be given in writing by the payee to the Postmaster of the Office of Payment.

- 16. Miscarriage of Advice of Telegram.—(a) Should any person allege that he is expecting a Telegraph Money Order and apply for payment, the Postmaster of the office at which the application is made may, if he holds no advice for such an order, send, at the request of that person, to the Postmaster of the alleged Office of Issue an ordinary telegram (not a service telegram) inquiring whether such a Telegraph Money Order has been issued. Such telegram of inquiry must give the names of the alleged remitter and payee and the amount of the order expected.
- (b) The cost of such a telegram of inquiry, with reply, must be paid for (at the ordinary rate) by the person making the application.
- (c) The amount so paid will be refunded should there appear to have been default on the part of any officer of the Department.
- 17. Alteration of Payee's Name.—The remitter of a Telegraph Money Order may apply for a correction of the name of the payee by telegraph on payment of the sum of 50 cents to be affixed in stamps to the telegram.
- 18. Stoppage of Payment.—The remitter of a Telegraph Money Order may apply to the Office of Issue for payment of the order to be stopped by telegram on payment of a fee of 50 cents. He must sign the telegram in full and the Department will do its best to stop payment, but will not be responsible if the telegram is too late to stop it.
- 19. Repayment.—Should the repayment of a Telegraph Money Order be required by the remitter, he must apply in writing to the Paying Office. If the order has not been paid, a new order will then be issued, less the ordinary commission, payable at any Money Order Office named for the purpose.
- 20. Transfer of Payment.—Should the remitter or payee require transfer of payment from one office to another, he must apply in writing to the Paying Office and send the order signed by him in the place provided A new order will then be issued, less the ordinary commission, payable at any Money Order Office named for the purpose.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended December 11, 1909.

Births.—The total births registered were 120 (2 Europeans, 14 Burghers, 62 Sinhalese, 17 Tamils, 17 Moors, 6 Malays, and 2 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1909, viz., 183,872) was 34.0, as against 34.6 in the preceding week, 25.2 in the corresponding week of last year, and 25.5 the weekly average for last year.

Deaths.—The total deaths registered were 109 (1 European, 8 Burghers, 61 Sinhalese, 26 Tamils, 12 Moors, 0 Malays, and 1 Other). The death-rate per 1,000 per annum was 30.9, as against 33.5 in the previous week, 47.6 in the corresponding week of last year, and 36.5 the weekly average for last year.

Infantile Deaths.—Of the 109 total deaths, 31 were of infants under one year of age, as against 29 in the preceding week, 44 in the corresponding week of the previous year, and 31 the average for last year.

Still Births.—The number of still births registered during the week was 8.

Selected Causes of Death .- As usual, the highest mortality was due to Pneumonia and Phthisis. Seventeen deaths were registered from Pneumonia (against 15 in the previous week and 12 the weekly average for last year), of which 4 each were in New Bazaar and Maradana Hospitals, 3 each in St. Sebastian and Kotahena, 2 in Maradana (exclusive of hospitals), and 1 in Slave Island. Five deaths were registered from Bronchitis.

- Eleven deaths were registered from Phthisis (against 12 in the previous week and 13 the weekly average for last year), of which 5 were in Maradana (exclusive of hospitals), 2 in Kollupitiya, and 1 each in Kotahena, New Bazaar, Maradana Hospitals, and Slave Island.
- Nine deaths were registered from Infantile Convulsions, 8 from Diarrhea, 5 Tetanus (including 4 infants), 4 Debility (2 infants), 4 Dysentery (1 infant), 4 Premature Birth, 3 Worms, 3 Cirrhosis of Liver, and 32 from Other Causes.
- Three deaths were registered from Enteric Fever as in the previous week (against 8 the weekly average for last year), of which 2 were in St. Paul's and 1 in Kotahena. 8 cases of Enteric Fever were reported, as in each of the previous two weeks.

5. One death was registered from Measles in New Bazaar. Five cases of Measles and 9 of Chickenpox

were reported in this week as in the last.

State of the Weather.—The mean temperature of air was $78 \cdot 3^{\circ}$, against $79 \cdot 5^{\circ}$ in the preceding week and $79 \cdot 9^{\circ}$ in the corresponding week of the previous year. The mean atmospheric pressure was $29 \cdot 946$ in., against 29.920 in. in the preceding week and 30.003 in. in the corresponding week of the previous year. The total rainfall in the week was 0.38 in., against 0.14 in. in the preceding week and nil in the corresponding week of the previous year.
