By His Excellency Sir HENRY EDWARD McCALLUM, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS certain by-laws contained in Chapters XI. and XIII. of the by-laws proclaimed on December 18, 1906, have been amended by the Municipal Council of Kandy, under the provisions of section 122 of the Municipal Councils' Ordinance, No. 7 of 1887, as amended by the Ordinance No. 8 of 1901, by substituting therefor or adding thereto the by-laws set out in the schedule hereto, and the said amended by-laws having under section 124 (1) of the first-named Ordinance been confirmed by the Governor, with the advice of the Executive Council, were published in two successive issues of the *Government Gazette*, namely, on February 18 and 25, 1910, in the English, Sinhalese, and Tamil languages, and laid before the Legislative Council :

And whereas the said amended by-laws were not objected to by the said Legislative Council within forty days after their being so laid before the said Council :

Now therefore know Ye that We, the said Governor, in exercise of the power in Us vested by sub-section (2) of section 124 of the first-named Ordinance, do hereby proclaim the said amended by-laws as set forth in the schedule hereto, and declare that the same shall come into force as from and after the date hereof.

Given at Nuwara Eliya, in the said Island of Ceylon, this Sixth day of June, in the year of our Lord One thousand Nine hundred and Ten.

SCHEDULE.
CHAPTER XI.

By-law No. 129.—By substituting the following by-law for the by-law as published :—

129. The owner or tenant of every stable, cattle stall, cattle halting place, or gala shall have the same covered with a tiled roof and paved with brick, stone, concrete, cement, or asphalt, and provided with suitable paved or cemented drains for conveying the urine and washings into a covered receptacle constructed in such manner as the Chairman shall direct, the contents of which shall be daily removed at the expense of such owner or tenant and disposed of so that no nuisance is caused thereby. Every such stable, cattle stall, halting place, or gala shall be daily washed, and always kept clean, and whitewashed at least once in three months.

By adding the following by-law after by-law No. 129 :—

129 A. The owner or occupier of any of the following places, viz., any livery or hack stable, horse lines, veterinary infirmary, cart stand, gala, cattle shed, or yard in which ten or more sheep or goats or five or more cattle are kept, shall once at least every day remove or cause to be removed all dung, manure, filth, urine, or other offensive or noxious matter produced in or upon the said premises, and shall cause the same to be deposited in such places as the Chairman shall from time to time direct. All such dung, manure, filth, urine, or other offensive or noxious matter produced in or upon such premises will be removed by the Municipal Council on application to the Chairman at such rates as may from time to time be fixed by him.

CHAPTER XIII.

By-law No. 207.—By substituting the following by-law for by-law as published :—

207. *Householders to deposit rubbish in proper receptacles.*—Any person who is desirous that ashes, sweepings, refuse, or other rubbish (other than refuse from premises where any trade is carried on) from his premises shall be removed by the scavengers of the Council, shall deposit the same in covered tubs, boxes, or other like receptacles of such shape and size as shall be approved in writing by the Chairman, on the curb stones or edge of footpaths outside his premises at such hours daily as the Chairman shall from time to time appoint by notice duly given; and shall remove the said tubs, boxes, or other like receptacles within half an hour after the emptying of such tubs, boxes, or other like receptacles by the scavengers. No person shall place any ashes, sweepings, refuse, or other rubbish on any street, except in covered tubs, boxes, or other receptacles as aforesaid, or except at such hours as aforesaid.

By adding the following by-law after by-law No. 207 :—

207 A. *Removal of trade refuse.*—Refuse from premises where any trade is carried on shall be removed by the Municipal Council on application to the Chairman at such rates as may from time to time be fixed by him.

By adding the following by-laws after by-law No. 209 :—

209 A. *Persons not to pluck plants or flowers in any public or recreation ground.*—No person using any public or recreation ground belonging to or in charge of the Municipal Council shall commit any nuisance therein, or pluck plants or flowers without the leave of the Chairman, or do any injury to the trees and shrubs in the ground.

209 B. *Picketing animals, &c., forbidden.*—No person shall picket animals or collect carts or form an encampment upon any public ground within the Municipality or on any ground or place belonging to or in charge of the Municipal Council without the written permission of the Chairman.

By adding the following by-law after by-law No. 213 :—

213 A. *Owner or occupier to repair, cut, or trim fences to a certain height.*—The Chairman may require the owner of any land or premises to surround such land or premises with boundary walls or good fences wherever they do not already exist, and where such walls or fences do exist the Chairman may require the owner, lessee, or occupier of such land or premises to put them into a state of proper repair, or to cut and trim the fences, or lower the boundary walls, so that they may not exceed such height from the base of the adjoining roadway as the Chairman may from time to time determine, or to cut and trim all trees which by overhanging any street are likely in the Chairman's opinion to obstruct or cause damage thereto. Written notice of any requirement under this by-law shall be served on the owner, lessee, or occupier, as the case may be, or posted to his address, and the owner, lessee, or occupier shall comply with the terms of the notice within such time as is mentioned therein, or such extension of it as the Chairman may allow.

By adding the following by-law after by-law No. 220 :—

220 A. *Hanging mats, &c.*—No person shall hang up or otherwise expose any mats, cloths, or other materials or substances on or at the side of any street.

By adding the following by-laws after by-law No. 221 A :—

221 B. *Public seats not to be misused or used by infected persons.*—No person shall lie down on or put either of his feet on any seat provided by the Municipal Council in any public place or recreation ground.

221 C. No person suffering from any loathsome, infectious, or contagious disease shall sit on or make use of any seat provided by the Municipal Council in any public place or recreation ground.

221 D. *Dirt, rubbish, &c., not to be thrown into the lake.*—No person shall throw cause, or suffer to be thrown any dirt, rubbish, filth, or other noisome or offensive matter or thing into the Kandy lake, or into any stream or waterway leading into the lake.

221 E. *Sand, &c., not to be removed from the lake.*—No person shall remove sand from the Kandy lake without the written permission of the Chairman, or do any act that is likely to cause damage to the bund of the lake.

SCHEDULE.

CHAPTER XX.

Bakeries and Eating Houses.

297. (1) *License.*—No place shall be used as a bakery without an annual license from the Chairman.

(2) *Water connections.*—The person applying for an annual license shall before so doing cause or procure to be laid into the premises a water connection from the water main, and shall cause such connection and all fittings thereof to be kept in proper order and efficient action so as to provide for use on the premises a sufficient supply of water for the purpose of thoroughly washing and cleansing such premises.

298. (1) *Walls to be plastered, floor cemented, and drainage provided.*—Every bakery shall be well ventilated and well lighted, and the walls thereof impervious, plastered with lime mortar and whitewashed, the floor cemented, and drainage sufficiently provided. A ceiling shall be provided over the table on which the flour is kneaded.

(2) *No bakery to be within thirty feet of a cesspit or latrine.*—No part of a bakery shall be within thirty feet of any cesspit or latrine, nor in a position where bad odours wafted therefrom shall reach it.

299. *No bakery to be used for other purposes.*—No place used as a bakery shall be used for any other purpose whatsoever, or shall have internal communication with any part of a dwelling-house.

300. *Utensils to be kept clean.*—All utensils and other furniture shall be kept clean.

301. *Materials used to be wholesome.*—The flour, water, and other materials used in the manufacture of bread shall be good and wholesome. There shall be a separate storeroom for flour, and no flour shall be left lying on the floor in any part of the bakery.

302. (1) *Removal of refuse and flushing of drains.*—All refuse and dirt in and about the premises shall be swept off, and the drains well flushed, and the premises at all times maintained in a clean and tidy condition.

(2) *Persons suffering from contagious disease not to be employed.*—No person suffering from a contagious or loathsome disease, or who has recently been in attendance on such person, or who is unwashed or otherwise unclean, shall be employed in a bakery.

(3) *Kneaders to wear aprons.*—All kneaders of flour shall wear large clean aprons.

(4) *Precautions to protect bread, &c., from flies and dust.*—All reasonable precautions shall be taken to protect cakes, bread, and flour from flies and dust.

(5) *Definition of bakery.*—A bakery includes any building or part of a building used for any process connected with the baking of bread for sale.

(6) *Transport of bread.*—No person shall transport bread from any one place to any other place, except in a closed vehicle or a closed basket, tin, or other suitable receptacle. Every such vehicle, basket, tin, or other receptacle shall at all times be kept thoroughly clean and wholesome, and no person shall commit any act which may tend to render any bread which is being transported dirty or unwholesome.

303. (1) *Eating-houses.*—No person shall, after the passing of these by-laws, keep or manage an eating-house without giving information of that fact to the Chairman within seven days of his commencing to keep or manage such eating-house, and in the case of eating-houses already existing at the time these by-laws come into operation within thirty days of the coming into operation of these by-laws. Any person who shall appear, act, or behave as the person in charge of an eating-house shall be deemed and taken to be the keeper or manager thereof.

(2) The provisions of by-laws 298, 300, 302 (1), and 302 (2) shall apply to eating-houses. An eating-house includes any house or place where cooked rice is kept for sale, other than a house for which a license has been obtained under "The Licensing Ordinance, 1891."

304. *Bakery to be subject to examination.*—Every bakery and the management and the conduct of the business shall be always open and subject to examination by the Chairman of the Municipal Council, the Health Officer, and all persons acting under the authority of the said Chairman.

WHEREAS by a Proclamation dated December 29, 1868, certain rules made by the proprietors of lands situated in Nuwarakalawiya district of the North-Central Province, under the provisions of "The Paddy Cultivation Ordinance, 1867," and approved by the Governor in Executive Council, were duly published:

And whereas at public meetings called by the Government Agent, North-Central Province, in the subdivisions of Nuwaragam korale, Eppawala korale, and Kalagam Korale North, in the said district of Nuwarakalawiya, in pursuance of section 21 of Ordinance No. 16 of 1906, rule No. 13 of the said rules was amended in the manner set forth in the schedule hereto, and the said amended rule was duly transmitted by the said Government Agent to His Excellency the Governor, in terms of the said section for approval or disallowance thereof:

Now know Ye that We, the said Governor, in exercise of the powers in Us vested by the said section 21, and with the advice aforesaid, do by this Our Proclamation give notice of Our approval of the said rule being amended as aforesaid.

And We do in all other respects confirm the said Proclamation.

SCHEDULE.

By adding the following proviso to rule No. 13 of the rules published by the said Proclamation dated December 29, 1868:—

Provided that if in the opinion of the Government Agent it is advisable to limit the cultivation seasons to enable the water to be reasonably and properly distributed to the best advantage of the general community and to ensure its being utilized to the full, he shall have power to alter the dates as seem to him to be reasonable.

SCHEDULE A.

BY-LAWS.

1. The proper authority may from time to time appoint and remove Inspectors of Carriages and Coaches, and it shall be the duty of such Inspectors to report to the proper authority on the condition of carriages and coaches plying on the lines of road for which they are appointed. The Inspectors' reports shall be forwarded at such time as the proper authority may appoint, and the proper authority may call for a special report at any time.
2. The report of an Inspector of Carriages and Coaches shall include a distinct reference to the number painted on the carriage or coach; a description of the condition of the carriage or coach; the condition of the horses or other animals used for drawing the carriage or coach; the height (approximately) of the horse or horses; the condition of the harness; the condition of the notifications to the public which, under these by-laws, should be apparent and legible on such carriage or coach.
3. It shall be lawful for an Inspector so appointed within his jurisdiction to enter upon any premises used as carriage or coach stables in any town, or along any lines of road on which carriages or coaches are licensed to ply, and to call upon the person in charge of such stables to produce for his inspection the license for such carriages or coaches as may be there, and the horses and harness kept in such stables for the use of the same, and any persons in charge of such stables not giving such Inspector all reasonable assistance at such inspection shall be guilty of an offence.
4. No carriage or coach shall be licensed under the provisions of "The Vehicles Ordinance, 1901," unless an Inspector has first certified that it is in all respects fit and safe to be used for passengers, and that the requirements of the said Ordinance and of these by-laws have been complied with.
5. The Inspector shall, when furnishing such certificate, specify the number of passengers which such carriage or coach should be permitted to carry.
6. It shall be the duty of every owner of a carriage or coach, before applying for a certificate, to notify his intention of doing so to the proper authority, who shall enter the name of the applicant and the number assigned to him in a register, and return to the applicant his notification, having endorsed thereon in letters and figures the number which the vehicle is to bear. This endorsement shall be signed by some one authorized by the proper authority.
7. Before a carriage or coach is produced to the Inspector to be inspected with a view to obtaining a certificate, such carriage or coach shall be conspicuously marked with the number (which shall be one of a progressive series) obtained from the proper authority in the manner laid down in rule 6 above. This number shall be not less than 4 inches in diameter, and shall be painted on each of the two sides of the carriage or coach, and no two carriages or coaches licensed by the same authority shall bear the same number.
8. A copy of the license issued by the proper authority properly framed and glazed to protect the same from the weather shall be fixed in a conspicuous place on each carriage or coach.
9. A notice stating the number of passengers (including the driver and other attendants) which the carriage or coach is licensed to carry shall be exposed in a conspicuous part of each carriage or coach. This notice shall be kept clean and legible, being renewed from time to time if necessary. No carriage or coach shall carry a greater number of persons than is permitted by the license, nor shall the driver at any time refuse to carry the full number of passengers.
10. When an Inspector refuses to grant the certificate mentioned in by-law No. 4, he shall report in writing to the proper authority his reason for such refusal, and shall at the same time furnish the applicant with a copy of his report, so as to enable the applicant to make good the deficiencies on account of which the certificate was refused.
11. No owner of any licensed carriage or coach shall use or allow to be used any animal for drawing the same, or any harness or other apparatus in connection therewith, unless such animal, apparatus, or harness shall be in a fit condition to be so

used, regard being had to the safety of the passengers and the humane treatment of the animal.

12. Both the proprietors and the drivers of vehicles shall be responsible when the horses or equipment of their carriages or coaches are deficient in terms of these by-laws, when passengers in excess of the number allowed by the license are carried in any carriage or coach, when animals unfit to draw carriages or coaches are used, or when animals attached to a carriage or coach driven by them are cruelly treated. Any person who enters a carriage or coach which already contains the full number of persons such carriage or coach is licensed to carry, shall be guilty of a breach of these by-laws, and shall be punishable accordingly.

13. The proper authority shall require proof of the efficiency of all drivers of licensed vehicles. On such proof being furnished to his satisfaction he shall issue a license to such driver, and shall register such license in a book to be kept for that purpose. No one but a licensed driver shall drive or be in charge of any licensed vehicle.

14. It shall be the duty of every Inspector to file a prosecution against both the driver and the proprietor of any carriage or coach for any offence or breach of these by-laws coming under this notice, and to prosecute such charge to final judgment.

15. Both the proprietor and the driver shall be held to have committed an offence if any number, notice, or writing required by these by-laws to be exhibited in any part of any carriage or coach is obliterated, removed, or altered.

16. Each passenger travelling by a licensed coach shall be permitted to carry luggage not exceeding 28 lb. in weight, and in all cases in which any excess above 28 lb. of luggage for each passenger is carried there shall be fewer passengers carried in proportion of one passenger for each hundredweight of excess luggage. Bags of grain or other goods shall not in any case be carried by a licensed coach except on the conditions last afore-mentioned.

17. It shall be the duty of all proprietors of coaches to register at the office of the proper authority their agents at the various coach offices on the line, and to register all their coach drivers, giving the names and addresses of such agents or coach drivers in full.

18. No motor car or other vehicle propelled by steam, electricity, or other motive power shall be driven at a pace which, having regard to the traffic and other conditions of the place where it is driven, is dangerous to the public. Nor shall any person drive such a vehicle unless he holds a certificate of competency from the proper authority.

19. The proper authority shall classify all licensed vehicles other than coaches, carts, hackeries, and jinrickshaws into first and second class vehicles, and shall determine with regard to each vehicle the number of passengers which it may carry. The proper authority shall cause to be entered on the license for each vehicle the class to which it belongs and the number of passengers which it is licensed to carry.

20. The class of each licensed carriage and the number of persons which it is licensed to carry shall be painted in a conspicuous part on the outside of such carriage, and shall at all times be plainly and distinctly visible and legible.

21. The owner or driver of any carriage licensed for hire shall not permit the same to ply for hire (except as hereinafter provided) but from an appointed stand.

22. A public stand for licensed carriages shall be appointed at the following place:—The Panadura Railway Station.

23. When such public stand shall be appointed, the proper authority shall cause due notice thereof to be given in such public manner as to him may seem fit that the same will be opened for public use on a date to be fixed in the said notice, and no carriage licensed for hire shall ply for hire from that date except from such stand, or from the owner's residence or place of business.

24. After every fourth carriage in every stand, there shall be left a space of at least 8 feet for passengers on foot to pass through.

25. Every carriage on its arrival at any public stand shall be drawn to the end of and be the last of the rank of any carriages already occupying such stand, and all carriages shall be arranged only in single rank.

26. All licensed carriages plying for hire (unless previously engaged or as hereinafter excepted) shall be driven up to the public stand at 6.30 A.M., and shall stand for hire till 7 P.M., except during a reasonable interval for rest, and the driver of every licensed carriage used for the conveyance of passengers shall remain in charge of it so long as it is drawn up at any stand.

27. Rates and fares for goods and passengers as well for time as distance shall be chargeable according to the following scale, which shall be legibly printed or inscribed on a card or plate and affixed inside in some conspicuous part of every licensed carriage plying for hire during all the time the carriage shall ply or be used for hire.

The rates as for a first or second class carriage drawn by a horse to be increased respectively by one-half.

Rates chargeable between 7.30 P.M. and 6 A.M. to be one-third more than the above charges.

28. The owner or driver of any licensed carriage shall be bound and compelled at all times to let their carriages for hire, whether the same be on the stand or at the residence or place of business of the owner, to any person applying for the same, unless the carriage, or the harness, or the horse used in drawing the same shall be unfit for use, or unless he has some other like reasonable cause for refusing; provided, however, that any person applying for a carriage shall, upon demand made, immediately and before the carriage is used pay to the owner or driver the fare authorized by law. Provided, however, that no horse drawing any such carriage shall be compelled to travel more than twelve miles between 6.30 A.M. and 7 P.M.

29. No licensed carriage which is unsafe or in bad repair or otherwise unfit for the accommodation and convenience of passengers shall be used or admitted into any public stand, and no horse shall be used in any licensed carriage unless the same shall have been inspected by the Inspector, or certified by him to be fit to be used in such carriage.

30. No driver of any licensed carriage shall suffer the same to stand or loiter in any street, or alongside of any other carriage, except for the purpose of setting down or taking up any passengers, nor shall he obstruct the driver of any other carriage in taking up or setting down any person, or wilfully prevent or endeavour to prevent the driver of any other licensed carriage from taking a fare.

31. No carriage which shall be let for hire on special agreement shall be subject to the operation of these by-laws during the term of such engagement.

32. Every driver of a licensed carriage shall wear a jacket or coat, and shall carry a badge, such badge to be provided by the proper authority, and to bear the number of the driver's license.

33. The proprietor shall be guilty of an offence if any of the following portions of the equipment of a carriage or coach for which an Inspector's certificate has been obtained is placed on another carriage or coach with a view of obtaining a certificate therefor, viz. :—

The lamps.	The cushions.
The glazed copy of the license.	The tent or covering.

34. No person shall leave or permit to be left on any public road or street any licensed vehicle without the oxen, horses, or other animals being yoked or harnessed thereto, unless such vehicle shall have accidentally broken down there, and in case of such accident, for a longer time than may be necessary for its removal. This rule will not be enforced until proper halting places are established.

35. In case of any property being left in any licensed vehicle by any person who may have hired or been carried in the same, the owner or driver of such vehicle shall, within twelve hours after such property shall have been found in such vehicle, take the same or cause it to be taken, in the state in which it was found, to the nearest Police Station, to be there deposited for reclamation; and the owner or driver delivering such property or causing the same to be delivered shall be entitled to a remuneration of 25 cents payable by the owner of such property (if the same does not consist of jewellery) before the same is allowed to be removed. If, however, the property found consist of jewellery, the owner thereof shall pay to the owner or driver a fee or remuneration of Re. 1.

If the property so found in any such vehicle and deposited in the nearest Police Station shall not be claimed by the true owner thereof within one month of such deposit, the said property shall be sold by public auction, after due notice of such intended sale in one or more of the local papers, and the proceeds of such sale, less expenses incurred in and about the publication of such sale, shall go to the general revenue.

6. A candidate before being admitted as an apprentice will be required to enter into an agreement to diligently serve as an apprentice for five years, obey all lawful orders of the Director of Public Works or any officer of the Public Works Department under whom he may be ordered by the Director of Public Works to serve, to keep all lawful secrets, and not to correspond directly or indirectly in the public press.
7. BY-LAW REFERRED TO.
CHAPTER XV.

248 A. The driver of every cart the body of which is not supported on springs shall while driving keep the cart as near as possible to the left-hand edge of the road in the direction in which the cart is proceeding. He shall not drive his bullock or bullocks at a greater pace than a walk, and shall not pass or attempt to pass any similar cart proceeding in the same direction as his own cart, unless that similar cart is halted. He shall not halt his cart at right angles to the road.

Rules prescribing Form of Application for License.

1. Every application for a license to supply energy for electric lighting, power, and traction, or to the public for any purpose, shall be made in writing to the Colonial Secretary, or in the cases of application for licenses under section 5 (1) (b) of the above-named Ordinance to the Chairman of the Municipal Council.

2. Every application shall be signed by the applicant or applicants, and shall contain the following particulars:—

- (a) The name, address, and description of the applicants.
- (b) A description of the premises or lands which the applicant proposes to use for the purpose of the license.
- (c) The amount of capital the applicant proposes to expend for the purpose of the license.
- (d) The purpose for which the energy is to be supplied.
- (e) If the energy is to be supplied for electric traction, a description of the type of vehicles to be used, the gauge, type of rail, overhead equipment, controllers (guards, &c.), with drawings and proposed charges.
- (f) Plans and description of the works and the system of supply.
- (g) Whether the generating station is to be within or without the area of supply.
- (h) A list of the powers and facilities required to break up public or private streets or roads, or to cross railways or tramways.
- (i) The pressure of generation, distribution, and supply to consumers, and method of conversion, if any.
- (j) Whether continuous or alternating current phase and frequency.
- (k) A description of the system of distribution, and if it is proposed to earth any part of the system.
- (l) Whether the mains, distributing mains, and services are to be underground or overhead, and the method of construction.
- (m) The system of charges to be adopted and price to be charged for energy to consumers.

3. Every such license shall be in such form and shall comprise such conditions as the Governor in Executive Council shall in each case prescribe, and shall state the purpose for which the energy is intended to be used, and the conditions subject to which this license is granted.

4. Stamp duty of Rs. 50 shall be charged in respect of each license.

THE following regulations for admission of students for training in the Survey Class at the Government Technical Schools are published for general information.

• Regulations for Admission to the Survey Department Training Class. •

A.—FOR APPOINTMENTS IN THE DEPARTMENT.

Admission.—Candidates will be admitted on application to the Surveyor-General, supported by school certificates, accompanied by a specimen of their draughtsmanship, and a certificate of good character. They must first serve as volunteers at the Head Office or outstation offices until proficient in drawing, when they will be selected for the Training Class, after passing the Pieceworkers' Examination, which will be held once a quarter, in the following subjects:—

	Maximum obtainable.	Minimum.
Dictation	75	50
Essay	100	50
Arithmetic	100	50
Plan Drawing	100	50

No appointments to the field will be made except through the Training Class.

Conditions for Admission.—A deposit of Rs. 100 must be made on admission, to be refunded at the end of training, less cost of lost stores or damages to instruments through wilful neglect or gross carelessness.

Candidates, on selection for the Training Class, will be required to enter into an agreement and bond to serve, on the completion of their training, for a period of three years as supernumerary surveyors.

Payment of Students.—Candidates whose progress after one month at the Training Class is such as to make them suitable for further training will receive Rs. 15 a month while in Colombo, and Rs. 30 a month while completing their training at Diyatalawa, on condition that their progress is satisfactory; and those who are rejected as surveyors while in the Training Class may be allowed to revert to the Head Office or outstation offices, and will in such cases be paid as pieceworkers.

Course at Diyatalawa.—After completing the course of instruction in Colombo, such students as are proficient will be sent to Diyatalawa for a month or more for further practical training.

Appointments to the Field.—They will receive appointments as soon as they are reported fit to take up duty in the field. Those for whom there may be no vacancies at the time will be employed as pieceworkers in one of the offices until vacancies occur.

Pay and Conditions as Supernumerary Surveyors.—From the date of their appointment they will receive pay at the rate of Rs. 2 a day, and will be refunded the actual expenses of the journey from Colombo to their first station. They will enter upon their duties in any part of the Island in which they may be called upon to serve. They will be on probation for two years, and liable to dismissal by the Surveyor-General during that time. At the expiration of the second year, if the surveyors are reported by their immediate superior to the Surveyor-General as efficient, they will be transferred to a separate grade to be termed "Supernumerary Surveyor. Survey School Grade," and draw an extra 50 cents a day, and after serving one year in this grade they will draw a further 50 cents a day or a total of Re. 1, provided always that they continue to give satisfaction to the Surveyor-General in the discharge of the duties entrusted to them. The drawing of the extra rate of 50 cents and Re. 1 will be dependent on the approval of the Surveyor-General, and may be stopped by him for unsatisfactory work or behaviour, the period of such stoppage to be deducted from the period served on that rate.

2. On receiving the rate of Rs. 3 a day, they will be entitled to enter for the Departmental Junior Examination, the syllabus of which is as follows:—

- (1) English Composition.
- (2) Arithmetic.
- (3) Elementary Geometry.
- (4) Mensuration.
- (5) Surveying and Levelling (paper and report by officers under whom the candidates has worked).
- (6) Elementary Trigonometry.
- (7) Adjustments of Theodolite and Level (paper and practically).
- (8) Drawing: Plan and Freehand.
- (9) Standing Orders.

All subjects are compulsory.

3. All students who pass the Survey Department Junior Examination will rank for promotion to the third grade on the establishment with the present members of the Department according to date of passing the examination, i.e., seniority for appointment to the third grade will date from the date of passing the examination irrespective of whether the officer came originally from the Training Class or not, all else being equal, but the Surveyor-General reserves the right to make recommendations to Government for the appointment to the third grade of any specially selected officer who shall have proved himself to possess qualifications superior to those possessed by officers who have passed the examination on prior dates.

4. Any student who has served the full three-year course in the Department of Civil Engineering at the Technical College, and has gained a certificate in accordance with the regulations of that Department of the College, shall, if he applies on leaving the College for admission to the Survey Department, be entitled, if selected, to draw Rs. 3 a day for two years on probation, subject to the rule governing the Supernumerary Surveyors' Class, and if at the end of that time he shall have given satisfaction to the Surveyor-General in the discharge of the duties entrusted to him, he will be classified as Supernumerary Surveyor, Survey School Grade, and may enter the next Departmental Junior Examination.

5. No student of the Survey School or person at present in the employ of the Survey Department shall lose seniority (except as provided in paragraph 3) provided he qualifies for promotion to the third grade within six years from the date of his entry into the Department.

6. On the occurrence of vacancies in the supernumerary grade of the Survey Department, preference will be given to selected or passed students of the Survey School as provided above, but if there are no candidates available or suitable at the time, the Surveyor-General may make a selection from outside candidates.

7. From the date of appointment to the third grade all officers, whether from the Survey School or elsewhere, must conform to the Standing Orders of the Department regarding further promotion. After being promoted to the second grade, an officer is entitled to enter for the Senior Examination, and after passing this, he shall, if he is found to possess the requisite administrative abilities, be eligible for promotion to the rank of Assistant Superintendent of Surveys with salary commencing at £300 a year, and rising by yearly increments of £25 to £350.

8. Nothing in the foregoing rules is to act prejudicially to the interest of those who have already been trained by officers of the Department on the approval of the Surveyor-General, or who have passed such tests as they may have been put to and already registered as suitable for an appointment.

Conditions for the Surveyor's License.—A supernumerary surveyor who has served for more than ten years will be entitled to a license under Ordinance No. 26 of 1909, provided he is the holder of a certificate of competency in land surveying issued by the Surveyor-General.

B.—FOR THE SURVEYOR-GENERAL'S LICENSE.

(Course, One Year).

The Entrance Examination will be held by such officers of the Survey Department and on such dates as shall be duly authorized by His Excellency the Governor, and will be as follows :—

Handwriting, Orthography, Composition, Arithmetic, Geometry (first book of Euclid), Algebra (up to and including Quadratic Equations), Plane Trigonometry (Elementary), Geography, and Drawing.

Candidates who hold certificates of having passed the Senior Cambridge or other examination of similar standing, or have matriculated at the London University or other similar institution from time to time approved by His Excellency the Governor, will be exempted from this examination in all subjects, if their certificates show that they have passed in Mathematics.

The syllabus of the course will be as follows :—

Fieldwork.—Chain surveying, theodolite surveying, and levelling, including adjustments of the theodolite and level, laying out curves.

Drawing.—Setting out, plotting, drawing up, computing, and making a report on a survey.

The course will include also mathematics and mensuration, and classes on the theory of surveying and levelling up to the limits required for the Surveyor-General's examination for the Government license for surveying and levelling.

Fees.

The fees will be Rs. 100 paid in advance for the one-year course, but if a candidate then fails to obtain a license, he may continue his training for another six months on payment of a further fee of Rs. 50, and in addition a deposit of Rs. 100 will be made on admission, to be returned to the student on leaving the College, less estimated value of any damage done to instruments or other property of Government.

Students who have obtained the Surveyor-General's license in surveying and levelling will be admitted to appointments in the Survey Department if they desire to do so on the same terms as those who have been trained under Regulations A.

The number of students to be admitted to Class A will be limited to the probable requirements of the Survey Department, while those for Class B will be limited to ten.

Schedule of Instruments, Tools, and Books which each Student is required to possess.

Annual licenses will be granted in "Surveying and Levelling," "Surveying" only, or "Levelling" only, to those who pass the final examination for those purposes by the Surveyor-General.

The above class will be held in connection with the Survey Department Training Class, and students for the Surveyor-General's license will be required to complete their field training at their own cost under such officers of the Department and at such stations as may be approved by the Surveyor-General.

All students of the class will be under the authority of the Surveyor-General. They will be expected to attend the class at the times and dates laid down for the Survey Department Training Class, and the Surveyor-General is authorized to dismiss them from the class for irregular attendance, bad conduct, or insufficient progress in their studies.

The rules for the examination of licensed surveyors are herewith annexed :—

1. *Examiners, date, and place of examination.*—The examiners shall be one or more officers of the Survey Department appointed annually by the Surveyor-General.

2. The examination shall be held during the first quarter of each year. A notice of the time and place at which the examination will be held shall be published one month beforehand in the *Government Gazette*.

3. *Subjects of examination.*—The examination shall comprise the following subjects :—

Mathematics.—Algebra up to quadratic equations, plane trigonometry, and the mensuration of surfaces and solids.

Drawing.—Setting out, plotting, tracing, and office work, including a report on a survey.

Field work.—Chain surveying, theodolite surveying, and levelling, including the adjustments of the theodolite and level and setting out curves.

4. (a) Any candidate found referring to notes or books or to be in communication with a surveyor whilst under examination shall be debarred from proceeding with it and considered to have failed in all subjects.

(b) Candidates shall produce instruments in good order, and no excuse will be admitted on account of defective instruments during examination.

(c) No candidate shall be allowed to compete who presents himself ten minutes after the appointed time.

(d) *Adjustments.*—Forty minutes shall be allowed for the correct adjustment of each instrument.

(e) The maximum collimation error allowed shall be 0.01 foot at two chains.

(f) Candidates who fail in adjustments shall be debarred from taking further part in the examination.

(g) *Field work.*—During the progress of field work, the examiner shall inspect the candidates on the ground.

(h) Candidates shall be expected to be at work in the field between the hours fixed by the examiner.

(i) Field and level books should be kept clearly and *in ink* or the work will not be accepted. Each page must be numbered, paged, and dated, and full reference properly made. *No erasures shall be allowed.* Mistakes should be corrected so that the original figures are plainly visible, and a short explanation written opposite the correction. Level books must be clearly referenced and properly reduced.

(j) Field and level books must be new, and must bear the name of the candidate neatly printed on the outside of the cover.

The field book must contain—

- (a) The record of the survey.
- (b) Report on the same.
- (c) Co-ordinates.
- (d) Computation of areas.

The level book must contain—

- (a) Flying levels.
- (b) Longitudinal section.
- (c) Check levels.
- (d) Cross sections.
- (e) Computation of earthwork.

No loose sheets shall be accepted. All field and level books must be delivered to the person appointed to receive them after work is over for the day. They should be called for the next morning by the candidates at the time fixed by the examiner.

(k) *Surveying*.—The largest angular misclosure allowed shall be one minute per mile of traverse. The largest misclosure allowed in chainage shall be five links per mile.

(l) *Levelling*.—The largest misclosure allowed in levelling shall be 0.06 foot per mile.

(m) The closing readings must in all cases be taken only in the examiner's presence or of some person deputed by him.

(n) *Office work*.—Plans and sections must be accurately plotted. They should be neat and well drawn. All lines must be drawn with the drawing or ruling pen, crow-quills being used for lettering only. Survey plans must be plotted to the scale of one chain to an inch. Two working days shall be allowed for drawing up the plans. All plans must be dated and signed by the candidates.

(o) The areas computed on a plan must be distinctly shown by a narrow-coloured border.

(p) Candidates will be expected to plot their survey by co-ordinates. The stations should be numbered similarly in the field book and the co-ordinate sheet and carefully cross referenced.

5. (a) *Fees*.—The fees payable in advance for the examination shall be:—

For an examination in surveying only	Rs. 20
For an examination in levelling only	„ 15
For an examination in surveying and levelling	„ 35

(b) No candidate shall be allowed to take part in the examination unless he has paid the fees prescribed.

6. *Certificate of character*.—Before being admitted to the examination, candidates will be required to fill up the accompanying form and to furnish copies of their school certificate in support, and in addition to a certificate of good character from a Government Agent, Assistant Government Agent, District Judge, or Police Magistrate, and a receipt for the fees paid by them.

7. *List of license holders*.—A list showing separately the names of—

- (a) Surveyors duly certified under Ordinance No. 15 of 1889.
- (b) Persons holding permanent licenses in surveying.
- (c) Persons holding permanent licenses in levelling.
- (d) Persons holding permanent licenses in surveying and levelling.
- (e) Persons holding annual licenses in surveying.
- (f) Persons holding annual licenses in levelling.
- (g) Persons holding annual licenses in surveying and levelling.

(h) Persons holding annual and special licenses to carry out Crown surveys shall be published in the first week of February in each year in the *Government Gazette* for general information, and may be consulted at any time at the Surveyor-General's Office.

Supplementary lists of the names of those persons who being entitled to the annual license were not at the beginning of the year in possession of such license shall be published in the issue of the *Government Gazette* following its grant or renewal.

8. *List of suspended and cancelled licenses*.—The names of those persons whose registration or permanent license or both have been suspended or cancelled shall be published in the *Government Gazette* immediately after such suspension or cancellation has been communicated by the District Court to the Surveyor-General; and in the same manner the names of the holders of annual licenses which the Surveyor-General has refused to renew under section 8 shall be published in the *Government Gazette* within thirty days after his decision has been communicated to such holders.

University Scholarships.

The following amended regulations will apply to the examinations to be held in July, 1911:—

SCHOLARSHIP EXAMINATION.

Special Regulations for the University Scholarship in Arts.

No candidate will be eligible for the Scholarship awarded on the Intermediate Arts Examination who does not take up the two subjects, Latin and Greek.

Candidates for the University Scholarship in Arts will be allowed to take, in addition to their other papers, either two higher Classical papers, or two higher Mathematical papers. The aggregate maximum of marks allowed for these papers will be the same in each case as the maximum allowed for each of the sections of the Intermediate Examination in Arts. But a candidate's marks for any of these higher papers will only be counted if he obtains at least one-third of the maximum of marks assigned to it.

Special Regulations for the University Scholarship in Science.

Candidates for the University Scholarship in Science will be allowed to take, in addition to their other papers, the paper on Analytical Geometry, which is set as a higher paper for the candidates in Arts, under similar conditions with regard to marking. The marks assigned to this paper in the Science Examination will bear the same proportion to the aggregate maximum of marks as in the Arts Examination.

N.B.—Candidates for the University Scholarship in Science will, in addition to the papers prescribed for the Intermediate Examination in Science, be required to take English Literature and Essay, which form the last section of the Intermediate Examination in Arts.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended June 11, 1910.

Births.—The total births registered were 73 (4 Europeans, 8 Burghers, 40 Sinhalese, 10 Tamils, 8 Moors, 2 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1910, viz., 185,704) was 20.5, as against 29.8 in the preceding week, 23.8 in the corresponding week of last year, and 25.1 the weekly average for last year.

Deaths.—The total deaths registered were 103 (2 Europeans, 4 Burghers, 45 Sinhalese, 28 Tamils, 19 Moors, 3 Malays, and 2 Others), including the death of a town resident who died in the Enteric Hospital at Kanatta. The death-rate

per 1,000 per annum was 28·9, as against 34·0 in the previous week, 34·4 in the corresponding week of last year, and 33·7 the weekly average for last year.

Infantile Deaths.—Of the 103 total deaths, 30 were of infants under one year of age, as against 36 in the preceding week, 27 in the corresponding week of the previous year and the average for last year.

Still Births.—The number of still births registered during the week was 6.

Selected Causes of Death.—Twelve deaths were registered from *Pneumonia* (against 11 in the previous week and 15 the weekly average for last year), of which 4 were in Kotahena, 3 in Maradana hospitals, 2 in St. Paul's, and 1 each in New Bazaar, Maradana (exclusive of hospitals), and Kollupitiya. Seven deaths were registered from *Bronchitis*.

2. Eleven deaths were registered from *Phthisis* (against 17 in the previous week and 15 the weekly average for last year), of which 3 were in New Bazaar, 2 each in San Sebastian, Maradana hospitals, and Maradana (exclusive of hospitals), and 1 each in St. Paul's and Slave Island.

3. Ten deaths were registered from *Infantile Convulsions*, 8 from *Enteritis* (2 infants), 7 *Debility* (2 infants), 6 *Diarrhoea* (2 infants), 5 *Dysentery*, 3 *Starvation* (all infants), and 29 from *Other Causes*.

4. Five deaths were registered from *Enteric Fever*, as in the previous three weeks (against 6 the weekly average for last year), 4 in St. Paul's and 1 in Kotahena. There were 22 cases reported during the week, against 15 in the previous week.

5. One case of *Measles* was reported, against 5 in the previous week; and 20 of *Chickenpox*, against 22 in the previous week.

State of the Weather.—The mean temperature of air was 82·8°, against 84·5° in the preceding week and 82·2° in the corresponding week of the previous year. The mean atmospheric pressure was 29·881 in., against 29·878 in. in the preceding week and 29·892 in. in the corresponding week of the previous year. The total rainfall in the week was 1·72 in., against 0·32 in. in the preceding week and 0·29 in. in the corresponding week of the previous year.
