SEASON REPORTS FOR THE MONTH OF APRIL, 1910.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Paddy : the yala paddy plants are thriving fairly.

Dry grain : no cultivation worth reporting.

Other products : the supply of vegetables was fair, and prices were reasonable; but fruit was scarce and dear. The flowering and the general prospects of coconuts were not satisfactory during the month. The crop for the month is reported at 6,235,420 coconuts approximately.

Prices of staple products : rice, Rs. 4 to Rs. 6 a bushel ; coconuts, Rs. 50 to Rs. 70 a thousand.

Rainfall : there were a few showers of rain during the month.

Remarks on harvest prospects generally : a good yala harvest may be generally expected.

Observations on the health of the inhabitants : there were in some villages chickenpox and fever ; otherwise the health of the inhabitants was generally good.

Health of cattle: with the exception of a few cases of rinderpest and hoof-and-mouth disease, the health of the cattle was generally good.

Chenas: seeds sown in some chenas. Some being sown and some are ready for sowing.
