PROCLAMATION BY THE GOVERNOR.

In the Name of His Majesty GEORGE THE FIFTH, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir Henry Edward McCallum, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by section 1 of "The Opium Ordinance, 1910," it was enacted that the said Ordinance shall come into force on such date as the Governor shall, by Proclamation in the Government Gazette, appoint; and it was further enacted that different dates may be appointed for different purposes and provisions of the said Ordinance:

Now know Ye that We, the said Governor, in exercise of the powers in Us vested as aforesaid, do hereby proclaim and ordain that sections 11, 15, and 16 of the said Ordinance shall come into force from the date hereof.

Given at Kandy, in the said Island of Ceylon, this Twenty-eighth day of June, in the year of our Lord One thousand Nine hundred and Ten.

GOVERNMENT NOTIFICATIONS.

T is hereby notified, in pursuance of section 11 of the Opium Ordinance, No. 5 of 1910, that any person who desires to be supplied with opium for his own consumption must apply, not later than July 31, 1910, at the Kachcheri of his district or to the Chief Headman of his division, on a form which will be supplied for the purpose, to be registered as a consumer of opium.

2. It is further notified, in pursuance of section 15 of the above-named Ordinance, that any vedarala who is desirous of being registered under the said section must apply to the Kachcheri of his district, not later than July 31, 1910, on a form which will be supplied.

All persons who have applied in conformity with the notices dated March 1, 1910, respectively marked A and B, and published hereunder, will be considered to have made the applications required by law, and all registrations, whether of consumer or of vedarala, which have been or shall be made in pursuance of applications under the said notices will be considered to have been duly made for the purposes of the above-named Ordinance.

Notice A .- Notice to Consumers of Opium.

It is hereby notified that, in view of approaching changes in the law relating to opium, which will require that any adult person who desires to be supplied with opium for his own consumption shall be registered as a consumer of opium, and shall obtain from the Government Agent a certificate of such registration which will entitle him to obtain a specified quantity of opium from an authorized vendor appointed by the Governor, all adult persons desiring to be supplied with opium for their own consumption should apply, not later than March 31, 1910, at the Kachcheri of the district or to the Chief Headman of the division, to be registered as consumers of opium.

The applicant must adduce proof to the satisfaction of the Government Agent, or Assistant Government Agent, or

Chief Headman of the amount of opium which he is accustomed to consume, the place from which he has obtained such

oplum, and the manner and form of the use of it to which he is addicted.

Notice B .- Notice to Vedaralas.

*IT is hereby notified that, in view of approaching changes in the law relating to opium, which will require that any native medical practitioner who desires to be supplied with opium for use in his practice shall be registered as a vedurala, and shall obtain from the Government Agent a certificate of such registration which will entitle him to obtain a specified quantity of opium from an authorized vendor appointed by the Governor, all native medical practitioners desiring to be supplied with opium for use in their practice should apply, not later than March 31, 1910, at the Kachcheri of the district or to the Chief Headman of the division to be registered as vedaralas.

The applicant must adduce proof to the satisfaction of the Government Agent or Assistant Government Agent that he is of good character and repute, has gone through a sufficient course of training in native medical practice, has access to and is able to understand the standard books on native medicine, and has a bona fide practice extending beyond the

limits of the minor headman's division in which he resides.
