By-LAW REFERRED TO.

Should any sample of milk taken under the provisions of the preceding by-laws a context be adulterated, the person in whose possession it is found shall be guilty an offence. If such person be a vendor of, or a person in the employ of, or acting on behalf of, a dairyman, then both such person and the dairyman shall be guilty of an offence.

SCHEDULE REFERRED TO.

Additions and Amendments to Chapter VI. of the Kandy Municipal Council By-laws.

By substituting the following by-law for by-law 64 as published:

64. No person shall keep or sell in a public market any article or thing not specified in his license or ticket.

By adding the following by-laws after by-law 72:—

72 A. The occupant of any stall or space in a market shall not cause or allow any goods or articles to be deposited or exposed for sale in or upon such stall or space so that such goods or articles or any part thereof shall project beyond the line of such stall or

No stall holder, owner or occupier, or lessee of any market shall in any way obstruct or allow to be obstructed any of the lanes, walks, gangways, passages, or other thoroughfares within such market by exposing for sale or accumulating or allowing to be exposed for sale or accumulated in any such lane, walk, gangway, passage, or thoroughfare any package or any other materials whatever.

By substituting the following by-law for by-law 73 as published:

73. Every person holding a license or ticket for any stall or space in a public market shall keep on or near such stall or space a receptacle, to be approved by the Chairman, in which such person shall deposit all rubbish and refuse matter.

By substituting the following by-law for by-law 82 (e) as published:-

82 (e) To behave in a disorderly manner, or beg or commit any nuisance in any public market or the premises appertaining

By substituting the following by-law for by-law 82 (h) as

82 (h) Being a person affected with any loathsome or contagious or infectious disease to occupy any stall, seat, or space in any public or private market, or expose or carry about for sale in such market, or in any street within the Municipality any article what-Sever. And no person shall employ in any capacity in any public or private market any person affected with any such disease, nor shall any person so affected enter any market. Any such person may be expelled from the market premises.

By adding the following by-laws after by-law 88:-

Every tenant, occupier, or servant of a tenant or occupier of any building or stall in the market shall extinguish or cause to be extinguished every fire or light in such building or stall before leaving it, and no fire or light shall be permitted which is dangerous to the safety of the building or stall.

No person suffering from infectious diseases to occupy market stall, or spacé.

88 B. The market-keeper of any other officer authorized by the Chairman may expel from the market premises any person who is found drunk or begging or loitering, or who misconducts himself, or is a lunatic; and if such person is a tenant or a tenant's servant may (subject to the approprial of the Chairman) prevent him from further carrying on any trade or business in the market, or occupying any shop or stall therein.

A vendor guilty of assault may be expelled from the market and prevented from further carrying on any trade or business, or occupying any shop or stall in the market.

CHAPTER XV.

Carriages.

25. The driver of every cart, the body of which is not supported on spring, shall while driving keep the cart as near as possible to the left-hand edge of the road in the direction in which the cart is proceeding. He shall not drive his bullock or bullocks at a greater pace than a walk, and shall not pass or attempt to pass any similar cart proceeding in the same direction as his own cart, unless that similar cart is halted. He shall not halt his cart across the road.

SCHEDULE. CHAPTER VI.

Establishment and Regulation of Markets.

28. No private market shall, except with the license of the Chairman, be established, or, if already established, be used within the Municipality in future without such license.

29. No person shall sell or expose for sale in any place, private market, or street within the Municipality any fruits without a license from the Council or contrary to the tenor of such license:

SCHEDULE.

CHAPTER XX. B.

Regulation of Street Traffic.

- 1. Any person who stands or loiters in any street, after having been ordered by any police officer to move on, shall be guilty of an offence punishable with a fine not exceeding Rs. 10.
- 2. Every person driving or drawing a licensed vehicle when disengaged or not carrying a fare shall keep to extreme left-hand edge of the street, leaving the middle of the left of the street for fast moving traffic.
- 3. No person shall cause or permit the emission of smoke or visible vapour from a mechanically propelled vehicle in such quantity so as to be a nuisance or to cause annoyance or danger to the public.
- 4. Any person found keeping a licensed vehicle in any public stand in excess of the authorized number of vehicles in such stand and refusing to withdraw the same when ordered to do so by a police officer shall be guilty of an offence punishable with a fine not exceeding Rs. 10. (For the purpose of this section, vehicles found in excess after counting the authorized number from the egress end of the stand shall be deemed to be in excess.)
- 5. The penalty for the contravention of the 2nd and 3rd by-laws shall be a fine not exceeding Rs. 20.

WHEREAS the District School Committee of Batticaloa have, in exercise of the power vested in them by section 19 of the Rural Schools Ordinance, No. 8 of 1907, made the by-laws set forth in the schedule hereto for the School District of Batticaloa, Eastern Province:

Now know Ye that We, the Governor of Ceylon, in exercise of the power vested in Us by sub-section (2) of section 20 of the said Ordinance, and with the advice of the Executive Council, do hereby confirm the by-laws set forth in the said schedule.

And We do hereby proclaim and declare that they shall come into operation from the date hereof.

Given at Colombo, in the said Island of Ceylon, this Thirteenth day of December, in the year of our Lord One thousand Nine hundred and Ten.

SCHEDULE.

By-laws made under Sections 19 and 20 of " The Rural Schools Ordinance. 1907," /or the Area described in the Schedule A hereto annexed by the District School Committee of Batticaloa.

In these by-laws-

The term "boy" means a boy residing in the area described in the schedule hereto.

parent" includes a guardian and any person who has the actual The term "

custody of the boy. The term "Code" means the Code for Aided Schools for the time being sanctioned by His Excellency the Governor in Executive Council.

The term "attendance" means an attendance for the period defined by the Code as constituting a full attendance recorded in an attendance register in the manner prescribed by the Code.

The term "local authority" means the District School Committee of Batticaloa.

The term "school" means a school specified in the Schedule B hereto.

The terms "adequate and suitable provision for the education of a child" and "reasonable excuse" shall bear the meaning defined in section 20 (1) (b) of "The Rural Schools Ordinance, 1907."

The term "Inspector of Schools" means an Inspector of Schools appointed by His Excellency the Governor.

The parent of every boy of not less than 6 nor more than 12 years of age shall cause such boy to attend one of the schools specified in Schdeule B, unless he has made other adequate and suitable provision for the education of such boy, or unless there is a reasonable excuse for non-attendance. Provided that no boy is required to attend school from a distance exceeding two miles.

The time during which every boy shall attend school shall be the whole time

for which the school shall be open for the education of boys of similar age.

4. Provided always that nothing in these by-laws-

(a) Shall prevent the presence of any boys being excused during the hours when religious instruction is given as provided by section 21 (d) of "The Rural Schools Ordinance, 1907."

(b) Shall require any boy to attend school on any day exclusively set apart for religious observance by the religious body to which his parent belongs.

And provided always that when a boy between 10 and 12 years of age, being beneficially employed to the satisfaction of the District School Committee, has received a certificate from an Inspector of Schools that he has passed in Reading, Writing, and Arithmetic, the examination prescribed for the third standard under Schedule D in the Second Class Upper Division, he shall not be required to attend school.

6. Every parent who shall not observe or shall neglect or violate these by-laws or any of them shall, upon conviction, be liable to a penalty not exceeding Rs. 20 for each offence, and an additional fine not exceeding Rs. 10 per day in the case of * continuing offence.

NOTE.—The following are the portions of the Rural Schools Ordinance referred to in sections 1 and 4 of these by-laws:-

Section 20 (1) (b).—A parent shall be deemed to have made adequate and suitable provision for the education of his child if he proves that his child is in regular attendance at a school registered by the Director of Public Instruction for the receipt of a grant in aid, or at a school with regard to which an application for a grant in aid is under consideration, or at a school certified by the Director of Public Instruction to provide adequate and suitable instruction; or if he proves that he has made such other provision for his child's education as the Director of Public Instruction shall certify to be adequate and suitable, or if he produces a certificate from the Director of Public Instruction recommending that the child shall be exempted from compulsory attendance. Provided that no parent shall be convicted for not causing his child to attend such school; if he proves to the satisfaction of the court that he has reasonable excuse for not causing such child to attend. A parent shall be deemed to have a reasonable excuse for not causing his child to attend school, if he proves that the child is prevented from attending by sickness or other unavoidable cause.

Section 21.—No school in which religious instruction is given shall be considered a public vernacular school unless the District Committee is satisfied-

(a) That religious instruction is given only during the times specified in the school time table;

(b) That religious instruction is not given to pupils of other denominations than that to which the school belongs if the parents object;

(v) That pupils who do not attend religious instruction are employed in other studies during the hours allotted to religious instruction;

(d) That such pupils, if their parents object to their being present in the room where religious instruction is given, are either allowed to study in some other part of the school premises during the hours when such instruction is given, or their presence in the school during such hours is excused; and

(e) That a copy of this section in the English, Sinhalese, and Tamil languages is conticuously posted up in the school.

The above by laws were made by the District School Committee of Batticaloa at a meeting held at the Batticaloa Kachcheri on February 15, 1910.

CEYLON GOVERNMENT ENGINEERING SCHOLARSHIPS.

N examination will be held by the Ceylon Government in March, 1911, for the award of Scholarships to be · held in the Upper Subordinate Class in Engineering at the Madras Engineering College.

If candidates of sufficient merit present themselves there will be awarded three Scholarships, which will under certain conditions lead to appointment in the Ceylon Irrigation Department.

The Scholarships will entitle the holders to the following allowances for the three years of their course in the Upper Subordinate Class:—A subsistence allowance of Rs. 30 per mensem, and an outfit and travelling allowance at the rate of Rs. 200 per annum paid half-yearly. Fees and deposits required for the classes will be paid by the Government. Those who pass the College final examination at the end of the three years' course will receive the same subsistence allowance for an additional year, during which they will be employed on works in India. They will also during this additional year receive the same travelling allowances as are drawn by the Indian students under the same circumstances. All allowances will be contingent on the good conduct and satisfactory progress of the student.

- The three scholars will, if they receive a certificate of good conduct and sati-factory progress during the year spent on works, be offered appointments as Irrigation Sub-Inspectors Second Class, and will be eligible for appoint ments to the higher grades of the Irrigation Subordinate Staff upon vacancies occurring. Each of these scholars will be required to execute a bond of Rs. 1,000 pledging himself to enter Government Service in the Irrigation Department, and remain in that service for at least ten years.
- The examination will be confined to candidates whose age will be under 22 on June 30, 1911, and who are nominated by His Excellency the Governor. Before receiving such nomination candidat s must have passed one of the following examinations:--

-The Matriculation Examination of the London University.

- II.—The Cambridge University Senior Local Examination, including a pass in not less than five of the sections 2-16. Three of these sections must be-
 - 1) English.
 - (2) Mathematics.
 - (3) Latin, or Chemistry, or Physics, or two subjects in Biology and Physical Geography.

III.—The Intermediate Examination in Arts of the Madras University.

The subjects of examination will be as follows:

Compulsory.

- (1) Arithmetic.
- (2) Drawing—Freehand and Geometrical.(3) English Language and Composition.
- (4) Pure Mathematics Geometry, Algebra, and Trigonometry.

Optional.

Not more than two of the following:-

(5) Applied Mathematics—Elementary Mechanics and Hydrostatics.

(6) Chemistry—Theoretical and Practical.

(7) Physics—the elements of Sound, Light, Heat, Electricity, and Magnetism. Candidates will be examined practically in the use of the commoner physical apparatus.

Note.—The standard of the examination in subjects (4), (5), (6), and (7) is sufficiently indicated in the syllabus for the respective subjects prescribed for the Senior Cambridge Local and the London Matriculation Examinations.

N.B.—In selecting the scholars a preference will be given to those who have passed in either Physics or Chemistry.

- Applications for His Excellency the Governor's nomination must be submitted to the Director of Irrigation not later than December 31, 1910. Each candidate must send in with his application two certificates of character, one of which must be from the Principal of the last school which he attended.

- (b) The authorized vendor must at once enter thereon the date of the last issue and quantity issued, and endorse in his register and on the face of the certificate and the duplicate certificate "Transferred," with his signature and date and forward both copies to the Government Agent or Assistant Government Agent who issued them.
- (c) The Government Agent or Assistant Government Agent must similarly endorse the triplicate certificate, and note the transfer in the Kachcheri Register.
- (d) He will then issue to the proper authority of the new district a notice in the following form:—" Certificate No. ——, of the ———— District, in favour of ————, has been cancelled, and the holder has been directed to apply to you for a new certificate for ———— grains, as he will reside at ————. He has drawn ————— grains this month."
- (e) The proper authority shall on application enter the consumer in his Kachcheri register and issue a certificate.
- (f) For the purpose of rules (d) and (e), "proper authority" shall include, if the new district is in a different district to the old one, i.e., under a different Government Agent or Assistant Government Agent, such Government Agent or Assistant Government Agent.

Note.—The object of the change is to facilitate reference under the new certificate. Unless the district serial is followed, the entries in the vendor's register cannot be readily traced. The same procedure may be followed in the case of change of vendor in the same district. In the case of a lost certificate the old number should be cancelled and a new certificate issued.

By-laws for the Prohibition of Cesspools and Establishment and Regulation of Closets on the Dry-earth System and for the removal and disposal of Night Soil and House Refuse, framed under Section 30, Sub-section (19a), of Ordinance No. 20 of 1896, as amended by Ordinances No. 14 of 1898 and No. 33 of 1909.

- 1. Board may order cesspools to be closed and dry-earth closets substituted.—The Chairman when specially empowered thereto by resolution of the Board may by notice in writing require the owner or occupier of any house or building or land having a cesspool on his premises to close such cesspool and to substitute a dry-earth closet therefor.
- 2. Permission to bury in private premises.—Permission may be granted in writing by the Chairman to any householder to have night soil from his own premises buried or otherwise disposed of on his own premises.
- 3. Removal of night soil.—Every person who has not had authority to bury night soil in his own premises is required to arrange for the removal of his night soil by the Board of Improvement.
- 4. Fees for the removal of night. Levery person employing a Board of Improvement scavenging cooly for the removal of night soil shall pay monthly in advance to the Board the rates approved by the Board. The sums payable if not paid on or before the 10th of the month in respect of which they shall be due may be reported by the Chairman to the Police Magistrate of Nuwara Eliya and recovered in the same way as if they were a fine imposed by such Magistrate.

Rule 43, for "124 (g)" in line 2 substitute "124 (h) and (i)."

- 50. Use of Apostrophes and Hyphens.—Words separated by an apostrophe (except in the case of certain names—see Rule 53 A) and words joined by a hypen are counted as so many separate words.
- 53 a. Surnames.—Names such as Macdonald (or McDonald), FitzGerald, O'Neil, DeMorgan, D'Cruz, De la Rue, St. John, Van de Brande, Du Bois, will be counted as one word each, even though written with capital medial letters. They will, however, be signalled as written.
 - Rule 112, for "condition (10)" in the last line but 7 substitute "condition (9)."
- 177. [Reg. XVII., I.]—The sender and addressee of any telegram already transmitted or in course of transmission (or the authorized representative of either of them) may, during the period of preservation of the records, i.e., ten months, and after they have proved, if necessary, their right and their identity, cause inquiry to be made, or instructions to be given, respecting such telegram by telegraph. They must deposit the following amounts:—
 - (a) The cost of the telegram making the request.
 - (b) When necessary (see Rule 178) the cost of a reply telegram.

They may also, in order to make or obtain corrections, cause a telegram, which they may have sent or received to be repeated, entirely or in part, by the Office of Destination or by the Office of Origin or by a Transit Office. In the case of a repetition asked for by the addressee, he must pay the full charge for each word to be repeated. This charge includes the cost of the reply.

- 178. [Reg. XVII., 2.]—Rectifying, completing, or cancelling telegrams and at other communications relating to a telegram already transmitted or in course of transmission, when they are addressed to a Telegraph Office, must be exchanged exclusively between the offices under the form of Paid Service Advices at the cost of the sender or the addressee making the demand.
- [Reg. XVII., 3.]—Paid Service Advices which are sent at the request of the addressee in order to obtain the repetition of a passage suspected to be erroneous imply always a telegraphic reply, and the insertion of the indication = RPx = is not necessary. In other cases in which a telegraphic reply is requested this indication must be employed.
- 199 [Reg. XIX., 10.] Inadmissible Groups or Words.—When the Office of Origin discovers, after the charge has been collected, that a telegram contains either inadmissible combinations or alterations of words, or of expressions or words, which, although not fulfilling the conditions of plain or code language, have been charged for as belonging to those languages, it applies to these expressions or words, for the calculation of the under-charge to be recovered from the sender, the rules to which they should have been respectively subjected. The combinations or alterations are counted in accordance with the number of words which they would contain if they were written in the usual manner. The Office of Origin acts in the same manner when the irregularities are brought to its notice by a Transit Office or by the Office of Destination. Nevertheless, neither of these two latter offices may delay the forwarding or delivery of the telegram, except in the case provided for in Rule 102.
- 200. Surnames.—Names such as Macdonald (or McDonald) FitzGerald, O'Niel, DeMorgan, D'Cruz, De la Rue, St. John, Van de Brande, Du Bois will be counted as one word each, even though written with capital medial letters. They will, however, be signalled as single words without break, the apostrophe (where used) being omitted.

201. Omit following from "Examples of Counting":-

260.8. [Res. LIV. 9.]—If the re-transmissions take place within the limits of the country to which the Office of Destination belongs, the supplementary charges to be collected from the addressee is calculated for each re-transmission according to the internal tariff of such country. If the re-transmissions take place beyond these limits, the supplementary charge is calculated by treating each international re-transmission as a separate telegram. The charge for each re-transmission is the charge applicable to traffic exchanged between the country which re-transmits and that to which it is re-transmitted.

In the case of telegrams re-transmitted within the limits of Ceylon, no additional charge is levied for re-transmission if the two addresses are within the same town; but if in different towns, the full inland rate will be charged for re-transmission. State telegrams will be re-transmitted free within the limits of Ceylon.

- (E) Telegrams to be re-transmitted by order of the Addressee or his Agent.
- 261. [Reg. LV., 1.]—Any person on furnishing the necessary proof of identity may request that telegrams arriving for him at a Telegraph Office in Ceylon be re-transmitted to him to a new address which he supplies.
- 261 a. [Reg. LV., 2.]—Requests for re-transmission must be made in writing by Paid Service Advice or by post (see Rule 181). They must be made either by the addressee or in his name by one of the persons mentioned in Rule 228 as entitled to receive telegrams on his behalf. Any one making such a request must undertake in writing to pay the charges which may not be recovered by the Delivery Office. When re-direction to a foreign country is desired, the person making the request should state definitely, in writing, whether telegrams from places in Ceylon are also to be re-directed to that foreign country. When no such statement is made, the request will be considered to apply to telegrams from foreign countries only.
- 261 b. Requests left at Telegraph Offices regarding the re-addressing or redirection of telegrams will be considered to be in force for a month only, and after that period they will be liable to the fees prescribed by Rule 238.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended December 10, 1910.

The total births registered were 102 (0 Europeans, 9 Burghers, 60 Sinhalese, 9 Tamils, 19 Moors, A Malays, and I Other). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1910, viz., 187,554) was 28.4, as against 32.0 in the preceding week, 34.0 in the corresponding week of last year, and 25.1 the weekly average for last year.

Peaths:—The total deaths registered were 127 (0 Europeans, 5 Burghers, 65 Sinhalese, 30 Tamils, 23 Moors, 0 Malays, and 4 Others). The death-rate per 1,000 per annum was 35.3, as against 30.9 in the previous week, and in the corresponding week of last year, and 33.7 the weekly average for last year.

Infantile Deaths:—Of the 127 total deaths, 34 were of infants under one year of age, as against 28 in the preceding week 31 in the corresponding week of the previous year, and 27 the average for last year.

Stillbirths. The number of stillbirths registered during the week was 7.

Selected Causes of Death.—Fifteen deaths were registered from Phthisis (against 10 in the previous week and 15 the weekly average for last year), of which 4 each were in Maradana (exclusive of hospitals), 3 each in Kotahena and Maradana hospitals, 2 each in St. Paul's and New Bazaar, 1 in Slave Island.

Fifteen deaths were registered from Pneumonia (against 6 in the previous week and 15 the weekly average for last year), of which 4 were in New Bazaar, 3 in Maradana (exclusive of hospitals), 2 in Kollupitiya North, and 1 each in Fort and Galle Face Ward, San Sebastian, St. Paul's, Kotahena, Maradana hospitals, and Slave Island. Six deaths were registered from Bronchitis.

3. Twelve deaths were registered from Debility (including 7 infants), 11 from Enteritis (2 infants), 7 Infantile Commissions, 7 Starvation (all infants), 5 Diarrhaa (1 infant), 4 Old Age, 4 Puerperal Fever, 3 Premature Birth, and 32 from Other Couses.

Six deaths were registered from Enteric Fever (against 2 in the previous week and 6 the weekly average for last year), of which 3 were in Kotahena and 1 each in San Sebastian, Maradana hospitals, and Maradana (exclusive of hospitals). There were 18 cases reported during the week, against 10 in the previous week.

5. Six eases of Smalpor were reported, against 5 in the previous week; also 4 of Measles, against 1 in the previous week; also 4 of Measles, against 1 in the previous week.

State of the Weather. The mean temperature of air was 78 1°, against 78 4° in the preceding week and 78 3° in the corresponding week of the previous year. The mean atmospheric pressure was 29 926 in., against 29 948 in. in the preceding week and 29 946 in. in the corresponding week of the previous year. Now know Ye that We, the said Governor, with the advice and consent aforesaid, and in exercise of the powers vested in Us by section 34 of "The Police Ordinance, 1865," and section 1 of Ordinance No. 19 of 1871, intituled "An Ordinance to provide for the reduction in certain places of the minimum rates payable for maintenance of Police," do hereby appoint that for the purposes aforesaid the tax payable on all houses and buildings of every description and on all lands and tenements whatsoever in the town of Moratuwa aforesaid, within the limits set forth in the schedule to the said Proclamation dated October 5, 1910, shall as from and after January 1, 1911, except in cases where the amount equal to the percentage on the bonâ fide annual value of such houses, buildings, lands, and tenements shall fall below the sum of 50 cents a year, and in the case of such buildings as are exempted from the payment of such tax by the said section 34, be at the rate of $1\frac{1}{2}$ per cent. on the bonâ fide value of such houses, buildings, lands, and tenements aforesaid, payable quarterly on March 31, June 30, September 30, and December 31, and that in cases in which the amount equal to the percentage on the bonâ fide annual value of such houses, buildings, lands, and tenements fall below the sum of 50 cents a year, a sum of 50 cents shall be assessed and be payable in half-yearly instalments, to wit, 25 cents on June 30 and 25 cents on December 31 in each year.
