CHAPTER VI,

Establishment and Regulation of Markets.

- 30. All fresh fish caught in the sea and brought on shore in any vessel whatsoever and landed in any part of the seabeach within the Municipal limits of the town of Galle, and all other fish brought otherwise within such limits, shall be taken by the owners thereof to the fish auction shed in the Galle bazaars.
- 31. Such fish shall first be sold by public auction in the said fish auction shed by the renter, who shall be entitled to recover a commission of 4 per cent. on the proceeds.
- 32. No fresh fish other than that purchased at such auction sale can be sold within the Municipal limits of the town of Galle without a license from the Council.
