##### HAMBANTOTA DISTRICT.

Paddy cultivation: the maha ploughing is in progress. In West Giruwa pattu owing to drought cultivation has not begun.

Other grains: chenas have been sown; prospects poor.

Weather: rainfall at Hambantota 2.96 in.; mean maximum temperature, 88.30°F.; mean minimum temperature, 74.70°F.

Health of people: satisfactory, except in the Katuwana division of West Giruwa pattu, where fever is prevalent.

Health of cattle: satisfactory; there were a few cases of rinderpest during the month.
