PROCLAMATIONS BY THE GOVERNOR.

In the Name of His Majesty GEORGE THE FIFTH, of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, King, Defender of the Faith.

PROCLAMATION.

By His Excellency Sir HENRY EDWARD McCALLUM, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

HEREAS for the purpose of carrying out the provisions of the Municipal Councils' Ordinance, No. 6 of 1910, the Municipal Council of Kandy has, in pursuance of section 109 (1) of the said Ordinance, amended, altered, and varied the by-laws, numbered respectively 137, 143, 144, 150, 156, 157, 159, 161, 162, 164, and 173, which are contained in Chapter XII. of the by-laws proclaimed on December 18, 1906, in the manner set forth in the schedule

Now know Ye that We, the Governor of Ceylon, in exercise of the power vested in Us by sub-section (3) of section 109 of the said Ordinance, and with the advice of the Executive Council, do hereby confirm and proclaim the amendments, alterations, and variations of the by-laws aforesaid as the same are set forth in the said schedule

Given at Elephant Pass, in the said Island of Ceylon, this Eighteenth day of January, in the year of our Lord One thousand Nine hundred and Eleven.

SCHEDULE.

Section 137.—For "Magistrate" substitute "Commissioner of the Court of Requests of Kandy, who shall exercise jurisdiction whatever the amount involved may be, and whose decision shall be subject to an appeal to the Supreme Court.

Appealable

Add Section 137 a.—Every such appeal shall be presented within the time and in the manner and subject to the rules and practice provided for and observed in appeals from order of Courts of Requests in their ordinary jurisdiction.

Power of Council to exempt any division, house, or land from payment of water-rate.

" Domestic purposes," what not included in. Add Section 137 b.—The Municipal Council may, with the consent of the Governor in Executive Council, from time to time, by notification in the Government Gazette, exempt any division or part of a division of the Municipality, and without such consent, any house, land, or tenement, from payment of the water-rate leviable under the provisions of Ordinance No. 8 of 1895.

For section 143 substitute the following:

Section 143.—Water supplied to premises occupied wholly on in any part for the following purposes shall be considered as supplied for other than domestic purposes, viz.

- (1) For the purposes of conducting or carrying on any trade or manufactory in which water is used.
- (2) For the purposes of a hotel, private boarding house, restaurant, lodging house.

(3) For public bathing places.

(4) For keeping horses, cattle, or vehicles for sale or hire.

(5) For swimming baths.

- (6) For fountains or hydraulic motors not used in connection with any trade.
- (7) For watering gardens or compounds where special appliances or connections are fixed permanently or temporarily to any service pipe or main for the purpose.

(8) For building or road-making or road-repairing purposes.

Add Section 143 a.—The prices of water supplied by meter for other than doffestic purposes shall be as follows:—

(1) To premises occupied wholly or in part-

- (a) For the purposes of conducting or carrying on any trade or manufactory in which water is used, Re. 1 per 1,000 gallons.
- (b) For the purposes of a hotel, private boarding house, restaurant, lodging house, Re. 1 per 1,000 gallons.
- (c) As public bathing places, 50 cents per 1,000 gallons.(d) For keeping horses, cattle, or vehicles for sale or hire,

50 cents per 1,000 gallons.
o premises upon which water is used for—

(a) Swimming baths, 50 cents per 1,000 gallons.

- (b) Fountains and hydraulic motors not used in connection with any trade, 50 cents per 1,000 gallons.
- (c) Watering gardens or compounds, 50 cents per 1,000 gallons.
- (d) Building and road-making and road-repairing purposes, Re. 1 per 1,000 gallons.

For section 144 substitute the following:-

Section 144.—It shall be lawful for the Council, on application by the owner or occupier of any house, to allow a private service of water to such house for domestic purposes, and to fix a meter on the pipe supplying such house or premises. The provision of section 157 in reference to the quantity of water allowed and to the charges for excess of water shall be applicable to this section. When it private service is allowed, the connection between the Municipal main and the premises to be served, as well as the necessary service pipes and fittings, shall be made, laid, and affixed by Municipal workmen under the supervision of the Superintendent of Works, at the expense of the person applying for such private service. The Council may require the estimated cost of such private service to be paid into the Municipal fund before the work in connection therewith is commenced. Also all future repairs, extensions, and alterations shall be executed at the expense of such owner or occupier.

Section 150.—After the word "recovered" read "as if the same were a tax under the Municipal Councils' Ordinance and any existing or future amending Ordinances."

After section 156 add the following:-

Section 156 a.—Whenever water is found running to waste from any tap, meter, pipe, or other fittings which is supplied with water from the waterworks, the Chairman or person duly authorized by him in writing may at once cut off the water, and such service shall not be re-connected until the cause of the waste is remedied.

For section 157 substitute the following:

Section 157.—Should the Council be of opinion that in any house or premises water from the Municipal waterworks is used by other than members of the household, or is wasted or unduly consumed, it shall be lawful for the Council to fix a meter on the pipe supplying such house or premises, and the owner or occupier shall pay for all water shown by the meter to have been consumed in excess of three thousand gallons, for every rupee of water-rate

Add Section 157 a .- It shall be lawful for the Council to fix a meter on the pipe supplying water to any house or premises where. the water is used for other than domestic purposes. The value of the amount of water consumed during the quarter shall be ascertained as provided in section 143 A, and from the amount thus obtained a deduction of 3 per cent. of the annual value of the premises, as ascertained under the provisions of Ordinance No. 6 of 1910, shall be made.

Add Section 157 b.—The Council may also agree with any person to supply water for other than domestic purposes, provided an agreement in the Form L in the schedule hereto annexed shall have been entered into with the Chairman of the Municipal Council.

Section 159.—After the word "recovered" insert "as if the same were a tax under the Municipal Councils' Ordinance and any existing or future amending Ordinances."

After section 161 add the following:-

Section 161 a .- For the purpose of calculating the quarterly consumption the difference between two readings of the meter shall be taken. The first reading may be that observed on any day not more than ten days before or after the calendar date of the commencement of the quarter, or in case of a newly fixed meter the first reading of the meter. The second reading may be that taken on any day not more than ten days earlier or later. than the calendar termination of the quarter, or if the meter is removed, or the supply closed during the quarter, then the last reading shall be taken as the second reading for ascertaining the quarter's water consumption. If two or more meters have been in use during the quarter, then the quarter's consumption shall be the sum of the quantities indicated by the meters. Provided always that the reading used as the last reading of any quarter shall be used as the first reading of the ensuing quarter.

After section 162 add the following :-

Section 162 a .- If the consumer doubts the accuracy of the meter which measures the water supplied to the premises occupied by him, then the meter shall on demand be tested by the Superintendent of Municipal Works. The consumer or any person appointed by him may be present when the meter is tested. result of the testing shall be binding both on the Council and on the consumer, and the quantity of water indicated by the meter for the month shall be counted according to the result of the test. If the meter be found to indicate correctly, or if it be found to indicate too little, then a fee of Rs 2.50 shall be paid to the Municipal Council for testing by the person demanding the test.

To section 164 add:-

Each quarter's account shall be final, and no surplus shall be carried forward from one quarter to the next.

For section 173 substitute the following:

Section 173.—The Chairman may diminish, withhold, or suspend, stop, turn off, or divert the supply of water through or by means of any pipe, service, public fountain, or other appliances connected to the waterworks either wholly or in part, or whenever such Chairman may think fit, and without prejudice to any water-rate, meter rent, or other sums due or to become due under the provisions of this chapter :-

- (1) Whenever the available supply of water from the waterworks shall, in the opinion of the Chairman, be insufficient.
- (2) Whenever it may be expedient or necessary for the purpose of extending, altering, or repairing the waterworks, or for the purpose of the connection of services.
- (3) When any public standpost is damaged, or the water thereof polluted or wasted.
- (4) If the construction or laying of any service by the owner of any premises is not made, altered, or re-adjusted in accordance with the provisions of this chapter.
- (5) If default be made in the payment of any money due under the provisions of this chapter from the owner or occupier of any premises, or so long as such default continues, or at the request of the owner of the tenement.
- (6) In case of fire.
- (7) If any act or thing be done or omitted contrary to the provisions of this chapter in relation to any damage, waste, pollution, or abuse of the waterworks, or any service, meter, or public fountain.

WHEREAS by section 53 of "The Courts Ordinances, 1889 and 1901," it is, inter alia, enacted that it shall be lawful for the Judges of the Supreme Court, or any three of them, of whom the Chief Justice shall be one, from time to time to frame, constitute, and establish such general rules and orders of Courts as to them shall seem meet for the pleading, practice, and procedure, where not especially provided for by "The Civil Procedure Code, 1889," or the Criminal Procedure Code, upon all actions, suits, prosecutions, and other matters, civil and criminal, to be brought to the Supreme Court and in all matters subordinate to it:

And whereas, in exercise of the aforesaid power and of the power vested in them by "The Foreign Tribunals Evidence Act, 1856," the Judges of the Supreme Court have framed, constituted, and established the rule set forth in the schedule hereto touching the issue of Commissions Rogatoires and Letters of Request for the taking of evidence in foreign countries in civil proceedings pending in Courts in this Island:

And whereas the said rules were, in pursuance of the said section of the said Ordinances, duly laid before the Legislative Council then in session and not objected to within forty days of their being so laid before the Council:

It is hereby proclaimed, in terms of the said section of the said Ordinances, that the said rules shall come into force from the date of the publication hereof.

Rule of Court.

In exercise of the power vested in Us by "The Courts Ordinances, 1889 and 1901," and of every other power enabling Us, We hereby make the following

Where, in any civil proceeding pending in any Court in this Island, evidence is required to be taken in a foreign country, and a Commission Rogatoire or Letter of Request is issued for that purpose, it shall be accompanied by a list of questions to be put to the witnesses respectively, together with a translation thereof in the language of the foreign State in which the Commission Rogatoire or Letter of Request has to be executed.

REGULATIONS REFERRED TO.

Eating Houses and Tea or Coffee Boutiques.

- 1. All utensils, furniture, and other requisites used in or belonging to any eating-house or tea or coffee boutique shall always be kept clean.
- 2. The walls of all eating-houses and tea or coffee boutiques shall be plastered and limewashed, the rooms well ventilated and lighted, and the floor cemented.
- 3. All refuse and dirt in and about the premises of an eating-house or tea or coffee boutique shall be removed twice daily.
- 4. No person suffering from any loathsome, contagious, or infectious disease, or who has recently been in attendance on any such persons, or who is unwashed or otherwise unclean, shall be employed in any eating-house or tea or coffee boutique.
- 5. The sugar used in such places shall be kept in glass-stoppered wide-mouthed bottles.
- 6. All cakes, sweetmeats, &c., exposed for sale shall be kept in properly constructed glass cases free from files. No food stuff shall be exposed to the contamination of flies. The glass cases used shall be kept scrupulously clean.
- 7. No waste tea or coffee or milk and no remnants of food or cooking waste shall be thrown on the ground, but the same shall be collected in a proper receptacle and removed daily.
- 8. These by-laws shall be framed and hung up in a prominent place in every such eating-house and tea or coffee boutique.

T is hereby notified under section 3 (1), Criminal Procedure Code, that on and after February 1, 1911, the villages named in column 3 and situate in the korales named in column 2 shall form and be within the limits of the Police Station named in column 1 of the annexed schedule.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended January 21, 1911.

Births.—The total births registered were 122 (1 European, 10 Burghers, 77 Sinhalese, 11 Tamils, 17 Moors, 3 Malays, and 3 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1911, viz., 189,423) was 33.6, as against 39.1 in the preceding week, 29.5 in the corresponding week of last year, and 25.6 the weekly average for last year.

-The total deaths registered were 118 (2 Europeans, 4 Burghers, 63 Sinhalese, 25 Tamils, 17 Moors, 3 Malays, and 4 Others). The death-rate per 1,000 per annum was 32.5, as against 33.6 in the previous week, 35.4 in the corresponding week of last year, and 31.2 the weekly average for last year.

Infantile Deaths.—Of the 118 total deaths, 24 were of infants under one year of age, as against 30 in the preceding week, 36 in the corresponding week of the previous year, and 27 the average for last year.

Still Births.—The number of still births registered during the week was 9.

Selected Causes of Death.—Thirtoen deaths were registered from Phthisis (against 11 in the previous week and 13 the weekly average for last year), of which 4 each were in Maradana Hospitals and Maradana (exclusive of hospitals). 2 in Slave Island, and 1 each in New Bazaar, Kollupitiya North, and Kollupitiya South.

- 2. Eleven deaths were registered from *P. neumonia* (against 13 in the previous week and 12 the weekly average for last year), of which 3 were in Maradana hospitals, 2 in New Bazaar, and 1 each in Fort and Galle Face Ward, San Sebastian, Maradana (exclusive of hospitals), Slave Island, Kollupitiya North, and Kollupitiya South. Three deaths were registered from *Bronchitis*.
- 3. Twelve deaths were registered from Infantile Convulsions, 10 from Enteritis (2 infants), 7 Debility (1 infant) 7 Diarrhea (3 infants), 7 Old Age, 6 Tetanus (3 infants), 6 Dysentery, 4 Dochmius Duodenalis, and 25 from Other Causes.
- 4. Seven deaths were registered from *Enteric Fever*, against 3 in the previous week and 5 the weekly average for last year), 2 each in Maradana (exclusive of hospitals), Slave Island, and Kollupitiya South, and 1 in Kotahena. There were 22 cases reported during the week, against 13 in the previous week.
- 5. Two cases of *Measles* were reported, against 3 in the previous week; and 18 of *Chickenpox*, against 23 in the previous week.

State of the Weather.—The mean temperature of air was 79.3°, against 79.0° in the preceding week and 77.9° in the corresponding week of the previous year. The mean atmospheric pressure was 29.958 in., against 29.953 in. in the preceding week and 29.960 in. in the corresponding week of the previous year. The total rainfall in the week was 0.67 in., against 0.68 in. in the preceding week and 0.01 in. in the corresponding week of the previous year.
