WHEREAS by section 4 (1) of Ordinance No. 3 of 1903 it is enacted that when it appears to the Governor, with the advice of the Executive Council, from time to time, that by reason of the existence or apprehension of crime and outrage in any district it is desirable to quarter police in such district, or should a police force have been already established there to increase the same, he may by Proclamation, which shall be published in the *Govern*ment Gazette, declare that for the reason aforesaid such district requires police or additional police, and may order police to be quartered in such district or additional police be employed there :

And whereas it appears to the Governor, with the advice of the Executive Council, that by reason of the existence of crime and outrage in the district defined in the schedule hereunto annexed it is desirable to quarter police in the said district :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby declare that by reason of the existence of crime and outrage therein the said district in the Eastern Province requires police, and do hereby order that a police force consisting of 1 sergeant and 6 constables be quartered in the said district in the said Eastern Province, as from and after May 1, 1911.

And We do further hereby define the limits of the said district to be those set out in the schedule hereunto annexed.

SIR,-I have the honour to inform you that the King has approved of clause 1 of Article 49 of the King's Regulations and Admiralty Instructions as to the firing of salutes on British anniversaries being amended so as to run as follows :-

"49. The fixed dates for firing salutes in celebration of British anniversaries are as follows, viz.:---

(a) The anniversaries of the birth, accession, and coronation of the reigning Sovereign;

(b) The birthday of the Consort of the reigning Sovereign;

(c) The birthday of the Queen Mother;

on which days a Royal Salute shall be fired at noon from all His Majesty's ships in port, and from all the forts and batteries from which Triumph Salutes are usually fired."

(f) Petrol will, subject to the provisions of clause (f), be accepted for conveyance (7) Fettol will, subject to the provisions of clause (7), be accepted for conveyance by passenger train at ordinary prepaid parcels rates in receptacles not attached to motor vehicles of 2, 4, or 5-gallon capacity, provided that not more than 16 gallons shall be conveyed in one train under the following conditions :— (g) Receptacles of 2-gallon capacity must be made of tinned or galvanized sheet iron or steel of not less than 27 B.W.G., and they must be packed either in pairs or fours in substantially constructed and sealed proceed and accept of such a size as will

The thickness of the wood must not be less than half an inch, and the general pattern of the cases must be approved by the General Manager of the Railway.

(i) The receptacles containing the petrol must be fitted with well-made filling holes and well-fitting screw plags of a pattern approved by the General Manager of the Railway, and an air space equal to one-tenth of its capacity must be left in each receptacle for expansion of the petrol. The receptacles must be gas-tight and so substantially constructed and secured as not to be liable, except under circumstances of gross negligence or extraordinary accident, to be broken or become defective, leaky, or insecure in transit. Damaged receptacles will not be accepted for transport. The nature of the contents and also the words "highly inflammable" must be distinctly marked on the 4 and 5-gallon receptacles, or on the wooden cases in which the 2-gallon receptacles are transported.

(k) Petrol will not be conveyed by passenger train under any other circumstances, but will be treated as explosives, and sent by goods trains on the days fixed for conveyance of explosives.

(l) A declaration in the following form must be signed by the owner or responsible agent of the owner of any motor vehicle before the vehicle can be accepted for conveyance by train or, in the case of motor cycles, for storage in the station cloak rooms :—

I hereby declare that the motor _____ which I require to be despatched by rail from _____ station (or deposited in the cloak room, or left at ______ station) is not charged with electricity, gas, oil, or petrol (small electric battery and coil affixed to petrol-propelled vehicles excepted), and I hereby agree to indemnify the Ceylon Government against all damage, loss, or expense which may arise out of, or be incurred in consequence of, such transport or storage.

(m) Return, empty vessels in which petrol has been conveyed by railway will be charged at half parcels rates. The screw plugs or caps of the empty vessels must be securely fastened.

RULES REFERRED TO.

Conveyance of Motor Vehicles and Petrol by Goods Train.

44. Petrol.—(a) "Petrol" includes all dangerous petroleum used for the propulsion of motor vehicles.

(b) Petrol will be accepted for conveyance by goods train at first class rate, and subject to the regulations governing the transport of explosives (*vide* clause 46), in receptacles, not attached to motor vehicles, of 2, 4, or 5-gallon capacity under the following conditions :—

(c) Receptacles of 2-gallon capacity must be made of tinned or galvanized sheet iron or steel of not less than 27 B.W.G., and they must be packed in substantially constructed and sealed wooden cases of such a size as will exactly accommodate either two or four receptacles of 2-gallon capacity as above defined. The thickness of the wood must not be less than half an inch, and the general pattern of the cases must be approved by the General Manager of the Railway.

(d) Receptacles of 4 or 5-gallon capacity must be made of sheet iron or steel, and the metal must be not less than 16 B.W.G. These will be conveyed unpacked.

(e) The receptacles containing the petrol must be fitted with well-made filling holes and well-fitting screw plugs of a pattern approved by the General Manager of the Railway, and an air space equal to one-tenth of its capacity must be left in each receptacle for expansion of the petrol. The receptacles must be gas-tight and so substantially constructed and secured as not to be liable, except unde circumstances of gross negligence or extraordinary accident, to be broken or becom defective, leaky, or insecure in transit. Damaged receptacles will not be accepted for transport. The nature of the contents and also the words "highly inflammable" must be distinctly marked on the 4 and 5-gallon receptacles, or on the wooden cases in which the 2-gallon receptacles are transported.

(f) No petrol will be accepted for conveyance by goods train unless the consignment is accompanied by a declaration from the consignor in the following terms, viz. :--

I hereby declare that the petrol herewith consigned by me is in every respect in accordance with the regulations of the Railway governing the transport of petrol by goods train as printed on the back of this declaration.

(g) Return empty vessels in which petrol has been conveyed by Railway at goods rates will be conveyed at fourth class rate in terms of clause 38. The screw caps or plugs of empty vessels must be securely fastened.

Under Sub-section (a).—Food, Fuel, and Water.

1.—(1) In the case of every ship subject to the provisions of this Ordinance the scale on which food, fuel, and water are to be supplied to the passengers per head per diem shall be as follows :—

(2) In the case of steamships carrying an apparatus for distilling fresh from salt water, a supply equal to five-sevenths of a gallon per head per diem shall suffice.

(3) Children above one year and under twelve years shall receive half rations.

(4) Passengers who desire to provide themselves with their own food shall be allowed to do so, but fuel and water shall be supplied by the ship.

Under Sub-section (b).—Medical Stores and other Appliances and Fittings for maintaining Health, Cleanliness, and Decency.

II.—(1) Every such ship shall have on board a supply of medicines and appliances as set forth in the schedule hereunto annexed, together with written or printed instructions for their use in a language which the commander or some other officer of the ship can read :—

(2) The medicines and surgical appliances above specified shall be supplied for the use of the passengers whenever circumstances so require; and if the medical officer, or, where there is none, the master of the ship, omits, when circumstances so require, to supply the same, he shall be punished with fine, which may extend to • two hundred rupees.

III.—(1) Every such ship carrying more than one hundred passengers shall carry the materials for the erection of a temporary hospital to provide for the treatment of such cases of sickness as it may be considered desirable to separate (such as smallpox, cholera, yellow fever, or plague), and for any general outbreak of sickness, when it would be necessary to keep the sick passengers apart from the others. The part of the upper deck upon which such temporary hospital shall be erected shall be pointed out and measured off by the principal officer in charge of the Customs at the port of embarkation or any person authorized by him. The framework of the hospital may be either of iron (in pieces that can be easily fitted together) of of wooden spars or bamboos. The roof must be tented, and both that and the side walls must be made of stout canvas and be perfectly water-tight, due provision being at the same time made for ventilation. The superficial area of the floor shall be not less than 72 fact, and such floor shall be raised at least 4 in.

from the deck; sheet iron is preferable as the material of the floor. The space for the hospital must always be deducted from the area measured for passengers on board of such ships.

(2) The temporary hospital shall always be erected at once and made available for the use of sick passengers whenever the circumstances as described above so require.

(3) If the master of any ship omits to erect a temporary hospital as required by this rule, he shall be punished with fine, which may extend to two hundred rupees, and with a further fine of twenty rupees for every day after the first during which the omission continues.

IV.-(1) Every such ship shall be fitted with not less than two privies sufficiently screened from public view and readily accessible and available at all times for the use of the passengers, and with one more such privy for every one hundred passengers or part of that number carried in excess of one hundred; but no privies shall be allowed in the between decks.

(2) A proportion of such privies, in any case not less than one if there be any females among the passengers, shall be set apart for the exclusive use of females, such proportion corresponding, as nearly as may be, to the proportion of female to male passengers.

V.—Every such ship shall be provided with and have available for the use of the passengers not less than two places for washing sufficiently screened from public view, whereof a full proportion, as described in rule IV., shall be set apart exclusively for females. A sufficient number of hand pumps shall also be provided for supplying sea water for purposes of ablution.

VI.—On every such ship cattle shall be kept securely penned in, so as not to inconvenience the passengers.

VII.—(1) Every such ship shall be provided with not less than two cabooses, or cooking ranges, on deck, properly housed and covered, to which passengers shall have ready access at certain times in each day. The ranges shall be made of substantial plate iron lined inside with bricks, and raised at least 4 in. from the deck, with an outlet or chimney at the top for the escape of smoke. Each range shall contain at least five cooking places, and an additional range shall be provided for every two hundred passengers carried in excess of one hundred. Cooking on board in the passengers' own stoves is prohibited, and any passenger so cooking or attempting to cook shall be punished with fine, which may extend to one hundred rupees.

(2) The crew of the ship shall not be allowed to use the cooking ranges set apart for passengers during the period passengers are on board, but shall be provided with a separate cooking range.

VIII.—The master of any ship omitting to keep any privy, washing place, or cooking range available for the use of the passengers, or any cattle securely penned in, or allowing the crew of the ship to use any cooking range set apart for passengers in breach of the foregoing rules, shall be punished with fine, which may extend to two hundred rupees, and when the breach is a continuing one with a further fine of twenty rupees for every day after the first during which the breach continues.

Under Sub-section (c).—Boats, Anchors, and Cables.

IX.—Every such ship shall be provided with boats according to the scale laid down in the annexed schedule, all such boats being fully fitted with all usual appliances :—

Schedule of Boat Accommodation.

In ships of 200 tons and upwards, no boat of less than 90 feet of cubical contents is to be counted in the number.

In ships of 600 tons and upwards, two of the boats should be lifeboats.

No greater number of boats need be taken than are sufficient to carry all the crew and passengers on board. The cubic contents of the boats in the foregoing table are ascertained by

The cubic contents of the boats in the foregoing table are ascertained by multiplying their outside length, their outside width, and their inside depth together, and then the product by 0.6.

 \mathbf{X} —Every such ship shall be provided with not less than three anchors and cables.

XI .-- Every such ship shall be provided---(a) If she be a steamship, with hose sufficient to reach from her engines to her

stem and taffrail;

- (b) If she be a sailing ship, with one fire engine or force pump, with hose sufficient to reach from her stem to her taffrail; and if her tonnage exceed
- 800 tons, with a second such engine or force pump, with like hose; and (c) In the pase both of steamships and sailing ships, with fire buckets in the proportion of three for every 100 tons up to 600, and two for every 100 tons above 600, provided that fifty in all shall suffice.

XII.--If fire annihilators or fire engines are carried, they shall be placed by the master under the special charge of one of the principal officers of the ship and the ship's carpenter, who should be held responsible that, with the buckets and other fire apparatus, they are kept in a state fit for immediate use. The engine shall be worked not less than once a week, and shall be kept in proper order. As soon as possible after leaving port the officers and crew shall be divided into parties and assigned to stations in case of fire. The master of any such ship failing to comply with the requirements of this rule shall be punished with fine, which may extend to two hundred rupees.

XIII.-The cargo of every such ship shall before leaving port be properly stowed away, and the decks cleared of any loose straw, hay, or other inflammable material. If any such ship leaves port without having the cargo so stowed and the decks so cleared, the master shall be punished with fine, which may extend to two hundred rupees.

-Immediately before leaving port the passengers of every such ship shall XIV.be called on to deliver up whatever lucifer matches, gunpowder, or other inflammable articles they may have about them. Any passenger omitting or refusing to deliver up any such articles when called upon to do so shall be punished with fine, wh, ch may extend to one hundred rupees.

XV.-No naked lights shall on any account be used in the hold or storerooms or in the between decks, except under trustworthy superintendence. No person shall read in bed with a naked light. Smoking between decks is strictly prohibited. Spirits must never be opened in the hold, but should be hoisted on deck for the purpose. Any person committing a breach of this rule shall be punished with a fine, which may extend to two hundred rupees.

Under Sub-section (e).—Appliances for saving Life and making Signals of Distress.

XVI.-Every such ship shall be provided with an adequate supply of life-buoys, not less than four for each vessel, signals of distress, and inextinguishable lights fitted for attachment to the life-buoys.

Under Sub-section (f).—Access of Between Passengers to the Upper Deck.

XVII.-If any portion of the upper deck of a ship be reserved for the exclusive use of a particular passenger or of passengers of a particular class, the area so reserved shall not exceed such limit as will leave free space for the access of the intermediate or between deck passengers to an extent of the upper deck equal to not less than 6 superficial feet for each such passenger.

"THE PASSENGER SHIPS ORDINANCE, 1906."

IS Excellency the Governor has been pleased, under section 8 of the above-named Ordinance, to appoint the 1 under mentioned places to be ports from which it is lawful for vessels proceeding to India to carry passengers in a greater number than one passenger to every five tons of burden, viz. -- Colombo, Negombo, Galle, Jaffna, Kayts, Kankesanturai, Valvettitturai, Point Pedro, Mullaittivu, and Mannar.

T is hereby notified that His Excellency the Governor, in exercise of the powers vested in him by section 4 of the Mines and Machinery Protection Ordinance, No. 2 of 1896, and with the advice of the Executive Council, has been pleased to cancel the rules made and published on April 12, 1904, January 10, 1906, October 5, 1906, August 13, 1908, February 25, 1910, September 29, 1910, and January 7, 1911, relating to Factories, and to make and substitute therefor the rules set forth in the schedule hereto.

SCHEDULE.

In these rules, unless the context otherwise requires-

Colonial Secretary's Office, Colombo, March 14, 1911.

"Child " means a person under the age of 14 years. "Young person " means a person of the age of 14 years and under the age of 18 years.

- "Woman" means a woman of 18 years of age and upwards. "Machinery" includes any driving strap or band.
- " Mill-gearing " ill-gearing " comprehends, every shaft, whether upright, oblique, or horizontal, and every wheth drum, or pulley by which the motion of the first moving power is communicated to any machine.

29. Every hoist or tackle, near to which any person is liable to pass or to be employed, and every wheel, if within a distance of 3 ft. 6 in. from the floor, directly connected with steam, water, electrical, or other mechanical power, whether in the engine-house or not, and every part of a steam, gas, or oil engine, electrical motor, dynamo, or water wheel, shall be securely fenced; and

30. Every wheel-race not otherwise secured shall be securely fenced close to the edge thereof.

31. Every part of the mill-gearing belting, ropes, or chains driven in any way whatever within a distance of 3 ft. 6 in. from the floor shall either be securely fenced or be in such a position or of such construction as to be as safe to every person employed in the factory as it would be if it were securely fenced.

32. All fencing shall be of wood 3 ft. 6 in. high, posts 3 in. by 3 in., top rail 3 in. by 2 in., intermediate rails, two in number, 2 in. by $1\frac{1}{2}$ in. If iron is used for rails, it must be not less than 1 in. in diameter, and shall be maintained in an efficient state while the parts required to be fenced are in motion.

33. All wires conveying electrical current from the dynamo to the motors or lamps shall have highly insulated covering so as to constitute no source of danger.

34. Every main switchboard shall be under lock and key and bear clear instructions for its use by the inexperienced. ${\boldsymbol{\cdot}}$

35. No child shall be allowed to clean any part of the machinery in the factory while the same is in motion.

36. No young person or woman shall be allowed to clean any mill-gearing belts, ropes, or chains conveying motive power from the driving to the driven machine while the same is in motion.

37. No child, young person, or woman shall be allowed to work between fixed and traversing parts of any self-acting machine while the machine is in motion.

¹ 38. No superintendent or manager of a factory shall allow any boiler to be used for generating steam for the purpose of driving machinery, unless he can produce a boiler certificate in the annexed Form D from an engineer specially licensed by Government to issue certificates as to fitness of boilers and competency of persons in charge thereof.

On or before June 30 in each year it shall be the duty of all superintendents and managers of factories in which boilers are used as aforesaid to report in writing to the Government Agent of the Province the names and situations of the factories in their charge, together with a copy of certificate in Form D of an engineer specially licensed by Government to issue certificates as to fitness of boilers and competency of persons in charge thereof for each boiler, and the Government Agent shall cause the same to be registered and numbered, informing the manager or superintendent of the number assigned to each factory. When any new factory in which a boiler is used as aforesaid is opened, or whenever a new boiler is erected in a factory after the said date, the superintendent or manager shall forthwith report the same, with copy of boiler certificate in manner aforesaid, and at the same time report the opening of the new factory or the erection of a new boiler to the Inspector of Factories.

Whenever the steam power in any factory is permanently discarded or done away with, the superintendent or manager shall forthwith report the same to the Government Agent of the Province and to the Inspector of Factories.

The certificate in Form D must be obtained annually from a licensed engineer, who shall inspect such boiler before the issue of each certificate. Form D to be kept in triplicate : one copy to be kept in the factory for the information of the Inspector of Factories, one to be sent to the Government Agent, and the third to be retained by the licensing engineer.

All original certificates of boilers to be kept in the factory for the information of the Inspector of Factories. No superintendent or manager shall allow any boiler to be used as aforesaid beyond the period specified or in excess of the time stated in the boiler certificate in Form D.

It shall be the duty of all superintendents and managers of factories, when any 'new factory in their charge is opened in which mechanical motive power is made use of, to cause to be delivered to the Government Agent of the Province and to the Inspector of Factories, within one month of the commencement of work, a notice, substantially in Form F annexed, intimating that work has been commenced.

39. No superintendent or manager shall allow any person to have, nor shall any person have, control over a boiler used as aforesaid, unless he can produce a certificate of competency in the annexed Form A from the Inspecting Engineer appointed by Government, or from an engineer specially licensed by Government to issue certificates as to fitness of boilers and competency of persons in charge thereof.

Superintendents and managers shall on or before June 30 in each year forward to the Government Agent of their Province the copies of the certificates of competency of all persons in their employment, and shall also forward to the Government Agent the copies of certificates of all persons whom they may subsequently allow to have control of any boiler.

The original or copy of certificate of competency to be kept in the factory for the information of the Inspector of Factories.

Superintendents and managers shall on or before January 31 in each year forward to the Government Agent of their Province the copies of the certificates of competency of all persons in their employment, and shall also forward to the Government Agent the copies of certificates of all persons whom they may subsequently allow to have control of any boiler.

The original or copy of certificate of competency to be kept in the factory for the information of the Inspector of Factories.

40. All persons specially authorized in writing thereto by the Government shall be Inspectors for the purposes of Ordinance No. 2 of 1896 in respect of such factories as shall be enumerated upon such written authority, and shall at all reasonable hours of the day have free access to such factories for the purposes of inspecting machinery in use therein, or any part thereof, and shall report to the Government Agent any failure to comply with the provisions of these rules.

The Inspectors thus appointed shall furnish once a year, if possible, a report on each factory in their charge and forward it to the Government Agent, on or before the date appointed by that officer, accompanied either by a certificate in the annexed Form B (Certificate of Inspection) or by a statement showing why the Inspector is unable to grant such certificate.

41. The manager or the engineer in charge of a factory in which mechanical motive power and connected machinery are made use of shall on or before June 30 in each year forward to the Government Agent of the Province in which the factory is situated a certificate in the annexed Form C that these rules have been complied with. Where the rules have not been complied with in all respects, the manager or engineer shall name the particulars in which the rules have not been complied with, and shall state the reason for such non-compliance.

It shall be the duty of all superintendents or managers of factories to cause to be delivered to the Government Agent of the Province and to the Inspector of Factories, within one month of the cessation of work, a notice, substantially in the Form E annexed, intimating that work in the factory has been stopped.

If work is resumed in the factory, a notice, substantially in Form F annexed, must be sent to the Government Agent of the Province and to the Inspector of Factories, within one month of the resumption of work, intimating that work has been re-commenced.

42. Upon receipt of the certificate referred to in rule 39 the Government Agent shall forward a copy thereof to the person with regard to whom the certificate is given. Where a copy of the certificate has been received, the Government Agent shall forward a duplicate thereof.

43. It shall be lawful for the Government Agent, when he is satisfied that any part of the machinery of a factory is a source of danger to any person or persons employed therein, to make an order in writing directing that such protective measures as he may think necessary be taken in regard to such part of the machinery.

44. The manager or superintendent shall carry out such order as quickly as possible, unless he lodges within ten days of the receipt of the order an appeal against the order to the Governor in Executive Council, by whom the order may be confirmed, modified, or annulled.

45. The superintendent or manager shall comply with the order which may be made by the Governor within two weeks of the receipt of a communication containing the decision arrived at.

46. Nothing in these rules shall be read or construed to preclude a special inspection being made of any factory at any time within reasonable hours by any person duly and specially authorized by the Government Agent to make such special inspection.

47. The superintendent or manager shall place a copy of these rules in a conspicuous position near the door of the factory.

48. The owner, superintendent, manager, or person in charge of a factory shall cause to be sent by telegram or by registered post to the Government Agent information of the occurrence of any accident to any workman resulting in death or serious injury within twenty-four hours of such occurrence.

Examination for the Local Division of the Civil Service of Ceylon.

1. An Examination for admission to the Local Division of the Civil Service will be held in Colombo in or about October next. The prospects and conditions of the Service are set out in the Minutes governing the Local Division of the Civil Service published in the *Government Gazette* of February 17, 1911. The number of persons to be selected at this Examination will be two.

2. No person will be admitted to compete who has not received a nomination from His Excellency the Governor.

3. Applications for nominations should be sent to the Principal Assistant Colonial Secretary—the envelope to be marked "Local Division, Civil Service"—on or before April 30. No question as to the delay or loss in the post of any such application can be entertained.

4. Nominations will be limited to candidates who have passed the Senior Standard of the Cambridge Local Examination, the London Matriculation, or any other public examination which may be deemed to be of an equally , high standard.

- 5. Every applicant must furnish satisfactory prool-
 - (a) That he is a natural-born British subject born in Ceylon of parents permanently resident in the Island.
 - (b) That at least 19 years and not more than 23 years have elapsed since the date of his birth on January 1, 1911.
 - (c) That he is of good moral character.

6. Applicants should attach to their applications-

- (1) Birth certificate.
- (2) A certificate of character from the head of the school at which the applicant was educated.
- (3) A statement showing where he was educated, examinations passed, degrees taken, &c., present occupation, and how he has spent the time since he left school.
- 4) A medical certificate that the applicant is of sound constitution, possessed of good sight, and otherwise physically qualified for the Service.
- (5) Particulars of property possessed by the applicant, showing the situation and nature of the land or property. It should also be stated in the case of landed property whether it is ancestral or recently acquired.
- (6) Any athletic distinctions obtained by the applicant should be stated, also whether the applicant is a Volunteer, and whether he is able to ride.

7. All candidates after nomination will be required to undergo a medical examination by a Board before the examination by the Civil Service Commissioners. The fee for the medical examination will be Rs. 10.50. The fee for the examination will be Rs. 25.

Syllabus of Subjects.

Note.-No text books will be prescribed for any subject.

ENGLISH.

English Language and Composition .-- The subject will include--

- (a) A subject for an essay to be chosen by each candidate from several subjects set. Those proposed may include some having reference to Geography and History, and some involving an acquaintance with English authors, as well as more abstract subjects, the main object being to test power of expression, thought and arrangement, general reading, and knowledge. (All candidates will be expected to attempt the essay, to which special importance is attached.)
- (b) Questions testing knowledge and command of English. These may include questions on précis writing, paraphrase, and analysis of sentences.
- (c) Questions testing general reading and knowledge of English books.

MATHEMATICS, CLASS I.

Arithmetic:—The ordinary rules, with applications more specially to the mensuration of plane figures and solids. The metric system, and the use of decimals in approximate calculation; contracted methods. The use and theory of recurring decimals are not required, and candidates are at liberty to use algebraic symbols and formulas and tables of logarithms. Geometry.--Plane geometry, theoretical and practical, not excluding simple problems in three dimensions. Pro

portion may be treated arithmetically; the special treatment of incommensurables is not required. *Algebra.*—Including graphs of the simpler agebraic functions; quadratic equations; use of graphs in solving, equations, and in illustrating and solving practical questions; rate of variation of a function and gradient or slope of a graph; graphic interpolation; indices and the simpler properties of surds. *Trigonometry.*—Up to and including solution of plane triangles; graphs of trigonometrical functions.

Grasp of elementary principles and readiness in practical application will be looked for, but no great analytical skill will be demanded. Numerical results should be given to a few significant figures, and rough checks on the accuracy of the results should be applied. Neatness and accuracy of working are expected, and sufficient indication of the method of solution to make the work immediately intelligible. The examination will include laboratory work. Acquaintance is expected with the balance and steel-yard, and with the method of finding volume by weighing in air and in water. An idea of the range of the questions which will be set at the laboratory examination may be obtained from the laboratory questions set under Mathematics, Class I., at recent examinations for junior appointments in the Home Civil Service, and shown in reprints of the examination papers published by Messrs. Wyman & Sons, Fetter Lane, London, E.C.

LATIN.

The paper will include (1) questions on grammar; (2) unprepared passages for translation into English, with questions; (3) one or more easy unprepared passages for translation into English, a vocabulary of unfamiliar words being given; (4) one or more unprepared passages of ordinary difficulty for translation into English; (5) easy sentences for translation into Latin; (6) one or more continuous passages for translation into Latin.

BOOKKEEPING AND ACCOUNTING.

Knowledge of the general principles of Bookkeeping and Accounting. Bookkeeping by double entry.

MATHEMATICS, CLASS II.

Includes Mathematics, Class I., together with Mechanics. The principles of the lever, the inclined plane, the composition of forces and virtual work, their experimental investigation and application to machines and other simple cases of equilibrium. Centre of gravity, couple or torque, velocity ratio, mechanical advantage or force--ratio, work,, officiency

Application to liquids and gases. Density. Boyle's Law. Pump, siphon, barometer, manometer. Velocity, acceleration, momentum, force, impulse of a force, energy, power or rate of work. The examination in Mathematics, Class II., will include laboratory work. An idea of the range of the questions which will be set at the laboratory examina-tion may be obtained from the laboratory questions set under Mathematics, Class II., at recent examinations for junior appointments in the Home Civil Service, and shown in reprints of the examination papers published by Messrs. Wyman & Sons, Fetter Lane, London, E.C.

CHEMISTRY.

The following outline indicates the range of the examination :---

Written.

The methods which lead to the discovery of the composition of common materials occurring in nature.

The determination of molecular weights, equivalents, and of atomic weights. Valency and structural formulæ. Classification of the elements, including the Periodic Scheme.

General characters of the chief types of compounds, including acids, bases, and salts, and a few prominent carbon compounds, especially as illustrating the relations of properties to composition and structure. No distinction will be admitted between Organic and Inorganic Chemistry.

History, production and properties of the more important and typical elements and their most familiar compounds. The character of chemical changes, including combustion, thermal dissociation, and electrolysis; the conditions which determine and influence them, and the attendant phenomena.

The whole to be treated in an elementary manner.

Candidates will be required to show that they have seen and practised a great variety of experiments, and are familiar with the appearance of common laboratory materials.

II.—Practical Examination.

Candidates will be required to show that they are familiar with easy quantitative operations, gravimetric and volumetric, with the rudiments of qualitative analysis, and that they have prepared a number of elements or compounds by processes involving the manipulation of gases and the purification of substances by crystallization, distillation, &c. Candidates must bring to the practical examination the notebooks which contain the record of the experimental work they have performed. Specimens made by the candidate, duly attested by the teacher, if any, may also be submitted to the examiners.

PHYSICS.

The following Syllabus indicates the general scope and character of the examination, without being exhaustive of all parts of the subject. Candidates are expected to show a general acquaintance with the apparatus by which the elementary principles of Physics are illustrated and applied :-

Nature of Wave-motion. Amplitudes. Wave-length. Frequency.

Experimental determination of the Velocity of Sound in Air. Echoes. Effect of change of Temperature on the Velocity.

Determination of Frequency by simple methods.

Experimental investigation of the modes of Vibration of Strings by means of the Sonometer.

Experimental investigation of the Vibrations of Air in Pipes by Resonance to Tuning Forks.

Organ Pipes. Position of Nodes and Antinodes.

Optics.—Propagation of Light. Measurement of Velocity. Laws of Reflection and Refraction. Photometry.

Reflection at Plane and Spherical Surfaces, and the formation of Images.

Refraction at Plane Surfaces and by Prisms. Minimum deviation. Chromatic dispersion. The formation of Images by single Lenses. Long and Short Sight and their correction by Lenses.

GEOGRAPHY AND HISTORY. (Two Papers.)

Geography.-Questions on descriptive and general geography.

History.-The general course of English History and the development of the British Empire, from the accession of Henry VII. to the present time, with a more detailed knowledge of the reign of Queen Victoria.

SINHALESE.

Translation of passages from Sinhalese into English and from English into Sinhalese. Questions on Grammar. A fair knowledge of Sinhalese literature will be expected. An oral examination will also be held locally, in which candidates will be tested as to their ability to interpret from Sinhalese into English and vice versa.

TAMIL.

Translation of passages from Tamil into English and from English into Tamil. Questions on Grammar. A fair knowledge of Tamil literature will be expected. An oral examination will also be held locally, in which candidates will be tested as to their ability to interpret from Tamil into English and vice versa.

ALMERIO FITZROY.

By the KING.

A Proclamation determining New Designs for Silver Coins.

Whereas under section 11 of the Coinage Act, 1870, We have power, with the advice of Our Privy Council, from time to time by Proclamation to determine the design for any coin :

And whereas it appears to Us desirable to determine new designs for the silver coins hereinafter specified, being some of the silver coins mentioned in the First Schedule to the Coinage Act, 1870:

We, therefore, in pursuance of the said enactment and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct, and ordain as follows :---

1. The designs for the said silver coins shall be as follows :-

(1) Half Crown.-Every half-crown shall have for the obverse impression Our effigy with the inscription "GEORGIUS V DEI GRA : BRITT : OMN : REX " and for the reverse the Ensigns Armorial of the United Kingdom contained in a shield surmounted by the Royal Crown and surrounded by the Garter bearing the motto "HONI SOIT QUI MAL Y PENSE," with the inscription "FID : DEF : IND : IMP :" together with the words "HALF OROWN " and the date of the year, with a graining upon the edge.

(2) Florin.—Every florin shall have the same obverse impression as the half-crown, with the inscription "GEORGIUS V D. G. BRITT: OMN: REX F. D. IND: IMP:" and for the reverse four crowned shields arranged in the form of a cross ; in the angles four sceptres springing from the Star of the Garter in the centre, together with the words "ONE FLORIN" and the date of the year, with a graining upon the edge.

(3) Shilling.-Every shilling shall have the same obverse impression and inscription as the half-crown, and for the reverse Our Royal Crest with the date of the year placed across the Crest, with the inscription "FID : DEF : IND : IMP : " together with the words " ONE SHILLING," with a graining upon the edge.

(4) Sixpence.—Every sixpence shall have the same obverse impression and inscription as the half-crown, and for the reverse the same impression and inscription as the shilling, together with the words "SIX PENCE," with a graining upon the edge.

(5) Silver Fourpence, Threepence, Twopence, and Penny.—Every silver fourpence, threepence, twopence; and penny shall have for the obverse impression Our aforesaid effigy, with the inscription "GEORGIUS V D. G. BRITT: OMN: REX F. D. IND: IMP:" and for the reverse the respective figures "4," "3," "2," "1" (according to the denomination or value of the piece) in the centre, with the date of the year placed across the figure, and encircled with an oak wreath surmounted by the Royal Crown, with a plain edge.

2. This Proclamation shall come into force and have effect as from the First day of January, One thousand Nine hundred and Eleven.

GOVERNMENT TRAINING COLLEGE, COLOMBO.

Entrance Examination for 1912 and 1913.

ENGLISH CLASSES (MEN AND WOMEN).

N Entrance Examination for admission to the English classes will be held at the Training College on November 1, 2, (3, 1911, commencing at 10.30 A.M. In order to gain admission to this examination, intending candidates must apply to the Principal of the Training College during the month of September for an admission form. These forms must be returned on or before October 16. Candidates will then be informed whether they have been selected to appear at the examination.

The students of these classes will be trained for teacherships in grant-in-aid and Government schools. The following studentskips are offered for competition :---

- (a) Thirteen studentships of Rs. 300 per annum each, with free tuition and free railway passes for use during vacations.
- (b) Six studentships carrying free tuition with free board and residence when the College is in session, and free railway passes for use during vacations.

Besides the nineteen students who receive the above allowances, twelve additional students will, if eligible candidates present themselves, be appointed, who will receive no allowance, but will be allowed to take up the first-year course free of charge, at the end of which they will receive a third class certificate, if their record during the year and their performance at the first-year examination be satisfactory. Such students will be allowed to complete the course, and if their work shows exceptional progress, will be eligible for appointment to a studentship of Rs. 300 in their second-year course. Four of these twelve will, if eligible candidates present themselves, be students who will take a special course with a view to qualify for the certificate under (c) below.

It must be understood that all students are appointed on probation for the first three months, and will not be allowed to continue their course unless their work shows a reasonable degree of promise.

The Second Class certificate issued to students at the conclusion of their course at the Government Training College will in future be of three grades :-

- (a) A certificate which qualifies a teacher to be in charge of a secondary school.
- (b) A certificate which qualifies a teacher to be in charge of an elementary school.
- (c) A certificate which qualifies a teacher to be in charge of an infant school ; this certificate will be recognized for the purpose of awarding the higher grant under clause 36 of the Code for Aided Schools.

The Entrance Examination will consist of two parts :---

I.—Compulsory subjects :—

- (1) English Language : Grammar and Idiom.
- (2) English Composition.
- (3) Reading aloud an unprepared passage from a work of a standard English author.
- (4) Arithmetic.
- (5) History and Geography, general knowledge of English History, and general Geography of the World.

II.—Optional subjects :--

Mathematics : Algebra to Quadratic Equations.

Geometry : the subject-matter of Euclid's Books I. to III. (experimentally and theoretically).

Languages : A.-Latin : Translation, Grammar, and Composition.

B.-Sinhalese : Ummagga Jataka and Guttila. Grammar. Composition.

C.-Tamil : Panchatantra, Nayadatam (verse), and Ilakkanachchurukkam. Composition.

N.B.—Only one of A, B, or C can be taken.

No further information will be given concerning this syllabus.

SINHALESE CLASS (MEN).

The students in this Department will be trained for masterships in Government Sinhalese schools.

Fifteen studentships will be open for competition to selected monitors in Government schools who pass their thirdyear examination at either of the two examinations immediately preceding the date of the Entrance Examination.

Selected students will receive free board and lodging at the College during the session, text books will be provided, and free passes on the railway will be issued for use during the vacations. The period of training will extend over two years, and at the end of this period those who pass the Final Examination will receive certificates of the second or third class in accordance with the record of their work in the College and their performance at the Final Examination.

Certificates of the first class will be issued only to trained teachers in the service of the Department who hold second class certificates after an uninterrupted service of ten years as head teacher in a school of the class corresponding to the certificate, provided that their conduct and efficiency be approved by the Director. For scale of payments see clause 8 of the Departmental Code.

The following will be the subjects for the Entrance Examination :---

Sinhalese Literature : Ummaga Jataka and Guttila. Grammar.

Composition and Dictation.

Arithmetic. Reading aloud from an unseen passage.

History of Ceylon.

General Geography of the World, Ceylon, and Asia in detail.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended March 11, 1911.

Births.—The total births registered in the city of Colombo in the week were 133 (0 Europeans, 9 Burghers, 86 Sinhalese, 17 Tamils, 17 Moors, 4 Malays, and 0 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on January 1, 1911, viz., 189,423) was 36.6, as against 21.2 in the preceding week, 29.2 in the corresponding week of last year, and 25.6 the weekly average for last year.

Deaths.—The total deaths registered were 108 (1 European, 2 Burghers, 56 Sinhalese, 22 Tamils, 19 Moors, 3 Malays, and 5 Others). The death-rate per 1,000 per annum was 29.7, as against 33.9 in the previous week, 26.1 in the corresponding week of last year, and 31.2 the weekly average for last year.

Infantile Deaths .--- Of the 108 total deaths, 21 were of infants under one year of age, as against 30 in the preceding week, 22 in the corresponding week of the previous year, and 27 the average for last year.

Stillbirths.-The number of stillbirths registered during the week was 9.

Selected Causes of Death.—Nineteen death's were registered from Pneumonia, as in the previous week (against 12 the weekly average for last year), of which 6 were in Maradana (exclusive of hospitals), 3 in San Sebastian, 2 each in Kotahena, New Bazaar, Maradana hospitals, and Slave Island, and 1 each in Pettah and St. Paul's. 5 deaths were registered from Bronchitis.

2. Eleven deaths were registered from *Phthisis* (against 14 in the previous week and 13 the weekly average for 'last year), of which 3 each were in Kotahena and Maradana hospitals, 2 each in New Bazaar and Slave Island, and 1 in Maradana (exclusive of hospitals).

3. Six deaths were registered from Diarrhæa (including 2 infants), 6 Enteritis, 6 Tetanus (3 infants), 5 Infantile Convulsions, 4 Debility (3 infants), 4 Old Age, 3 Remittent Fever, 3 Dropsy, 2 Premature Birth, 2 Apoplexy, 2 Worms, and 21 from Other Causes.

4. Nine deaths were registered from *Enteric Fever* (against 6 in the previous week and 5 the weekly average for last year), 2 each in San Sebastian, New Bazaar, and Maradana hospitals, and 1 each in Kotahena, Maradana (exclusive of hospitals), and Slave Island. There were 18 cases reported during the week, against 22 in the previous week.

5. One case of *Smallpox* was reported, as in the previous week; also one case of *Measles*, against 9 in the previous week; and 53 of *Chickenpox*, against 45 in the previous week.

State of the Weather.—The mean temperature of air was 82.7°, against 81.6° in the preceding week and 79.8° in the corresponding week of the previous year. The mean atmospheric pressure was 29.935 in., against 29.975 in. in the preceding week, and 29.959 in. in the corresponding week of the previous year. The total rainfall in the week was 0.01 in., against 0.02 in. in the preceding week, and nil in the corresponding week of the previous year.
