NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 6th day of March, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in any one or more of such lands or to some interest therein, make claim in person or in writing to the said lands or any of them or to some interest therein to the Special Officer appointed under section 23 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle:

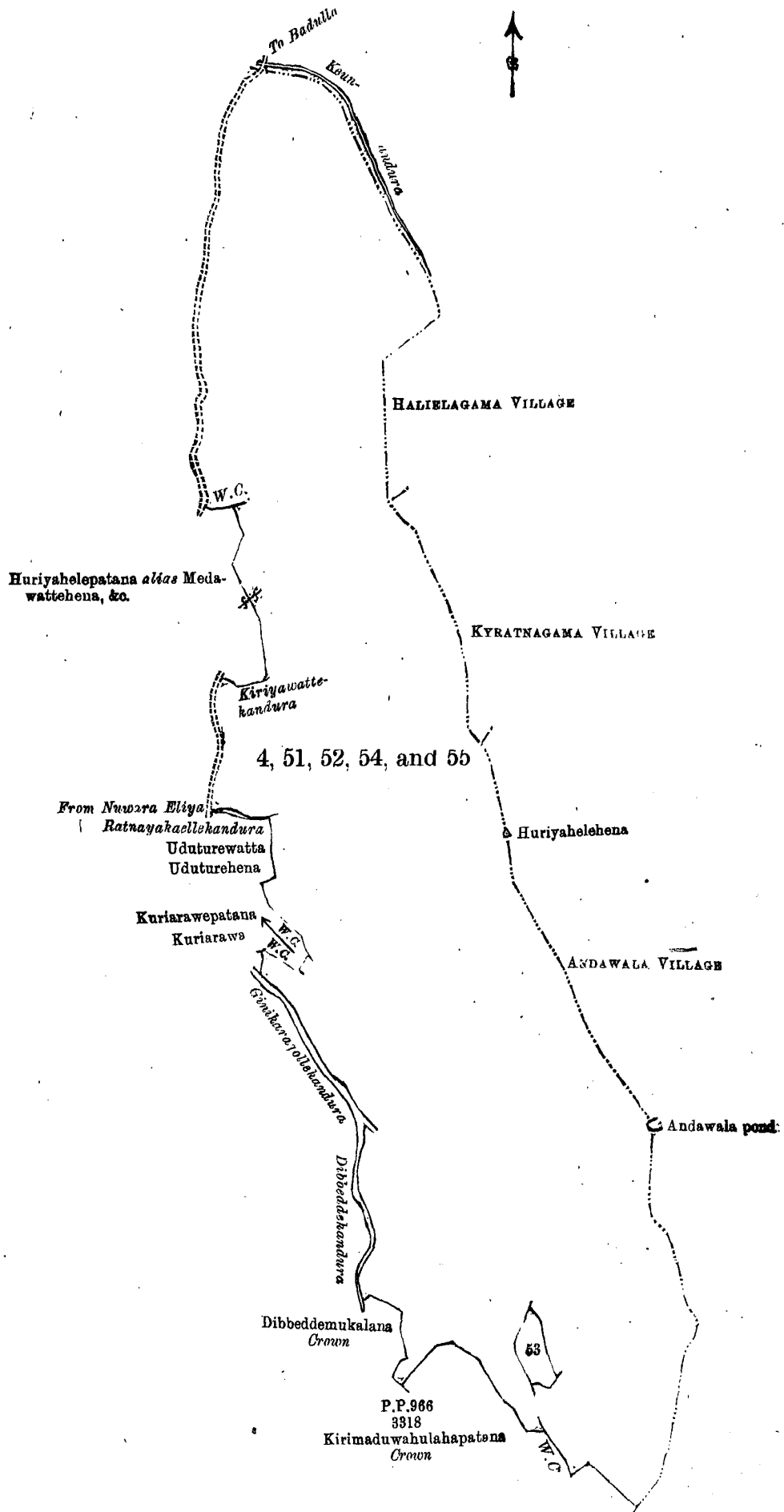

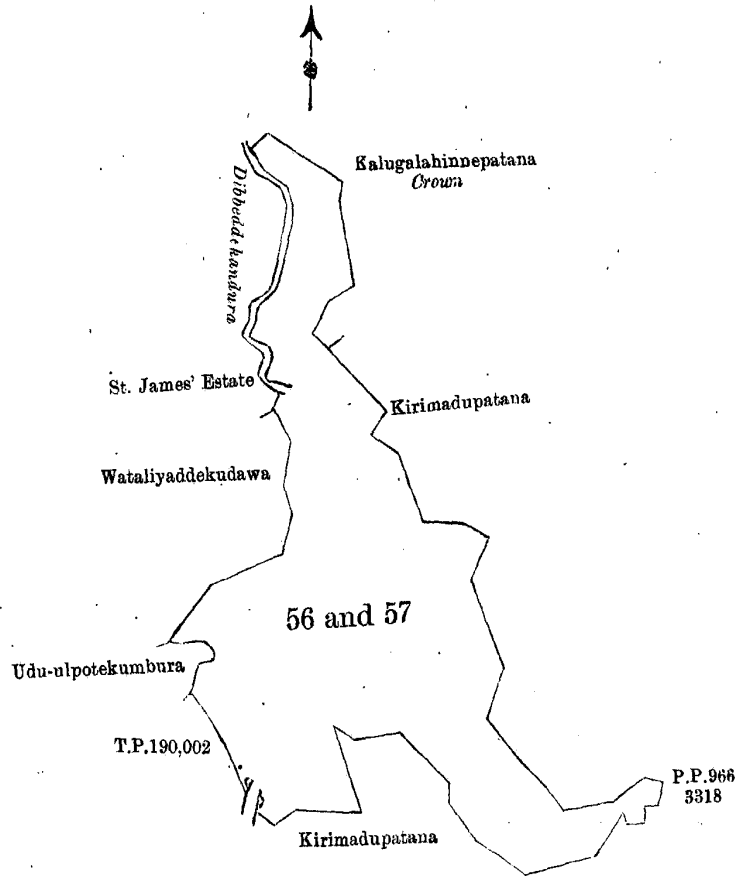
