#### FINAL ORDERS.

Order under Section 2 of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," declaring Lands to be Crown Property.

In the matter of the lands commonly called or known as Sungankutti of Karukkativu and Sinnativukani, situate in the village of Karukkativu, in Akkarai Pattu North of the Kalpitiya division of the Puttalam District, in the North-Western Province, and of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903."

THE notice required by section 1 of "The Waste Lands Ordinances of 1897, 1899, 1900, and 1903," having been duly published in manner prescribed by that section in respect of the above-named lands (vide Notice No. 3,946), and no claim having been made to the said lands or to any interest therein within the period of three months from the date specified in the said notice, I, Edward Bruce Alexander, Assistant Government Agent of the Puttalam and Chilaw Districts of the North-Western Province, under and by virtue of the powers vested in me in that behalf by section 2 of the said Ordinances, do hereby on April 6, 1911, order and declare that the said lands, as more fully described herein below, situate in the village of Karukkativu, in Akkarai Pattu North of the Kalpitiya division of the Puttalam District, in the North-Western Province, and shown as lots 14,671, 14,672, 14,673, and 14,674 in preliminary plan 3,292, and in the annexed diagram, and containing in extent 51 acres 3 roods and 30 perches, are the property of the Crown.

#### Description of the Lands referred to.

The following lots situated at the village Karukkativu, in Akkarai Pattu North of the Kalpitiya division of the Puttalam District, in the North-Western Province, as described in the annexed diagram:-

P. 84,893, claimed by Kuppe Tambi Marikkar, Karakativutottan claimed by Muttu Markar Ahamadu Lebbe and another, and Karakkativutottan claimed by Muttu Marakan Mahammadu Ali and others, Panningpaliamtottam claimed by Lebbe Kunji, and Udatarawa claimed by Mapulle Tambi Marikkar.
