By His Excellency Sir HUGH CLIFFORD, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer Administering the Government of the Island of Ceylon, with the Dependencies thereof.

HUGH CLIFFORD.

NOW Ye that We, the Governor of Ceylon, in exercise of the power vested in Us by section 6(1) of the Cemeteries and Burials Ordinance, No. 9 of 1899, and with the advice of the Executive Council, do hereby, as from and after the date hereof, establish as a general cemetery the parcel of land called Kendagaspitivehena, situated in the town of Dehiowita, in Atulugam korale in the Three Korales, of the District of Kegalla, in the Province of Sabaramuwa, containing in extent 4 acres 1 rood and 17 perches, delineated as lot 340 in preliminary plan 2,049, for the burial or cremation of the dead, within the limits specified in the schedule hereto:

Given at Colombo, in the said Island of Ceylon, this Twenty-second day of July, in the year of our Lord One thousand Nine hundred and Eleven.

NOW Ye that We, the Officer Administering the Government of Ceylon, in exercise of the power in Us vested by section 6 of the Masters Attendant's Ordinance, No. 6 of 1865, and with the advice and consent of the Executive Council, do hereby frame and establish for the port of Colombo the following additional port rule (to be numbered 10 of Section III.) for the purposes of the said Ordinance. And We do hereby promulgate that the said rule shall take effect as from and after September 1, 1911.

#### GOD SAVE THE KING.

#### SECTION III.

10. Commanders of vessels or, in their absence, the officers in charge and contractors or their agents or servants engaged in shipping or discharging cargo or coal or other articles shall not use or suffer or permit to be used any ropes, tackle, or other gear that may be worn, frail, or otherwise unsuitable from any cause whatever for the purpose of heaving or lowering such cargo or coal or other articles. Any police officer not below the rank of sergeant may at any time inspect and examine, such ropes, tackle, or other gear, and prohibit their use if found unsuitable.

THE QUARANTINE AND PREVENTION OF DISEASES ORDINANCE, No. 3 OF 1897.

IT is hereby notified for public information that His Excellency the Officer Administering the Government, in exercise of the powers vested in him by section 4 of the above-named Ordinance, and with the advice of the Executive Council, has been pleased to vary regulation No. 22 of the regulations dated September 17, 1907, and published in the Government Gazette No. 6,207 of September 20, 1907, by the addition thereto of the following regulation (to be numbered 22 A), namely:—

22 A. Every person holding such permit as aforesaid or holding a permit granted by the Chairman, Plague Committee, must inform the Health Officer at the port of landing of his intended place or places of residence, and must during such period as may be ordered by the Health Officer report himself daily to such officer as may be designated.

# VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended July 22, 1911.

Births.—The total births registered were 97 (2 Europeans, 9 Burghers, 59 Sinhalese, 10 Tamils, 12 Moors, 5 Malays, and 0 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1911, viz., 213,825) was 23.6, as against 23.9 in the preceding week, 18.1 in the corresponding week of last year, and 25.6 the weekly average for last year.

Deaths.—The total deaths registered were 153 (3 Europeans, 10 Burghers, 85 Sinhalese, 23 Tamils, 23 Moors, 4 Maiays, and 5 Others). The death-rate per 1,000 per annum was 37.3, as against 43.4 in the previous week, 37.3 in the corresponding week of last year, and 31.2 the weekly average for last year.

Injantile Deaths.—Of the 153 total deaths, 33 were of infants under one year of age, as against 45 in the preceding week, 40 in the corresponding week of the previous year, and 27 the average for last year.

Stillbirths.—The number of stillbirths registered during the week was 10.

Selected Causes of Death.—Seventeen deaths were registered from Pneumonia (against 24 in the previous week and 12 the weekly average for last year), of which 5 were in Maradana hospitals, 4 in St. Paul's, 2 each in Pettah and Kotahena, and 1 each in Fort and Galle Face Ward, Maradana (exclusive of hospitals), Slave Island, and Kollupitiya North. Six deaths were registered from Bronchius.

- 2. Thirteen deaths were registered from *Phthisis* (against 11 in the previous week and 13 the weekly average for last year), of which 3 each were in New Bazaar, Maradana hospitals, Maradana (exclusive of hospitals), 2 in St. Paul's, and 1 each in San Sebastian and Kollupitiya North.
- 3. Twelve deaths were registered from Enteric Fever (against 6 in the previous week and 5 the weekly average for last year), of which 4 were in Maradana (exclusive of hospitals), 3 in Maradana hospitals, 2 each in Kotahena and New Bazaar, and 1 in St. Paul's. There were 30 cases reported during the week, against 23 in the previous week.
- 4. Fourteen deaths were registered from Enteritis (including 2 infants), 11 from Infantile Convulsions, 11 Dysentery (2 infants), 10 Debility (6 infants), 6 Diarrhea (3 infants), 6 Worms, 6 Sentity, 4 Malaria (1 infant), 3 Simple Meningitis (1 infant), and 33 from Other Causes.
- 5. No death was registered from Smallpox during the week; 3 cases were reported, against 4 in the previous week; also 4 of Measles, against 7 in the previous week; and 10 of Chickenpox, against 7 in the previous week.
- 6. One death was registered from Suspected Cholcra, of a Tamil in St. Paul's. There were 2 cases reported during the week.

State of the Weather.—The mean temperature of air was 82.0°, against 80.6° in the preceding week and 81.4° in the corresponding week of the previous year. The mean atmospheric pressure was 29.890 in., against 29.907 in. in the preceding week and 29.859 in. in the corresponding week of the previous year. The total rainfall in the week was 0.24 in., against 2.04 in. in the preceding week and 1.99 in. in the corresponding week of the previous year.
