ABSTRACTS OF SEASON REPORTS.

SEASON REPORTS FOR THE MONTHS OF SEPTEMBER, 1911.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Paddy, (a) maha: the crop is ripening; (b) yala: the crop has just been reaped.

Dry grain: nil.

Other products: the flowering prospects for the month are unsatisfactory. Fruits, such as mangoes, jak, pineapples, &c., are not seasonable.

Prices of staple products: rice (imported), Rs. 5 to Rs. 6.75 per bushel; paddy, Rs. 2 a bushel; coconuts, Rs. 55 per 1,000.

Rainfall: there have been a few showers of rain during the month.

Remarks on harvest prospects generally: owing to the drought some of the plants have been damaged.

Observations on the health of the inhabitants: malarial fever still prevalent.

Health of cattle: there have been spasmodic outbreaks of rinderpest at Karagampitiya, Meetotamulla, Etul Kotte, and were consequently declared as infected villages. Karagampitiya is now free of the disease. The outbreak of rinderpest at Talangama South was of a virulent type. But at present the disease is on the decrease.

KALUTARA DISTRICT.

Paddy: the yala harvest was gathered in during the month. Cultivation for the maha commenced.

Dry grain: no cultivation worth reporting.

Other products: (a) there was a fair supply of vegetables. Dessert fruits, jak, breadfruit, and yams were scarce. (b) The flowering of coconuts was better than during the past few months. (c) The crop of coconuts for the month was estimated at 2,298,890 nuts.

Prices of staple products: rice, Rs. 4.50 to Rs. 7.50 per bushel; coconuts, Rs. 50 to Rs. 80 per thousand.

Remarks on harvest prospects generally: the yala harvest was comparatively poor, and was damaged by the floods in some parts.

Rainfall: total, 5.72 in.; mean, .19 in.

Health of people: good, except for a few cases of dysentery, chickenpox, and fever.

Health of cattle: there were a few cases of rinderpest in Rayigam korale introduced from the Colombo District.

The disease has been now stamped out.

CENTRAL PROVINCE.

KANDY DISTRICT.

MATALE DISTRICT.

Rainfall: 5.65 in.

Paddy, yala crops gathered; maha fields are being cultivated.

Dry grains: chenas are still being cleared.

Coconut: (a) flowering poor; (b) 110,000 nuts approximate crop.

Tanks in Matale North are dry.

Health of people: fever and chickenpox still prevalent.

Health of cattle: good.

Prices: moderate.

NUWARA ELIYA DISTRICT.

Paddy—Yala cultivation: fields have young plants.

Dry grains: chenas are being cleared.

Health of population: fever is prevailing to a great extent in Udu Hewaheta and Walapane.

Health of cattle: good.

Prices of staple articles: paddy, Rs. 2 per bushel; kurakkan, Rs. 2 per bushel; Indian corn, Rs. 2 per bushel; rice (Coast), Rs. 6 to Rs. 7 per bushel; rice (country), Rs. 5 per bushel; coconut, Rs. 8 to 10 per 100 nuts.

NORTHERN PROVINCE.

JAFFNA DISTRICT.

Paddy: sowing in progress in certain divisions of the peninsula; in others finished.

Dry grains: kurakkan and varaku sowing finished in The Islands division.

Coconuts: condition of flowers and nuts ordinary. Price, Rs. 7 per 100.

Palmyras: fruits season; moderate crop.

Tobacco cultivation: nil.

Prices of staple articles: paddy, Rs. 2.25 per bushel; rice, Rs. 5 per bushel; pairu, Rs. 4.50 per bushel; varaku, Re. 1.75 per bushel; salt, 4 cents per lb. and 9 cents per measure.

Health of people: generally good.

Health of cattle: generally good, but owing to lack of rain the cattle suffered from want of grass and water.

MANNAR DISTRICT.

Weather : maximum temperature, 90·1°; minimum temperature, 78·4°; rainfall, 0·12 in. Direction of the wind south-west. The long drought still continues.

Agriculture—Paddy : fields are being manured. Tobacco : nil. Coconuts : condition of flowers and nuts very poor owing to the protracted drought. Palmyras : condition poor. Dry grain : jungle is being cleared in the villages, where chena cultivation has been allowed for this year.

Health of people : normal.

Health of cattle : there is no disease among cattle, but the mortality from starvation and weakness is very great.

GALLE DISTRICT.

There is no standing harvest to report upon. Preparations are being made for maha, 1911.

The cultivation of dry grain is restricted.

Coconut, tea, cinnamon, and vegetables are general products. The prospects of coming crops of coconut are promising. The estimated crop for the month is 6,956,500.

Coast rice, Rs. 5 per bushel ; paddy, Rs. 2 per bushel ; fine grain, Rs. 2 per bushel ; coconuts, Rs. 50 per 1,000.

Rainfall of the month : hardly any.

The yala crop was poor in some parts of the district.

Health of the inhabitants has been satisfactory.

MATARA DISTRICT.

Weather : generally wet.

Agriculture : maha sowing is in progress.

Health of people : satisfactory; there were a few cases of chickenpox and malarial fever.

Health of cattle : satisfactory, but for ten cases of rinderpest at Lalpe in Kandaboda pattu.

Food supply : rice, Rs. 4 to Rs. 6 per bushel ; paddy, Rs. 2 to Rs. 2·25 per bushel ; fine grain, Re. 1·50 to Rs. 2·50 per bushel ; coconuts, Rs. 4 to Rs. 12 per 100.

HAMBANTOTA DISTRICT.

Paddy cultivation : cultivation of fields has not yet begun owing to the scarcity of water.

Fine grain : chenas are being sown with fine grain.

Weather : maximum temperature, 88·0°; minimum temperature, 76·0°; rainfall, 2·15 in.

Health of people : fever prevails in the interior of the district.

Health of cattle : there have been no cases of rinderpest during the month.

Prices : country rice, Rs. 4·68 per bushel ; Coast rice, Rs. 5 per bushel ; paddy, Rs. 2·25 per bushel ; kurakkan, Rs. 2·25 per bushel ; coconuts, Rs. 50 to Rs. 60 per 1,000 ; plantains, Rs. 60 per 100 bunches ; pumpkins, Rs. 15 per 100 ; sweet potatoes, Rs. 2·50 per cwt. About 300,000 coconuts were picked during the month.

EASTERN PROVINCE.

BATTICALOA DISTRICT.

Paddy : ploughing and sowing for munmari cultivation progressing.

Other grain and products : dry grain in plants. Some chenas still being cleared and burnt. Prospects of coconut trees : good owing to recent showers of rain.

Public health : fever and sore-eyes prevail.

Cattle disease : nil.

Paddy, Rs. 2·20 per bushel.

Rainfall : 1910, 2·71 in.; 1911, 5·76 in.

PUTTALAM AND CHILAW DISTRICTS.

Paddy : owing to scarcity of rain yala crop was a failure. Preparations are being made for maha cultivation.

Dry grain : chenas are being cleared for maha cultivation.

Other products, including coconuts : flowering and prospects of coconuts are very bad owing to severe drought. Many trees are reported to have withered and died. The crop in the two districts is estimated at 8,648,070 nuts. Galas and gardens are being prepared for tobacco and vegetable cultivation.

Prices of staple products : rice, Rs. 3 to Rs. 6 per bushel ; paddy, Re. 1·75 to Rs. 2·50 per bushel ; dry grain, Re. 1 to Rs. 2·50 per bushel.

Rainfall of the month : Puttalam District, nil. Chilaw District : nil. Chilaw town, 18 in.

Harvest prospects generally : very bad in both the districts owing to prolonged drought.

Health of inhabitants : Puttalam District, good. Parangi is to be found as usual in Demala hatpattu and Rajakumarawanni pattu. Chilaw District : good on the whole. There were a few cases of fever, dysentery, and sore-eyes in some villages.

Health of cattle : there were two suspected cases of rinderpest in Pitigal Korale South. Drastic measures were taken to stamp out the disease.

ANURADHAPURA DISTRICT.

PROVINCE OF UVA.

BADULLA DISTRICT.

Weather : windy and hot, with occasional showers.

Paddy : fields have been sown for yala cultivation.

Chenas : chenas have been cleared.

Fruit and vegetables : a moderate supply is available.

Other products : the flowering and prospects of the coconut are fair.

Health of the people : satisfactory. Fever, sore-eyes, and chickenpox occurred during the month.

Health of cattle : generally good.

Price of staple products : rice, varies from Rs. 6 to Rs. 8.75 per bushel ; kurakkan, Re. 1.25 to Rs. 2 per bushel ; coconuts, from Rs. 5 to Rs. 10 per 100 nuts.

Rainfall : 3.24 in. as registered at the observatory.

PROVINCE OF SABARAGAMUWA.

RATNAPURA DISTRICT.

Paddy : the maha fields in Kuruwiti korale are in plants. Those in Nawadun korale and Atakalan korale are being sown. Some tracts of fields in the low-lying parts of Kuruwiti korale have been damaged by the recent flood. The yala crops in Nawadun, Atakalan, and Kolonna korales have been harvested.

Dry grain : the yala chenas in Kuruwiti korale are in blossom ; in Kukulukorale the plants are five months old ; and in Nawadun korale the crop has been reaped. Kurakkan crops in Meda, Kadawat, and Atakalan korales are being reaped.

Other products—coconut : crop poor.

Health of people : fever, which prevailed in some parts of the district, is gradually decreasing.

Health of cattle : satisfactory, except in Kuruwiti korale, where rinderpest is prevailing in three wasamas.

Rainfall : there was plenty of rain throughout the district, especially in Kuruwiti, Nawadun, and Kukulukorales.

Prices of food products : rice (imported), Rs. 5 to Rs. 6.50 per bushel ; rice (country), Rs. 4 to Rs. 5.50 per bushel ; el-wi, Rs. 2 to Rs. 3 per bushel ; kurakkan, Re. 1.50 to Rs. 2.50 per bushel ; amu, 75 cents to Re. 1.75 per bushel ; meneri, Re. 1.50 to Re. 1.75 per bushel ; salt, 10 cents to 14 cents per pound ; salt fish, 31 cents to 80 cents per pound ; coconuts, Rs. 5 to Rs. 15 per 100 ; Indian corn, Re. 1.12½ to Re. 1.25 per 100.

KEGALLA DISTRICT.

Paddy : maha prospects are not good. The plants in some of the fields cultivated for maha are being transplanted ; yala harvest is not satisfactory.

Dry grain : hill paddy and amu prospects are good ; kurakkan chenas are being harvested.

OFFERS, marked on the envelopes "Purchase of Timber," will be received by the Assistant Conservator of Forests, Batticaloa Division, Batticaloa, up to Monday, October 30, 1911, for the purchase of all unmarked and unnumbered trees, poles, warichies, &c., standing within the 209-acre block in the Kanthalai Forest Reserve, to the north of and between the 7th and 8th mileposts, Kandy road, Trincomalee District, which will be pointed out by the Subdivisional Forest Officer, Trincomalee, for a period of seven months. Purchasers proposing to make an offer are requested to inspect the block preparatory to making the offer.

2. Any intending purchaser must make an offer for all the unmarked and unnumbered trees, poles, &c., standing within the 209-acre block.

3. Offers must be made on forms obtained from the Office of the Assistant Conservator of Forests, Batticaloa, on a deposit of Rs. 20 being made in the Trincomalee or Batticaloa Kacheheri, and no offer will be considered unless it is on the recognized form. Alterations must be initialled, otherwise the offers may be treated as informal and rejected.

4. Should the person tendering decline or fail to pay, the required deposit and sign the agreement within 10 days of receiving notice in writing from the Head of the Department, or his duly authorized representative, that his offer has been accepted, the deposit mentioned in clause 3 shall be forfeited to the Crown.

5. The highest offer is subject to the approval of the Conservator of Forests, and half of the purchase amount should be deposited on acceptance of an offer, and the balance should be paid within three months from date of first payment.

6. The purchaser will be permitted to dispose of all the timber and firewood within or out of the Island.

7. If the purchaser agrees to open a depôt and stack timber and firewood sufficient to meet the requirements of the public and sell them at rates approved of by the Conservator of Forests, no license for felling and removal of small timber and firewood for sale will be issued by the Forest Department up to June 30, 1912.

8. If the timber and firewood within the 209-acre block is not sufficient to meet the requirements of the public during the period in question, the Forest Department will issue licenses to the purchaser to fell timber from Crown land on payment of usual royalty.

9. None of the numbered or marked trees should be felled on any account by the purchaser or his workmen. The felling and removal of numbered or marked trees standing within the 209-acre block will constitute an offence punishable under the Forest Ordinance or Penal Code, and a termination of the monopoly and forfeiture of all sums paid.

10. The purchaser will be held responsible for the action of his workmen.

11.
