GOVERNMENT NOTIFICATIONS.

Ceylon Government Agricultural Scholarships.

ITH a view to securing trained teachers for Provincial Agricultural Schools which it is proposed to establish in Ceylon, it has been decided, with the approval of the Secretary of State for the Colonies, to grant Government Scholarships to promising young men desirous of embarking on an agricultural career in the Government service to enable them to receive a training in an Agricultural College in India.

2. As a first step it is proposed to grant four such scholarships tenable for a period of three years for a course of training at the Agricultural College at Poona. The scholarships will entitle the holders to the following allowances during the three years of their course of training:—A subsistence allowance of Rs. 50 per mensem, and an outfit and travelling all wance at the rate of Rs. 300 per annum paid half-yearly. The candidates will be provided with quarters, but they will have to provide their own boarding. Fees for tuition, cost of instruments, &c., and rent of quarters will be paid by Government.

The scholarships will be granted by nomination by the Governor in Executive Council to selected candidates who were over 19 and less than 24 years of age on January 1, 1912. Candidates for nomination must, however, have passed one of the following examinations:-

(a) The Intermediate Examination in Arts or Science of the University of Lordon.

(b) The F.A. or the B.A. Examination of the Calcutta University, provided this has been passed with a classical language and history.

(c) The F.A. or B.A. Examination of the Madras University, provided this has been passed with a classical language.

Candidates will also be required to pass a test in physical fitness before nomination.

The course of study is that laid down by the University of Bombay for the degree of Bachelor of Agriculture. The candidates will have to take the F. Ag., S. Ag., and B. Ag. Examinations in succession.

5. Applications for His Excellency the Governor's nomination must be submitted to the Hon. the Colonial Secretary not later than March 1, 1912. Each candidate must send in with his application two certificates of character, one of which must be from the Principal of the last school which le attended; also proof of age.

Candidates nominated will be required to pay a medical fee of Rs. 10:50.

The next scholastic year of the Agricultural College at Poona will commence on June 1, 1912, and the students/nominated for the scholarship will be admitted to the College on that date.

GENERAL BY-LAWS.

(a) All and any part of any house, dwelling, church, place of assembly, or other building shall be provided with sufficient light and ventilation, and shall, whenever so ordered by the Government Agent or any officer acting under his authority, be forthwith internally or externally limewashed, disinfected, or otherwise cleansed.

(b) Privies shall be constructed where, in the opinion of the Government Agent,

it is desirable that they should exist.

(c) Cosspits or offensive drains shall, whenever so ordered by the headman, be filled up by the owners of the land on which they are situated and others be opened.

(d) Compounds shall be cleansed and rubbish in them shall be buried or burnt, and brushwood and weeds growing within 50 yards of houses shall be cut down and

(e) Fences on private premises shall be kept down to a maximum height of six feet, and all overhanging branches and foliage shall be removed, and every owner or occupier of such premises so ordered by a headman shall forthwith comply with such directions.

(1) Hollow places in compounds or close to dwelling-houses shall be filled up or drained so that water may not stagnate in them, and all unnecessary vessels or receptacles of any description lying about the said premises, and which are liable to hold or contain water likely to become stagnant, shall be removed.

BY-LAWS REFERRED TO.

- 1. Every person now carrying on the sale of water to residents within the limits of the Local Board of Batticaloa, or who intends to carry on such sale hereafter, shall apply to the Chairman of the Local Board for a permit setting out his full name and address and the number of the cart used or to be used by him for conveying the water for sale.
- 2. On receipt of such application, the Secretary of the Local Board shall register the name and address of the applicant and the number of the cart, and the Chairman, Local Board, shall issue a permit to him (without any fees) subject to the conditions hereinafter mentioned.
- 3. Every such licensed seller of water shall bring his cart and barrel filled with water once a week at the time and place mentioned in his permit for the purpose of having the barrel cleaned and disinfected in the presence of the Inspector, Local Board.
- 4. After the expiration of two weeks from the time these by-laws come into force, any person selling water to residents within Local Board limits without a permit as provided in by-law 2, and any licensed water seller not complying with by-law 3, shall be guilty of an offence, and liable on conviction to pay a fine not exceeding Rs. 20.
- 5. The Chairman may cancel the permit granted to any water seller on his being convicted under the preceding section.

Order in Council applying the Extradition Acts to Siam, November 10, 1911.

At the Court at Buckingham Palace, the 10th day of November, 1911.

Present:

The King's Most Excellent Majesty.

Prime Minister. Lord President. Lord Privy Seal. Lord Chamberlain.

Whereas by the Extradition Acts, 1870 to 1906, it was amongst other things enacted that, where an arrangement has been made with any foreign State with respect to the surrender to such State of any fugitive criminals. His Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State; and that His Majesty may, by the same or any subsequent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, exceptions, and qualifications as may be deemed expedient:

And whereas a Treaty was concluded at Bangkok on the 4th day of March, 1911, between His Majesty and His Majesty the King of Siam, for the Extradition of Criminals, which Treaty is in the terms following:—

Who, having communicated to each other their respective full powers, found in good and due form, have are upon and concluded the following articles:—

ARTICLE 1.

The High Contracting Parties engage to deliver up to each other persons over whom they respectively jurisdiction who, being accused or convicted of a crime or offence committed in the territory of the one Party found within the territory of the other Party, under the circumstances and conditions stated in the present

Coloured Tea Ruling.

THE Treasury Department has issued the following announcement in regard to the importation of tea:-

"Excessive colouring matter in teas shipped from abroad prior to May 1, 1911, may be removed under Customs supervision at the expanse of the importers, whether such teas have or have not been rejected on account of the presence of such colouring matter.

"However, teas from which such excessive colouring matter has been removed will not be admitted unless they comply with the law and regulations in all respects, and, therefore, samples of such reprocessed teas will be submitted to the tea examiner for

determination of their quality, colouring matter, &c.

"Teas shipped from abroad after May 1, 1911, will not be allowed entry if they contain any artificial colouring matter at all."

To Collectors of Customs and others concerned:

It has come to the attention of the Department that certain of the samples deposited in the Custom-houses of the country in accordance with the provisions of section 3 of the Act of March 2, 1897, known as the Tea Act, which purport to represent the standards established by Department Circular No. 17 of March 1, 1911, do not accurately represent those standards thus established in so far as they contain a slight amount of artificial colouring or facing matter. The Department has obtained the opinion of the Solicitor of the Treasury upon the question whether or not the variation of certain of the samples from the standards established by the circular is a legal bar to the enforcement of the proper standards as publicly announced. To this inquiry the Solicitor has replied that the standards announced in the Circular of March 1, 1911, control, irrespective of the fact that ε few of the samples purporting to represent those standards contain artificial colouring or facing matter. Consequently no teas shipped from abroad after May 1, 1911, which contain any artificial colouring or facing matter will be permitted entry into this country. Officers of Customs will be governed accordingly

From the SOLICITOR to the SECRETARY OF THE TREASURY.

Department of Justice, Office of the Solicitor of the Treasury, Washington, September 12, 1911.

Sir,-Your telegram received by your Private Secretary this morning, which has been delivered to me, recites as follows:-

"Get immediately opinion of Solicitor whether or not the tea standards must be observed if these prove to be coloured notwithstanding the clear intent to have them uncoloured, and the adequate notice and publicity given the real intention by the Department

Section 2 of an Act entitled "An Act to prevent the Importation of Impure and I nwholesome Tea," approved March 2, 1897, directs the Secretary of the Treasury to appoint a board to consist of seven members, experts in teas, whose duty it shall be to prepare

and submit to the Secretary of the Treasury standard samples of tea.

Section 3 of the same Act provides that the Secretary, upon the recommendation of said board, shall fix and establish uniform standards of purity, quality, and fitness for consumption of all kinds of teas imported into the United States, and shall procure and deposit in the Custom-houses of the ports of New York, Chicago, San Francisco, and such other ports as he may determine, duplicate samples of such standards; and shall procure a sufficient number of other duplicate samples of such standards to supply the importers and dealers in tea at all other ports desiring the same at cost; and that all teas, or merchandise described as tea, of inferior purity, quality, and fitness for consumption to such standards shall be prohibited from entry.

From the language of your telegram it might appear that samples of teas recommended as standards by the tea board possessed artificial colouring either known or unknown to such board. But whether artificial colouring in the samples of tea were known or unknown to the board is immaterial to the present inquiry. If samples of teas recommended by the tea board to you as standards were known by the tea board to contain artificial colouring, it is quite clear from Department Circular No. 17 of 1911 that any standards recommended by the board which may have included artificial colouring did not receive your approval, for the reason that the decision or circular in relation thereto, among other things, recites as follows

"The standards recommended by the board of tea experts and fixed and established by me in regulation 19 of the appended regulations as the legal standards for the year 1911 are in every instance teas entirely free from artificial colouring or facing matter.

Thus, I take it that the standards actually established for the year 1911 in pursuance of the Act above referred to were the standards recommended by the board, modified, so far as the artificial colouring is concerned, by the Act of the Department of March 1, 1911.

I am of the opinion that the recommendations of the tea board were advisory in character, and that the Secretary of the Treasury had the right to modify and adopt the same so modified as he might consider consistent and in accordance with the intent and meaning of the Act of Congress above referred to, and that the standards recommended by the tea board, so modified and adopted as indicated by the language of the circular above quoted, constitute the standards to be observed relative to the importation of teas for the year 1911, and that any samples of such standards as may have been furnished importers or others interested would necessarily have to be considered in connection with the order made by the Secretary of the Treasury in establishing standards. Such order of approval and adoption of standards in pursuance of the Act of Congress imparted notice to the world in the same manner and to the same extent as the statute on that subject imparted public notice, that it was the clear intention of the Department, indicated by the order of adoption, that no artificially coloured teas should be imported into the United States after May 1, 1911. This intent is further evidenced by T. D. 31,367, made in pursuance of the Act of March 2, 1897. This decision of the Department bears date of March 10, 1911, and provides, inter alia, as follows:-

"Teas shipped from abroad after May 1, 1911, will not be allowed entry if they contain any artificial colouring matter at all." From the foregoing it may be reasonably concluded-

First, that the standards of teas subject to importation fixed by the Department were such as had been recommended by the

tea board, but containing no artificial colouring;

Second, that the samples furnished, whether possessing artificial colouring or not, were to be taken and considered in connection with the regulations promulgated adopting the standards, which specifically provided that no artificially coloured tea could be lawfully imported into the United States;

imported into the United States;

Third, that importers cannot be heard to urge the existence of samples containing colouring matter misrepresenting standards actually adopted as authority for importing artificially coloured teas; and

Fourth, that samples must yield to standards and not standards to samples, or false representatives of standards, especially when the public rules and regulations of the Department, of which importers will be presumed to have knowledge, clearly indicate what the legal standards are.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended December 23, 1911.

The total births registered were 101 (I European, 10 Burghers, 54 Sinhalese, 19 Tamils, 12 Moors, 3 Malays, and 2 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1,1911, viz., 213,825) was 24.6, as against 29.0 in the preceding week, 21.8 in the corresponding week of last year, and 25.6 the weekly average for last year.

Deaths.—The total deaths registered were 180 (0 Europeans, 9 Burghers, 93 Sinhalese, 45 Tamils, 23 Moors, 4 Malays, and 6 Others). The death-rate per 1,000 per annum was 43.9, as against 42.9 in the previous week, 31.8 in the corresponding week of last year, and 31.2 the weekly average for last year.

Infantile Deaths.—Of the 180 total deaths, 49 were of infants under one year of age, as against 53 in the preceding

27 in the corresponding week of the previous year, and the average for last year. Stillbirths.—The number of stillbirths registered during the week was 6.

Selected Causes of Death .- Twenty-three deaths were registered from Pneumonia (against 20 in the previous week and 12 the weekly average for last year), of which 7 were in St. Paul's, 6 in Maradana hospitals, 3 each in Pettah, Kotahena, Maradana (exclusive of hospitals), and I in New Bazaar. Eight deaths were registered from Bronchitis.

2. Fourteen deaths were registered from Phthisis (against 12 in the previous week and 13 the weekly average for

last year), of which 3 each were in St. Paul's and Kotahena, 2 each in New Bazaar, Maradana hospitals, and

Maradana (exclusive of hospitals), and I each in Pettah and Slave Island.

3. Five deaths were registered from Enteric Fever (against 10 in the previous week and 5 the weekly average for last year), of which 2 were in Maradana (exclusive of hospitals), and 1 each in Pettah, San Sebastian, and Maradana hospitals. There were 22 cases reported during the week, against 16 in the previous week.

4. Fourteen deaths were registered from Enteritis (including 3 infants), 14 Infantile Convulsions, 11 Sentity, 8 Tetanus (7 infants), 7 Debility (5 infants), 7 Dysentery. 6 Premature Birth, 5 Diarrhea (3 infants), 5 each from Simple Meningitis, Want of Breast Milk, and Worms, 3 each from Anchylostomiasis and Cirrhosis of the Liver, 3 from Judicial Execution, and 34 from Other Causes.

5. Four cases of Measles were reported, as in the previous week; and 5 of Chickenpox, against 10 in the

previous week.

State of the Weather.—The mean temperature of air was 80.2° against 80.0°, in the preceding week and 78.3° in the corresponding week of the previous year. The mean atmospheric pressure was 29.871 in., against 29.829 in. in the preceding week and 30 000 in. in the corresponding week of the previous year. The total rainfall in the week was 1.87 in., against 0.98 in. in the preceding week and nil in the corresponding week of the previous year.
