INVESTIGATION CONDUCTED UNDER SECTION 2 OF THE CHAPTER N_0 . 04 OF 1991 RELATING TO POWERS OF SUPERVISION OF ADMINISTRATION OF THE LOCAL GOVERNMENT INSTIUTIONS

BY virtue of the powers vested in me by the Section 2 of the Charter No. 04 of 1991 relating to powers of supervision of administration of the Local Government Institutions I, Isura Devapriya, the Chief Minister of Western Provincial Councils and the Minister of Finance and Planning, Engineering Services, Law and Order, Local Government and Provincial Administration, Economic Promotion, Power and Energy, Environment Affairs, Water Supply and Drainage and Tourism Affairs, do hereby appoint Mr. Kumara Hewage Sumithrapala, Retired Judge of the High Court, as an Investigation Committee of one member, to investigate and submit a report within three months as to whether the offences specified under Section 2(1) of the above Charter have been committed by W. Samanlal Fernando whilst holding office as the Mayor of Moratuwa Municipal Council.

Matters/Charges which are to be investigated.

- 1. You have committed, whilst holding office as the Mayor of the Municipal Council Moratuwa, the offences mentioned in Section/s 2(i)(a) and/or 2(i)(c) of the Charter No. 04 of 1991 by way of granting approval to fell and remove the teak wood trees in the cemetery of Rawatawatta under the administration of Municipal Council Moratuwa during the period from 14.11.2015 to 07.12.2015 or a close period, without obtaining proper approval from the Municipal Council.
- 2. You have committed, whilst holding office as the Mayor of the Municipal Council Moratuwa, the offences mentioned in Section/s 2(i)(a) and/or 2(i)(c) of the Charter No. 04 of 1991 by way of taking action to enter into an agreement with W. E. Security Services Pvt. Ltd., at No. 26/1/1, Church Road, Rathnapura to maintain security services within the premises of the Municipal Council Moratuwa without obtaining proper approval from the Municipal Council and/or getting approval of the Council for the agreement.
- 3. You have committed, whilst holding office as the Mayor of the Municipal Council Moratuwa, the offences mentioned in Section/s 2(i)(a) and/or 2(i)(c) of the Charter No. 04 of 1991 by not implementing the Court Order issued to remove the unathorized construction at No. 163A, Station Road, Moratuwa and/or making an environment not to implement the said order during the period from 10.07.2009 to 30.08.2010 or a close period.



Further, in terms of the provisions mentioned in Section 2(2) of the Charter No. 04 of 1991 relating to powers of supervision of administration of the Local Government Institutions, the powers vested in the Commissioner appointed by the Investigations Commission Act are vested in this one member investigation committee. It is further informed that the written and oral evidence identified to be made applicable in the investigation on the above matter have been included in the following Schedule.
