PROCLAMATION.

By His Excellency Sir EDWARD NOEL WALKER, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by section 8 of "The Road Ordinance, 1861," it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, by Proclamation to declare that any road, canal, or river shall be deemed to be a principal thoroughfare for the purposes of the said Ordinance, and such road, canal, or river shall, from the time specified in such Proclamation, be deemed to be a principal thoroughfare accordingly:

And whereas it is expedient to declare the road from the Resthouse to the Bar at Patticaloa, Eastern Province, a principal thoroughfare for the purposes of the said Ordinance:

Now therefore know Ye that We, the said Lieutenant-Governor, with the advice of the Executive Council, do hereby declare that the road from the Resthouse to the Bar at Batticaloa aforesaid shall, for the purposes of the said Ordinance, be deemed to be a principal thoroughfare as from and after the First day of January, One thousand Eight hundred and Ninety-four.

Given at Kandy, in the said Island of Ceylon, this Twenty-fifth day of July, in the year of our Lord One thousand Eight hundred and Ninety-three.

PROCLAMATION.

By His Excellency Sir EDWARD NOEL WALKER, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Lieutenant-Governor in and over the Island of Ceylon, with the Dependencies thereof.

WHEREAS by section 3 of Ordinance No. 11 of 1891 it is enacted that it shall be lawful for the Governor, with the advice of the Executive Council, from time to time, by Proclamation in the *Government Gazette*, to impose a duty, and the same from time to time to increase or reduce, not exceeding twelve rupees per hundredweight on all hides and fourteen rupees per hundredweight on all horns, respectively, of spotted deer and sambur when exported from this Colony—anything in the Ordinances Nos. 17 of 1869 and 14 of 1871 to the contrary notwithstanding :

And whereas by a Proclamation dated the 16th day of January, 1892, the Governor, with the advice of the Executive Council, imposed a certain duty on all such hides and horns exported from this Colony, and by a subsequent Proclamation dated the 19th day of January, 1893, increased such duty thereon :

And whereas it is expedient to further increase such duty :

Now know Ye that We, the said Governor, with the advice of the Executive Council, do hereby increase the duty imposed by the Proclamation of the 19th day of January, 1893, aforesaid, on all hides and horns, respectively, of spotted deer and sambur when exported from this Colony to twelve rupees per hundredweight on all such hides and fourteen rupees per hundredweight on all such horns, as from and after the 1st day of August, 1893, and declare that the duty on all such hides and horns respectively, when exported from this Colony, shall from and after that date be twelve rupees per hundredweight on all such hides and fourteen rupees per hundredweight on all such horns.

Given at Kandy, in the said Island of Ceylon, this Twenty-eighth day of July, in the year of our Lord One thousand Eight hundred and Ninety-three.

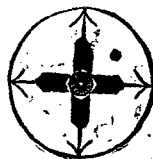

NOTICES UNDER THE FOREST ORDINANCE.

WHEREAS by the sixth section of Ordinance No. 10 of 1885 it is enacted that whenever it is proposed to constitute any land a reserved forest, notice thereof shall be published in the *Government Gazette*—

- (a) specifying, as nearly as possible, the situation and limits of such land ;
- (b) declaring that it is proposed to constitute such land a reserved forest ;
- (c) naming an officer (hereinafter called "The Forest Settlement Officer"), who shall be appointed by the Governor to inquire into and determine the existence, nature, and extent of any rights claimed by, or alleged to exist in favour of, any person in or over any land comprised within such limits; and any claims relating to the practice within such limits of chena cultivation, and to deal with the same as provided in chapter II. of the said Ordinance :

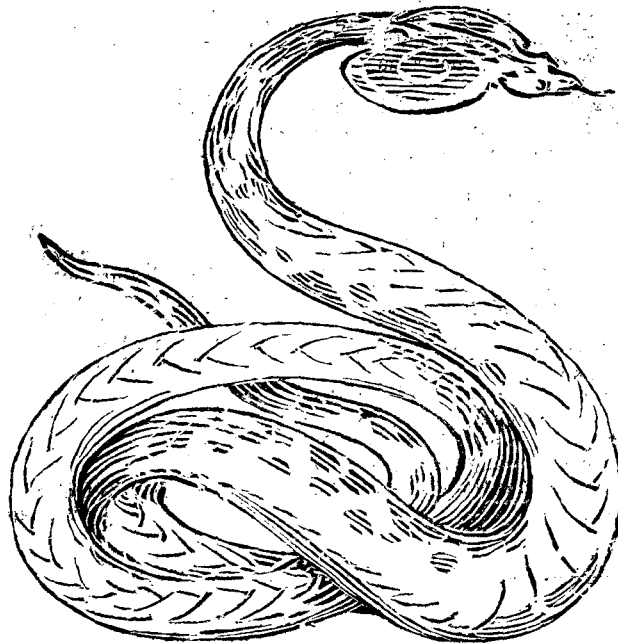

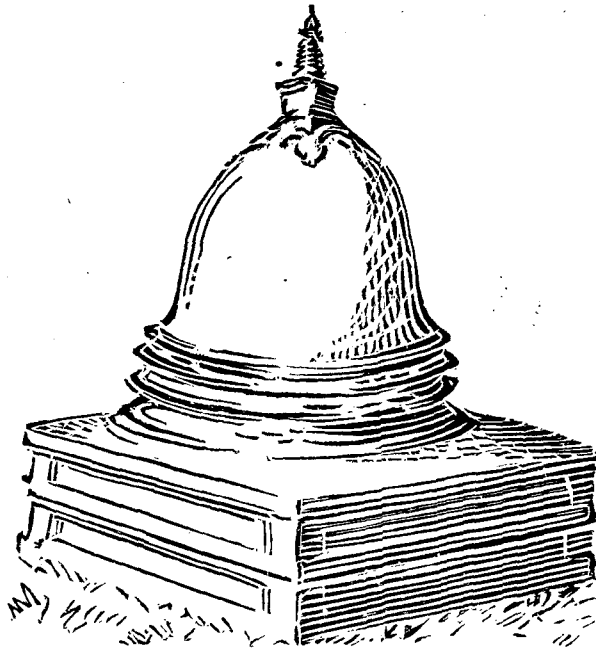
