THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, John Anthoni Emmanuvel Amarathunga, Minister of Lands, hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of land in total extent of about 0.5239 Hectare depicted in Advance Tracing No. Maha/HRS/2013/1641 dated 20th November 2013, prepared by the Surveyor General situated in the Village of Medawela in the Minor Division of Kulugammana Siya Paththuwa in the Divisional Secretary's Division of Harispaththuwa in Kandy District, Central Province and bounded as follows :
