**SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007**

**Order under Section 2**

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ravi Karunanayake, Minister of Finance the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of list of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy, at the rates specified in the corresponding entries in Column II of that Schedule. This Order shall be valid for a period of 06 months commencing from 13th May 2016, subject to provisions of Sub section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in *Gazette Extraordinary* No. 1957/5 of 08.03.2016 in respect of Vegetable Oils (H.S Heading Nos. 15.07, 15.11, 15.12, 15.13) and Margarine (H.S Code Nos. 1517.10.30, 1517.10.90) are rescinded with effect from 13th May 2016.
