By His Excellency Sir HENRY EDWARD MCCALLUM, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George; Governor and Commander-in-Chief in and over the Island of Ceylon, with the Dependencies thereof.

NOW Ye that We, the Governor of Ceylon, in exercise of the power vested in him by section 4 of the Cattle Ordinance, No. 10 of 1898, and with the advice of the Executive Council, have made the following regulation for the prevention of cattle stealing, and declare that the same shall be in force throughout the whole Island with effect as from and after the date hereof.

Given at Colombo, in the said Island of Ceylon, this Thirty-first day of December, in the year of Our Lord One thousand Nine hundred and Twelve.

Regulation referred to.

On or before January 15 in each year cattle owners shall furnish lists of all their cattle, showing the sex, age, colour, and brand marks of each animal, and distinguishing buffaloes from neat or black cattle, to the Udaiyar or Korala or Arachehi of the division in which the cattle are kept.

Ceylon Government Engineering Scholarships.

N examination will be held by the Ceylon Government in April, 1913, for the award of scholarships to be held in the Upper Subordinate Class in Engineering at the Madras Engineering College. If candidates of sufficient merit present themselves there will be awarded three scholarships, which will under certain conditions lead to appointments in the Ceylon Irrigation Department. The scholarships will entitle the holders to the following allowances for the three years of their course in the Upper Subordinate Class :- A subsistence allowance of Rs. 30 per mensem, and an outfit and travelling allowance at the rate of Rs. 200 per annum, paid half-yearly. Fees and deposits required for the classes will be paid by the

Government. Those who pass the College final examination at the end of the three years' course will recei same subsistence allowance for an additional year, during which they will be employed on works in India. will also during this additional year receive the same travelling allowances as are drawn by Indian students un the same circumstances. All allowances will be contingent on the good conduct and satisfactory progress of the student.

The three scholars will, if they receive a certificate of good conduct and satisfactory progress during the 2. year spent on works, be offered appointments as Irrigation Inspectors, Class II., of the Irrigation Department, with prospects of promotion to the higher grades of Irrigation Inspectors, Class I., and Chief Irrigation Inspectors. The following is the sanctioned scale of salaries and strength for these appointments :---

Twelve Inspectors, Class II., at Rs. 960 rising to Rs. 1,360 by annual increments of Rs. 40. Ten Inspectors, Class I., at Rs. 1,400 rising to Rs. 2,300 by annual increments of Rs. 60. Eight Chief Inspectors at Rs. 2,500 rising to Rs. 3,000 by annual increments of Rs. 100.

Promotion from class to class is by selection. Each of these scholars will be required to execute a bond of Rs. 1,000, pledging himself to enter Government service in the Irrigation Department, and remain in that service for at least ten years. 3. The examination will be confined to candidates whose age will be under 22 on June 30, 1913, and who are nominated by His Excellency the Governor. Before receiving such nomination, candidates must have passed one of the following examinations :---

(i.) The Matriculation Examination of the London University.

- (ii.) The Cambridge University Senior Local Examination, including a pass in not less than five of the sections 2–16. Three of these sections must be-
 - (1) English.
 - (2) Mathematics.
 - (3) Latin, or Chemistry, or Physics, or two subjects in Biology and Physical Geography.
- (iii.) The Intermediate Examination in Arts of the Madras University.
- The subjects of examination will be as follows :----**4**.

(1) Arithmetic.

Compulsory.

(2) Drawing—Freehand and Geometrical.

(3) English Language and Composition.

(4) Pure Mathematics—Geometry, Algebra, and Trigonometry.

Optional. Not more than two of the following :---

- (5) Applied Mathematics—Elementary Mechanics and Hydrostatics.
- Chemistry—Theoretical and Practical. (6)
- (7) Physics—the elements of Sound, Light, Heat, Electricity, and Magnetism. Candidates will be examined practically in the use of the commoner physical apparatus.

NOTE.—The standard of the examination in subjects (4), (5), (6), and (7) is sufficiently indicated in the syllabus for the respective subjects prescribed for the Senior Cambridge Local and the London Matriculation Examinations.

N.B.—In selecting the scholars a preference will be given to those who have passed in either Physics or Chemistry.

5. Applications for His Excellency the Governor's nomination must be submitted to the Director of Irrigation not later than February 15, 1913. Each candidate must send in with his application two certificates of character. one of which must be from the Principal of the last school which he attended.

6. Candidates nominated by His Excellency the Governor will be required to pay a medical fee of Rs. 10.50and an examination fee of Rs. 25.

7. Any further particulars and forms of application for nomination may be obtained from the Director of Irrigation.

SIR,-WITH reference to my circular despatch of April 25, 1911, I have the honour to inform you that the rate of postage on letters from the New Hebrides to the United Kingdom and to all parts of the British Empire has been reduced to one penny per ounce from the 10th proximo, and that the postal authorities of the New Hebrides will accept without surcharge letters prepaid at the penny rate which are received from other British postal administrations.

VITAL STATISTICS.

Registrar-General's Weekly Health Report of the City of Colombo for the Week ended December 21, 1912.

Births.—The total births registered in the city of Colombo in the week were 87 (1 European, 8 Burghers, 50 Sinhalese, 13 Tamils, 11 Moors, 3 Malays, and 1 Other). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1912, viz., 226,969) was 20.0, as against 22.6 in the preceding week, 24.9 in the corresponding week of last year, and 26.0 the weekly average for last year.

Deaths.—The total deaths registered were 138 (2 Europeans, 8 Burghers, 62 Sinhalese, 34 Tamils, 28 Moors, 1 Malay, and 3 Others). The death-rate per 1,000 per annum was 31.8, as against 30.6 in the previous week, 44.4 in the corresponding week of last year, and $35 \cdot 2$ the weekly average of last year.

Infantile Deaths.—Of the 138 total deaths, 31 were of infants under one year of age, as against 33 in the preceding week, 49 in the corresponding week of the previous year, and 32 the average of last year.

Stillbirths.—The number of stillbirths registered during the week was 9.

Selected Causes of Death.-Fourteen deaths were registered from Phthisis (against 9 in the previous week and 14 the weekly average for last year), of which 5 were in Maradana (exclusive of hospitals), 2 each in New Bazaar and Wellawatta, and 1 each in Pettah, St. Paul's, Kotahena, Maradana hospitals, and Slave Island.

2. Twelve deaths were registered from Pneumonia (against 18 in the previous week and the weekly average for last year), of which 3 were in St. Paul's, 2 each in San Sebastian. Kotahena, and New Bazaar, and I each in Maradana (exclusive of hospitals), Slave Island, and Kollupitiya. Nine deaths were registered from Bronchitis.

3. Five deaths were registered from Enteric Fever (as in the previous week, against 8 the weekly average for last year), of which 2 were in St. Paul's, and 1 each in Kotahena, Maradana (exclusive of hospitals), and Slave Island. There were 6 cases reported during the week, against 11 in the previous week.

4. Fifteen deaths were registered from Infantile Convulsions, 14 from Senility, 9 from Enteritis (3 infants), 5 from Debility (4 infants), 3 each from Dysentery, Worms, Rickets, Heart Disease, and Premature Birth, and 40 from Other Causes.

5. Ten cases of Measles were reported, against 12 in the previous week; and 5 of Chickenpox, against 7 in the previous week.

State of the Weather.—The mean temperature of air was 78.1°, against 79.0° in the preceding week and 80.2° in the corresponding week of the previous year. The mean atmospheric pressure was 29:820 in., against 29.888 in. in the preceding week and 29.871 in, in the corresponding week of the previous year. The total rainfall in the week was 2.85 in., against nil in the preceding week and 1.87 in. in the corresponding week of the previous year.

Births.-The total births registered in the city of Colombo in the week were 78 (1 European, 6 Burghers, 41 Sinhalese, 16 Tamils, 10 Moors, 2 Malays, and 2 Others). The birth-rate per 1,000 per annum (calculated on the estimated population on July 1, 1912, viz., 226,969) was 18.0, as against 20.0 in the preceding week, 17.0 in the corresponding week of last year, and $26 \cdot 0$ the weekly average for last year.

Deaths.--The total deaths registered were 133 (0 Europeans, 5 Burghers, 61 Sinhalese, 39 Tamils, 16 Moors, 7 Malays, and 5 Others). The death-rate per 1,000 per annum was 30.6, as against 31.8 in the previous week, 39.2 in the corresponding week of last year, and $35 \cdot 2$ the weekly average of last year.

Infantile Deaths.—Of the 133 total deaths, 35 were of infants under one year of age, as against 31 in the preceding week, 45 in the corresponding week of the previous year, and 32 the average of last year.

Stillbirths.--The number of stillbirths registered during the week was 7.

Selected Causes of Death.-Fourteen deaths were registered from Phthisis (as in the previous week and the weekly average for last year), of which 5 were in Kotahena, 3 in Pettah, 2 in Maradana hospitals, and 1 each in San Sebastian, New Bazaar, Maradana (exclusive of hospitals), and Slave Island.

Thirteen deaths were registered from *Pneumonia* (against 12 in the previous week and 18 the weekly average · 2. for last year), of which 3 each were in St. Paul's, Kotahena, and Maradana (exclusive of hospitals), 2 in Wellawatta, and 1 each in Pettah and Maradana hospitals. Four deaths were registered from Bronchitis.

3. Only one death was registered from *Enteric Fever* in San Sebastian (against 5 in the provious week and 8 the weekly average for last year). There were 11 cases reported during the week, against 6 in the previous week.

4. Twelve deaths were registered from Enteritis (3 infants), 10 from Infantile Convulsions, 8 each from Dysentery (1 infant), and Debility (6 infants), 6 from Senility, 4 each from Tetanus (2 infants), Premature Birth and Other External Violence, 3 each from Syphilis (2 infants), Puerperal Septicæmia, and Marasmus (all infants), 2 from Worms, 1 from Diarrhoea, and 33 from Other Causes.

5. Four cases of *Measles* were reported, against 10 in the previous week; and 1 of *Chickenpox*, against 5 in the previous week.

State of the Weather.—The mean temperature of air was 78.6°, against 78.1° in the preceding week and 80.5° in the corresponding week of the previous year. The mean atmospheric pressure was 29.868 in., against 29.820 in. in the preceding week and 29.858 in. in the corresponding week of the previous year.
