NOTICE UNDER THE WASTE LANDS ORDINANCES, 1897, 1899, AND 1900.

TAKE notice, that unless within three months from the 13th day of March, 1903, the persons, if any, who claim any interest in the lands hereinafter mentioned, or in any one or more of such lands, appear before the Special Officer appointed under section 28 of "The Waste Lands Ordinances, 1897, 1899, and 1900," at his office at Galle and make claim to the said lands or any of them or to some interest therein:


