COLOMBO DISTRICT.

Paddy, maha : the crop has now been reaped and threshed. Yala : the fields are now being ploughed and sown. Dry grain : in Siyane Korale East and West and Hewagam korale the lands are being prepared for the cultivation of kurakkan and amu.

Other products : jak fruit and breadfruit are abundant, and their prices are moderate. Sweet potatoes, cassava, and yams are scarce.

Prices of staple products : the price of coconuts varies from Rs. 60 to Rs. 80 per thousand. Imported rice is sold from Rs. 4 · 50 to Rs. 6 · 50 per bushel.

Rainfall : the rainfall was sufficient.

Remarks on harvest prospects : a good harvest is expected.

Health of the inhabitants : generally good. There were a few cases of chickenpox, measles, and enteric.

Health of cattle : there had been a few cases of rinderpest in Alutkuru Korale North and Hewagam korale, and cases of hoof-and-mouth disease in most of the korales.
