ABSTRACTS OF SEASON REPORTS.

SEASON REPORT FOR THE MONTH OF APRIL, 1913.

EASTERN PROVINCE.

TRINCOMALEE DISTRICT.

Rainfall: defective.

Paddy: sowing going on in Andankulam, Tamblegam, and Kantalai. Threshing has commenced in Chempianaru and Kaddukkulam East.

Tobacco: in some places curing is going on, and some cultivators are exporting tobacco to Batticaloa, where it fetches a good price; but the crop is not good on account of rain.

Coconuts: condition of crop good.

Fishery: good.

Health of people: satisfactory.

Health of cattle: rinderpest in town and Uppuveli is subsiding, but in Sampaltivu it still prevails.

Prices of staple articles: paddy, Re. 1.75 to Rs. 2.33 per bushel; rice (country), Rs. 3.75 to Rs. 5.32 per bushel; rice (imported), Rs. 5.88 per bushel.

SALES OF ARRACK, TOLL, AND OTHER RENTS.

NOTICE is hereby given that the Government Agent for the Eastern Province will receive tenders at the Batticaloa Kachcheri up to 12 noon on Monday, June 9, 1913, for the purchase of the Kallady Ferry Rent, together with the branch toll at Navatkudah, in the District of Batticaloa, for fifteen months from July 1, 1913, to September 30, 1914.

2. The Government Agent shall have power in his discretion to refuse to accept any tender, subject to which power the highest tenderer will become the purchaser, and shall conform to and perform all the conditions hereunder appearing.
