## MINUTE.

The following Draft of a proposed Ordinance is published for general information:—

# An Ordinance to amend "The Local Boards Ordinance, 1898."

Preamble

HEREAS it is expedient to amend "The Local Boards Ordinance, 1898": Be it therefore enacted by the Governor of Ceylon, by and with the advice and consent of the Legislative Council thereof, as follows:

Short title.

1 This Ordinance may be cited as "The Local Boards (Amendment) Ordinance, No. of 1913."

Addition of proviso to section 47.

2 At the end of section 47 of the principal Ordinance there shall be added the following proviso:

Provided further that in prescribing conditions for the repayment of the said loan the Governor in Executive Council may dispense with the requirements provided for in section 50.

Addition of proviso to section 50.

3 At the end of section 50 of the principal Ordinance there shall be added the following proviso:

Provided, however, that the provisions of this section shall not apply where an order has been made by the Governor in Executive Council under the last provise to section 47 dispensing with the requirements provided for in this section.

## Statement of Objects and Reasons.

The object of the amendment is to enable the Governor in imposing conditions for the repayment of loans made by Government to Local Boards to provide for the total extinction of the debt on payment by the Board of fixed instalments for a definite number of years. As in such cases the sinking fund required by section 50 of Ordinance No. 13 of 1898 will not be necessary, it is proposed to add a proviso to section 47 to the effect that the requirements of section 50 may in such cases be dispensed with, and a proviso with the like effect to section 50 of the Ordinance.
