I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act as amended by the land acquisition (amendment) Act, No.28 of 1964 that the Government intends to acquire the following land/ Servitude which for a public purpose.

Description of the land or Servitude to be acquired:-
