*My No.:* WGSWD&EIP/ACQ/KB/21.

I, hereby give notice, under Sub-section (1) of section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire the abandon paddy field described below and located between Horana - Colombo bus route and Ranketha Place at Paropakara Mawatha, Boralessgamuwa to create a water reserve, water tank, water ways and townscape development under Weras Ganga Storm Water Drainage and Environment Improvement Project.
