SEASON REPORTS FOR THE MONTH OF JULY, 1913.

WESTERN PROVINCE.

COLOMBO DISTRICT.

Paddy: the paddy plants of the yala season are thriving well. Fields are being cultivated for the maha season.
 Dry grain: in Siyane Korales West and East and Hewagam kurakkan plants are blossoming.
 Other products: fruits, such as pineapples, jak, and breadfruit, can be had at a moderate price. Vegetables, mangoes, and oranges are scarce.
 Prices of staple products: the price of coconuts varies from Rs. 65 to Rs. 75 per 1,000. Imported rice is sold from Rs. 4 to Rs. 6.50 per bushel.
 Remarks on harvest prospects: a good harvest is expected.
 Rainfall: there was rain during the earlier part of the month.
 Health of the people: generally good.
 Health of cattle: only two cases of rinderpest in Alutkuru Korale North. Hoof-and-mouth disease prevailed in Alutkuru Korale South and Alutkuru Korale North.

Fishery: medium. Large quantities are sold for preparing salt fish to be exported to outstations.

Health of people: health impaired owing to excessive heat.

Health of cattle: rinderpest exists in Kuchecheveli. Hoof-and-mouth disease prevails in Tanglepattu.

Prices of staple articles: paddy, Re. 1.75 to Rs. 2.62 per bushel; rice (country), Rs. 3.75 to Rs. 5.60 per bushel; rice (imported), Rs. 5.60 per bushel.

NORTH-WESTERN PROVINCE.

KURUNEGALA DISTRICT.

Paddy: yala crops young. Maha being cultivated.

Prospects: not good for want of rain.

Fine grain: some crops are being gathered, some flowering, and some getting ripe.

Prospects: not good for want of rain.

Prospects of coconut flowering: good.

Rainfall: very little rain.

Health of people: good.

Health of cattle: cattle rinderpest and hoof-and-mouth disease are prevailing.

Tanks: some dry, and in some there is small quantity of water.

PUTTALAM AND CHILAW DISTRICTS.

Paddy: yala cultivation is growing fairly well. Fields are being prepared for maha cultivation.

Weather: dry.

Rainfall: the registered rainfall at Anuradhapura during the month was 2.34 in.

Cultivation: paddy crop is being reaped in the Kelagam palata, Hurulu palata, and the Tamankaduwa district. In Nuwaragam palata the fields are in young plants.

Kurakkan: there was no kurakkan cultivation during the month.

Fruits and vegetables: fruit is scarce and dear. A moderate supply of vegetables is available.

Health of the people: satisfactory, except for a few cases of fever and sore-eyes.

Health of cattle: a few cases of rinderpest broke out at Wedigune village in Rilpola korale.
