Conditions of Sale of Lease.

1. The lease to extend for a term of 60 years renewable at the option of the lessee for a further term of 30 years.
2. The lessee will be bound to complete a residential building within two years from date of lease, under penalty of forfeiture of the lease and all moneys paid on account of it.
3. The lessee will be bound to submit plans of all buildings proposed to be erected for the approval of the Board of Improvement. It shall be competent for the Board of Improvement to reject such plans wholly, or to direct such modification as may seem to the Board desirable.
