4. If deeds are tendered as security, the one-twelfth cash security will be retained till the rent is closed.

The person whose tender is selected will also be required to deposit money to pay the fees of the Crown Counsel for examining and giving his opinion on title deeds of properties tendered by him as security, and the fees charged by the Crown Proctor for examining documents and drawing the security bond, and also the expenses of appraising the properties, and of registering the security bond.

5. All title deeds tendered as security should be accompanied by a certificate obtained from the Registrar of Lands that the lands to which they relate are unencumbered. This certificate must be obtained at the cost of the party offering the security.
